The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Andrew Kane of Oakland.

The journal of yesterday was read and approved.

Mrs. BAKER: Mr. Speaker, I move we accept the Majority "Ought not to pass" Report.

Mr. DESHAIES: Mr. Speaker, I would like to have this tabled one legislative day.

Thereupon, Mrs. Baker of Orrington requested a vote.

The SPEAKER: The pending question is on the motion of the gentleman from Westbrook, Mr. Deshaies, that this Bill be tabled pending the motion of Mrs. Baker of Orrington to accept the Majority "Ought not to pass" Report in non-concurrence and specially assigned for Monday, January 21. All in favor of that motion will vote yes; those opposed will vote no.

A vote of the House was taken.

45 having voted in the affirmative and 28 having voted in the negative, the motion did prevail.

Was reported by the Committee on Bills in the Second Reading and read the second time.

Mr. Immonen of West Paris offered House Amendment "A" and moved its adoption.

House Amendment "A" (H-641) was read by the Clerk.

The SPEAKER: The Chair recognizes the gentleman from West Paris, Mr. Immonen.

Mr. IMMONEN: Mr. Speaker, Ladies and Gentlemen of the House: The county commissioners from Oxford County intended to have this as an emergency measure. Somehow or other in drafting the bill in Legislative Research, that was overlooked. There are federal funds available sometime in March, and I would move for the adoption of this amendment.

Thereupon, House Amendment "A" was adopted.

The Bill was passed to be engrossed as amended in non-concurrence and sent up for concurrence

Passed to Be Enacted Emergency Measure

An Act to Appropriate Moneys for Legislative Expenditures (S. P. 730) (L. D. 2142)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 113 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

An Act Making Appropriations for the Supplemental Security Income Program (S.P. 823) (L. D. 2335)

Was reported by the Committee on Engrosssed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 113 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

On motion of Mr. Birt of East Millinocket, was ordered sent forthwith to the Senate.

Emergency Measure

An Act to Authorize Satellite Centers for Vocational Education (H. P. 1757) (L. D. 2216) (C. "A" H-627)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House being necessary, a total was taken. 119 voted in favor of same and none against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Talbot.

Mr. TALBOT: Mr. Speaker, Ladies and Gentlemen of the House: I would like to thank you first of all, and I guess you do deserve an explanation of some sort for tabling this item. I have no problems with the bill — well I do have problems with the bill, I certainly don't have any problems with the gentleman from Stonington, Representative Greenlaw.

I did submit a joint resolution of my own last week to the Joint Committee on Bills, and it didn't go through, it didn't pass. I was kind of upset because that resolution, I think, was important to me. When I saw this resolution on the table, which I am quite sure is important to Mr. Greenlaw, I thought I would just try and keep everything honest and above board.

I decided to go around to the different people the different members of the Reference of Bills Committee to find out their reactions as to why they killed the resolution of mine, and I did just that. I got an honest, good and sincere reason why each and every member killed the resolution I had. I have no problems with that at all. The only two people that I didn't question was the gentleman from Standish, Mr. Simpson, who was busy in the hall with the Stop ERA people, and the gentleman from the Senate, the President, Mr. MacLeod. I went to his office and he was busy and he said, "Well, I will see you in a minute, we are going to kill that ERA bill this morningtomorrow." I immediately rushed right out to buy him a pair of white sneakers. So I told everybody else and they gave me their reactions.

It disturbs me because the resolution I had submitted was something that had to do with an individual I think, that the entire country was taking part in, and the governor of the State of Maine was taking part in, and I felt that we should have taken part in and we didn't; but that is all right, I have no qualms with

But this joint resolution commending the Maine Congressional Delegation, I think, is something of less importance, at least to me, to the gentleman from Stonington, I think, it's quite important. Just as an explanation, I just want to try and keep everybody honest. Now I move its passage, Mr. Speaker.
Thereupon, the Joint Resolution was

adopted and sent up for concurrence.
