SENATE

Wednesday, January 10, 1973 Senate called to order by the President.

Prayer by the Rev. David Dunn of Augusta.

Reading of the Journal of yesterday.

Papers from the House Joint Order

ORDERED, the Senate concurring, that a Joint Special Committee on Public Lands. consisting of ten members, three of whom shall be Members of the Senate appointed by the President of the Senate and seven of whom shall be Members of the House appointed by the Speaker of the House, is hereby created and appointed for the purpose of reviewing legislation introduced in the 106th Legislature in connection with public lands including public The Committee is not only lots. authorized to review all legislation introduced in connection with the public lots but is directed to study and report on the present legal status of the public lots; the legal rights of the citizens of Maine in the public lots; and the alternative uses to which the public lots may be put to in the public interest and to report to the Legislature its views and recommendations in regard to what action, if any, the Legislature should take in regard to the use of public lands including public lots and to draft legislation to implement its recommendations.

The Committee shall act as expeditiously as possible and shall report to the 106th Legislature either in regular or special session in such manner as the Committee deems appropriate.

The Committee shall proceed in its work with the assistance of the Attorney General's Department, the Director of Legislative Research, the Legislative Finance Officer and any other state department, board, commission, authority or agency from which information may be required to carry out and expedite the Committee's duties. Furthermore, said Committee may employ such assistants, clerks, attorneys, agents and advisors as it shall deem necessary and set the conditions of their employment with the approval of the President of the Senate and the Speaker of the House. If it is necessary for the Committee to meet when the Legislature is not in session, the Committee members shall be reimbursed for their actual expenses in service to the Committee, with the exception of mileage which shall be paid at the same rate received by state employees. The Committee is authorized to conduct public hearings at such times, places and in such manner as it deems appropriate to fulfill its duties.

There is allocated to the Committee from the Legislative Account the sum of \$10,000 to carry out the purposes of this Order. (H. P. 84)

Comes from the House Read and Passed.

Which was Read.

The PRESIDENT: Is it now the pleasure of the Senate that this Joint Order receive passage in concurrence.

The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ: Mr. President, I notice the absence from the chamber of the sponsor. It is a radical departure from legislative procedures, and I would suggest that someone consider tabling this until the sponsor is present.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Thereupon, on motion by Mr. Berry of Cumberland, tabled until later in today's session, pending Passage.

To Members of the 106th Legislature

We are pleased to submit for your consideration the report of the Committee on Legislative Ethics with respect to their study of the bill: An Act Relating to Disclosure of Economic Interests by Legislators, House Paper 1572, Legislative Document 2029.

The Committee has devoted a good deal of time and study to the document which relates to disclosure of economic interests by legislators and is of the opinion that present statutes sufficiently accomplish the purpose of the legislation. The Committee does, however, approve of the concept of meaningful disclosure provisions. (Signed)

Report of the Legislative Ethics Committee

The Committee on Legislative Ethics was directed by the 105th Legislature of the State of Maine by House Order dated February 29. 1972, a copy whereof is attached hereto, to study the provisions of the bill: An Act Relating to Disclosure of Economic Interests by Legislators, House Paper 1572, Legislative Document 2029. The purpose of the study was to develop, if possible, more meaningful legislation for presentation to the regular session of the 106th Legislature.

The Committee has carefully considered and studied the provisions of Legislative Document 2029. The primary thrust of the legislation was to provide for disclosure of economic interests of legislators although some consideration was given to disclosure of interests of some members of the Judicial and Executive Departments. Basically, the legislation, somewhat vague in details of operation, required each candidate for the Legislature to file a statement of economic interests. The legislation did not require a

disclosure of the legislator's spouse's interests and did not provide for any updating of the information from time to time.

It should also be noted that the 105th Legislature enacted Chapter 602 of the Public Laws of 1971, which is entitled An Act Relating to Legislative Ethics. This is a comprehensive provision which broadens considerably the authority of the Legislative Ethics Committee, defines conflict of interests of legislators and also specifically provides that a legislator has a conflict of interest in the situation where the adoption of proposed legislation will result a direct significant financial in – gain to him or his spouse or his employer or to a person, corporation or association in which he or his spouse owns stock or other securities. The legislation prohibits a legislator from voting in such a situation and also provides that a legislator has a conflict where his vote is influenced by a promise of payment of money or promise of employment to him or a member of his family. In short, the legislation is most comprehensive and all encompassing as respects conflicts of interests of legislators.

The real purpose of L. D. 2029 was to reach and eliminate those situations where there might be possible conflicts of interests by legislators. The Committee feels, however, that the recently enacted provisions which broaden the authority of the Legislative Ethics Committee accomplish the pur-poses of L. D. 2029. Not only is conflict of interest defined in the ethics legislation but the Ethics Committee has the power to subpoena witnesses, conduct investigations, secure books and records and may seek judicial help in the enforcement of its orders. In short, it has very broad powers to inquire into and examine possible conflicts of interests by legislators.

It therefore appears to the Committee that there are ample statutory provisions on the books at this time with respect to conflicts of interests of legislators and that, although the C o m m it t e e approves of the concept of meaningful disclosure provisions, the purpose of L. D. 2029 is, in fact, accomplished by existing statutes.

Therefore, the Committee recommends at this time that further legislation in this area is not necessary and respectfully recommends to the members of the 106th Legislature that they carefully observe the workings of the Act Relating to Legislative Ethics in order that its practical effect may be observed before any further steps are taken in this area.

Mr. BERRY: Mr. President and Members of the Senate: The departure of Austin Wilkins from state service is certainly a sad event for the people of the State of Maine, and as I sat listening to our Secretary reading the resolve, it shows how inadequate words can be in an attempt to express appreciation for such a long record of service.

Austin Wilkins, of course, has Forest Commissioner heen for longer than any of us in this room have been around in the state. He is an individual who has conducted the affairs of his department, which we all know is of a rather sensitive and delicate nature because he has to walk a path between some people who own our lands and on the other side some people who use our lands, and never in the course of the administration of his department has there been the slightest rumors of scandal, mismanagement, or anything other than the running of the department in a most efficient way.

I have come to regard Austin as a personal friend, from my standpoint, and I am sure I share these feelings with other members of the legislature who through the years have worked with him. He is an example of a capable, dedicated and devoted public servant, and the type of person that the State of Maine is extremely lucky to have running its affairs.
