The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY: Mr. President and Members of the Senate: Through the years there has been developed a rather patchwork method of treatment of the officers and employees of the Legislature insofar as the pension and retirement state system goes.

Starting out with the former Clerk of the House, Harvey Pease, a few isolated individuals were given pension benefits, and through the years there has been no order or planned progress in developing the extension of these benefits to all employees of the Legislature. This Order does this. It makes no particularly special treatment for the employees in the Legislature. It treats them just as all other state employees are treated. It also puts them on an equal footing as far as the retirement system goes with the Legislators, but once again we have no particular benefits that accrue to us that don't

This is certainly a major step forward in treating our associates in the Legislature with the decency that they should have. They will be making contributions to the fund just like any other member of the system does. I think, again this is a major step forward and I urge your support for this order.

Thereupon, Mr. Sewall of Penobscot requested a roll call.

The PRESIDENT: The Chair Senator from recognizes the Kennebec, Senator Katz.

Mr. KATZ: Mr. President and Members of the Senate: I for one am not even vaguely ready for the question, if I am going on the record on a roll call vote. I really don't understand just what programs are involved here, what the nature of the funding has been, and specifically where the money is going. If I confess my ignorance it is a sincere confession and I would like to know specifically what we are voting on.
The PRESIDENT: The Chair

recognizes the Senator from Penobscot, Senator Sewall.

Mr. SEWALL: Mr. President and Members of the Senate: This bill was presented to us as a result of the cutoff of federal funds under the so-called Title 4-A. These funds had been going into quasi-welfare programs, many programs which have been proliferating all over the country, and I believe that the federal government felt that they would better be handled on a local level.

We were presented a bill with a price tag of \$1 million to continue funding these programs until June 30th of this fiscal year. majority of the members of the Committee on Appropriations felt that this might be a little long, and we believed that we did not have sufficient information hand to pass on the merits of the 40 to 50 programs involved. We felt that if we could assign this project to a knowledgeable staff person that these could be researched and we could come back by the middle of March with some hard information and recommendations for the members of the Maine Legislature.

Many of these programs adoubtedly would better be undoubtedly would better be financed by local agencies. On the other hand, it is very hard to say definitively which ones should be funded by the state and which should be funded locally. Therefore, we are requesting funding in the amount of \$350,000, which will carry these programs on until March 15, at which time, or before that time actually, we are in hopes of coming out with another bill which would place all these programs on a reasonably permanent basis. Many may be cut off from state funding but, on the other hand, we do want to know which ones should be funded by the state and which should be funded by local money. Therefore, in effect, this bill really asks for a little time in which to make knowledgeable decisions in this area.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brennan,

Mr. BRENNAN: Mr. President and Members of the Senate: I rise in support of the remarks made by Senator Sewall. This is an emergency bill designed to meet emergency needs. I think we all would agree that a social service emergency is just as important to the fate of thousands of Maine people as an emergency created by a natural or manmade disaster. The emergency calls for a broad scope of action over a short period of time, and when the emergency is past more detailed scrutiny can be given to the social services needs in the long run, but for now I think the responsibility is ours. I think Senator Sewall pointed out that this is something to fund for a two and a half month period, and that an aide has been hired by the legislative staff to look at these programs in detail. The need is there now.

Just briefly to point out who might benefit from this program, think the elderly who are receiving meals on wheels, I think those who are receiving homemaker services, and thus keeping some people out of institutions; I think they are going to benefit and, in the long run I think the state benefits. But I think this is a situation to give a breathing spell to look for other sources of funding. I think Senator Sewall has pointed it out very well, and I hope you will vote to accept the Majority

Ought to Pass Report.

The Chair The PRESIDENT: recognizes the Senator from

Kennebec, Senator Katz.

Mr. KATZ: Mr. President, I am grateful for the explanations which have been presented. I now notice on my desk a rather comprehensive list of programs, which I guess were passed out yesterday. Might I ask through the Chair whether this represents the basis for the continuation of these programs that we are talking about under this appropriation?

I notice the Chair answers in the affirmative, and I thank you very much.

The PRESIDENT: Is the Senate ready for the question? The pending question before the Senate is that the Senate accept the Majority Ought to Pass Report of the Committee.

The Chair recognizes the Senator from Penobscot, Senator Sewall.

Mr. Sewall of Penobscot then withdrew his request for a roll call.

The PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Greeley.

Mr. GREELEY: Mr. President, I would like to move that this bill be tabled for one legislative day.

The PRESIDENT: The Senator from Waldo, Senator Greeley, moves that Legislative Document 79 be tabled and specially assigned for tomorrow.

The Chair recognizes the Senator from Penobscot, Senator Sewall.

On motion by Mr. Sewall of Penobscot, a division was had. Nine Senators having voted in the affirmative, and 21 Senators having voted in the negative, the motion did not prevail.

The PRESIDENT: Is it now the pleasure of the Senate to accept the Majority Ought to Pass Report of the Committee? A division has been requested. As many Senators as are in favor of accepting the Majority Ought to Pass Report of the Committee will please rise and remain standing until counted.

A division was had. 28 Senators having voted in the affirmative, and two Senators having voted in the negative, the Majority Ought to Pass Report of the Committee was Accepted and the Bill Read Once.

Thereupon, under suspension of the rules, the Bill was given its Second Reading and Passed to be Engrossed. Sent down for concurrence.
