The several clerks of committees to which are referred bills, resolves or orders involving the appropriation or expenditure of money shall forthwith upon receipt of such bills, transmit a copy thereof carrying endorsement of reference, to the Committee on Appropriations and Financial Affairs for its information. No bill shall be in order for advertising for hearing or any other procedure until such copy is so transmitted. The Appropriations Committee shall issue a printed report and tabulation of such bills weekly.

Every bill, resolve or order involving the appropriation or expenditure of money shall be presented to the Committee on Appropriations and Financial Affairs for examination and recording before it is engrossed, and no further action shall be had on such bills, resolves or orders until proper endorsement thereon is made by said Committee.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Sewall.

Mr. SEWALL: Mr. President and Members of the Senate: This order which you have before you, which has been distributed, would clear up in Rule 16 of the Joint Rules a rather ambiguous passage which calls for a reference of all bills to the Appropriations Committee. In reading it carefully, none of us can really understand what is meant by the language in the original Rule 16, and this order hopefully would clear up the situation.

Briefly, it now reads that any bill or resolve carrying money on it, either an appropriation or cost, or an increase in monies, will be referred to the Appropriations Committee for their attention, and it does cross out some of this other ambiguous language.

The PRESIDENT: Will all those Senators in favor of the passage of this order please rise and remain standing until counted. Those opposed please rise and remain standing until counted.

A division was had. 30 Senators having voted in the affirmative, and no Senators having voted in the negative, with three being absent, the Order received Passage.

There are included in this group several Maine people, and it is very much in order that the legislature in behalf of the people of the State of Maine officially express the deep gratitude of the people to these men for their many, many long days of imprisonment and privation.

It is provided in the order that under the direction of the Adjutant General of the State, at such time as most of these men find themselves in the State, that we will have the honor and privilege of greeting them here in the halls of the legislature.

Pending — Acceptance of Report. Thereupon, the Ought to Pass Report of the Committee was Accepted in concurrence, the Bill Read Once and Tomorrow Assigned for Second Reading.

Bill, "An Act Appropriating Funds for an International Arrivals Building at Bangor International Airport." (H. P. 175) (L. D. 217)

Tabled — February 20, 1973 by Senator Sewall of Penobscot.

Pending — Enactment.

Mr. Sewall of Penobscot then moved the pending question.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brennan.

Mr. BRENNAN: Mr. President and Members of the Senate: I think, as you all know, items like this usually go to the Appropriations Table and compete with other demands on the state treasury somewhat equally towards the end of the session. However, while an early appropriation is unusual, it is not unprecedented, and it is my understanding that Bangor needs this appropriation now in order to meet a certain c o n s t r u c t i o n deadline.

Now, I believe that appropriations to improve our transportation facilities are of vital importance to the State of Maine. Maine endures a comparative economic disadvantage because of its relative isolation from the major markets and major suppliers in the United States. We need modern, efficient transportation facilities in order to reduce the disadvantage of distance between us. It is my belief that air, rail, and sea transport should all be given a major priority for us so that we can assist the Maine economy to prosper. So it is for these reasons that I support this unusual expediting of the appropriation of this bill so it will go on to the Governor's desk, and for all those reasons I urge support for the motion of the distinguished Senator from Penobscot, Senator Sewall.

The PRESIDENT: Is the Senate

ready for the qsestion?

Thereupon, this being an emergency measure and having received the affirmative vote of 30 members of the Senate, was Passed to be Enacted and, having been signed by the President, was by the Secretary presented to the Governor for his approval.

Reconsidered Matter

On motion by Mr. Cianchette of Somerset, the Senate voted to reconsider its action of yesterday whereby Bill, "An Act Relating to Apportionment of Cost of Reconstruction of Railroad Grade Separation Structures on Nonfederal Aid-State Aid Highways" (S. P. 136) (L. D. 348) was Passed to be Engrossed.
