Mr. Anderson of Hancock then moved that the Senate Accept the Majority Ought Not to Pass Report of the Committee.

The PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE: Mr. President and Members of the Senate: I would oppose the motion of my learned colleague and dear friend, the distinguished Senator from Hancock.

This is one of my several children before this body and, being of a protective nature, I feel that I must defend this bill. To give you some history on it, it was proposed to me by a member of my own community who represents a group of rabbit hunters in Franklin County. These people, unfortunately, have to work five and a half or six days a week, unlike most of us I might add, therefore, they find it difficult to follow their recreational pursuit of rabbit hunting in the short time left to them on a Saturday aftersoon. So they are requesting that they be permitted to hunt rabbits on Sunday. They aren't asking for anything else. They aren't asking that they hunt deer, moose, or any other animal; just rabbits during the open season for rabbit hunting.

These gentlemen appeared at the hearing about three weeks ago and they were supported by others from other parts of the state — a gentleman from Sagadahoc, another one from Lincoln — who reinforced the testimony of people from Somerset and Franklin Counties. They would like to follow the recreation of hunting rabbits on Sunday. Just as those people have the right to go fishing on Sunday, go snowmobiling, go

skiing, they would like to follow their desired recreational pursuit of hunting on Sunday. The testimony was all by the proponents, and there was only one opponent; that being the Deputy Commissioner of Fisheries and Wildlife, Mr. Peppard, who said that there are little enough rabbits in the State of Maine so he didn't think that the pressure on the rabbits was warranted.

I would take hearty disagreement with Mr. Peppard's findings because as an old rabbit hunter myself I found that there is no dearth of rabbits, particularly in the Franklin County area. So, in support of one of my children, I would like to ask for a division on the motion before you.

The PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Anderson.

Mr. ANDERSON: Mr. President and Members of the Senate: Let me reiterate what the good Senator from Franklin Senator Shute, has said, that this is not his brainchild; he was requested to put it in by a constituent.

Now, rabbits are just beginning to make a comeback, and I don't believe that they will stand the pressure of seven days' hunting; they should have at least one day of rest. It would be the temptation, I am sure, of quite a few hunters to take along a couple of buckshot shells with them and take a crack at a deer. Now, as you know, our deer herd is rapidly diminishing and we can't do anything to help out these poachers; we have got to curb it in every way we can. Deer are hunted six days a week. and I think they should have one day of rest free of baying hounds and exploding firearms. And again, sincerely believe that it is sacrilegious to use firearms and hunt on Sunday. This will simply open the door to all Sunday hunting. I am very much opposed to it and, Mr. President, I move indefinite postponement of this bill.

The PRESIDENT: The Senator from Hancock, Senator Anderson, now moves that Bill, "An Act Permitting Sunday Hunting of Rabbits," (S. P. 36) (L. D. 102) be Indefinitely Postponed.

The Chair recognizes the Senator

from Franklin, Senator Shute. Mr. SHUTE: Mr. President and Members of the Senate: I would just like to correct two impressions that the Senator from Hancock, Senator Anderson, left with you: first of all, it may be sacrilegious for the Senator to hunt on Sunday. but our good neighbors to the west of us in New Hampshire do hunt deer on Sunday. Secondly, I would like to protect the good name of hunters in Franklin County particularly, and if he is suggesting that they would go out with buckshot and hunt on Sunday, hunt for deer, this is not true; there are no poachers in Franklin County.

The PRESIDENT: The recognizes the Senator from Penobscot, Senator Sewall.

Mr. SEWALL: Mr. President, I would like to pose a question through the Chair to the good Senator from Franklin, Senator Shute. Number one, is there any kind of hunting allowed on Sunday? Number two, I guess, how do the rabbits feel about this?

The PRESIDENT: The Senator from Penobscot, Senator Sewall, has posed two questions through the Chair which the Senator from Franklin may answer if he desires.

The Chair recognizes the Senator from Franklin, Senator Shute.

Mr. SHUTE: Mr. President and Members of the Senate: The rabbits are not too happy about have heen bill. They multiplying as usual and there are apparently as many rabbits as there have been in the past. Last year a group of us hunted in a particular area and during the hunting season we shot well over one hundred rabbits. We go back to the same area this year and find fully as many rabbits as there were last year.

Your first question, may I ask the clerk to read the first question?

PRESIDENT: The would inform the Senator that the first question was: Is there any Sunday hunting allowed at the present time?

Mr. SHUTE: Mr. President and Members of the Senate: There is no Sunday hunting of any kind permitted in this state.

The PRESIDENT: Is the Senate ready for the question? The pending question before the Senate is the motion of the Senator from Hancock, Senator Anderson, that Bill, "An Act Permitting Sunday Hunting of Rabbits" be indefinitely postponed. As many Senators as are in favor of indefinite postponement will please say yes: those opposed no. The Chair is in doubt and will order a division.

The Chair recognizes the Senator from Penobscot, Senator Tanous.

Mr. TANOUS: Mr. President and Members of the Senate: I certainly hadn't intended to speak on this subject matter, but since rabbits are in season and since equal rights are also in season - I have always opposed Sunday hunting bills, not for the reasons I have heard here this morning, but we have many, many thousands of non-hunters in the State of Maine. There are thousands of them who enjoy the woods, believe it or not, and most of these people don't like to go into the woods during the week when there is gunfire going around them. They like one day out of the week to at least enjoy the woods, and we do have the most beautiful woods in the world State of Maine. in the especially during hunting season. They love to go out in the woods on picnics on Sundays with their wives and children and not have to fear gunfire coming over them. So for this reason I oppose this particular bill.

The PRESIDENT: The Chair from the Senator recognizes Franklin, Senator Shute.

Mr. SHUTE: Mr. President and Members of the Senate: In the matter of walking in the woods on a Sunday enjoying the beauties of nature, I am heartily in agreement with the views of the Senator from Penobscot, Senator Tanous. It is just as difficult for one to go walking in the woods either skiing or snowshoeing on a winters day because one has to be wary of speeding snowmobilers. So take your pick: watch out for number six shot or be knocked down by a speeding snowmobiler.

The PRESIDENT: Is the Senate ready for the question? pending question before the Senate is the motion of the Senator from Hancock, Senator Anderson that Bill "An Act Permitting Sunday Hunting of Rabbits" be indefinitely postponed. As many Senators as are in favor of the motion to indefinitely postpone the bill will please rise and remain standing until counted. Those opposed will please rise and remain standing until counted.

A division was had. Twenty-two Senators having voted in the affirmative, and eight Senators having voted in the negative, the Bill was Indefinitely Postponed.
