#### After Recess

Called to order by the President. The PRESIDENT: The Chair is very pleased to note the presence in the Senate Chamber this morning of a very distinguished young lady, Miss Brenda Snowman of Caribou, who holds the title this year of Maine Potato Blossom Queen.

I would like to ask the Senator from Aroostook, Senator Cyr, if he would escort Miss Snowman to the rostrum for any remarks she might care to make.

Thereupon, Senator Cyr of Aroostook escorted Miss Snowman to the rostrum where she addressed the Senate as follows:

Miss SNOWMAN: Mr. President and Members of the Senate: I would like to thank you very much for the honor bestowed upon me today in being presented to the Senate.

I would like to mention that the bag of potatoes that you found on your desk this morning is with the compliments of the Maine Potato Commission and that this week is Maine Potato Week, March 7th through the 17th. Thank you.

Thereupon, Senator Cyr escorted Miss Snowman from the rostrum to the rear of the Chamber amid the applause of the Senate, the members rising.

Mr. Shute of Franklin was granted unanimous consent to address the Senate:

Mr. SHUTE: Mr. President, many years ago when I was discharged from the Marine Corps at Bainbridge, Maryland, I was told— I am sure it was in jest—by some of the officers present that some of the states had seen fit to pass out bonuses to the returning veterans, but Maine was in fact giving a sack of potatoes to its returning veterans. I am glad today I have received my bonus, and I thank the sponsors of this very much.

Mr. President, in another vein, it distressed me a great deal to read a headline in a local paper this morning, and I will have to credit it to irresponsible journalism. But my seatmate and I, the good Senator from Knox, Senator Huber, are at least two members here who derive part of our income from broadcasting and the dissemination of news, and as a sponsor of a so-called "Shield Bill' which would protect sources that newsmen have for their news that they provide for the public, free flow of information. I am very much distressed to see this type of irresponsible headline writing. I can't credit it to the reporter who was here yesterday, but any person who suggests that the State Senate yesterday bowed to pressure on the Equal Rights Amendment vote doesn't know what he is talking about, because if indeed we had all bowed to pressure that occurred from Wednesday until yesterday's vote, I am sure that the vote would have gone the other way.

I do decry this type of headline writing and I regret it because this is part of my profession.
