Mr. CIANCHETTE: Mr. President and Members of the Senate: I rise to support Senator Anderson, and I would just like to say a word. I think this open season on moose here is a little ridiculous, and I hope the Senate will go along with the motion of Senator Anderson of Hancock.

When I see this open season on moose, it is just like jacking deer under a light, and I would like to show why I think that open season on moose would be similar to jacking deer under a light. As you know, the light will attract the deer. He will stand there and look at that light, and you have an opportunity to shoot him. It is absolutely no sport at all. Well, I think the same thing can happen to the moose in the daytime. With a simple little device, just a piece of birch bark rolled up, you can stand back in the woods and (demonstrating with call device), so that moose will come right to you. You can sit right down there and shoot the moose. Now, I claim that is no sport at all, and we don't need anything like that in

Maine. The next time I go hunting moose, it will be with my call and a camera. (Applause)

Joint Resolution STATE OF MAINE

In the Year of Our Lord One Thousand Nine Hundred and Seventy-Three

Joint Resolution in Opposition to Reduced or Substitute Telegraph Service at Augusta, the Capital City of the State of Maine

WE, your Memorialists, the House of Representatives and Senate of the State of Maine in the One Hundred and Sixth Legislative Session assembled, most respectfully present and petition the Federal Communications Commission and all appropriate divisions thereof, as follows; and

divisions thereof, as follows; and WHEREAS, the Western Union Telegraph Company applied on March 8, 1973, to the Federal Communications Commission for permission to discontinue its present Class 1 teleprinter-operated office on Water Street, Augusta, with substitute service to be provided by Depot News, Water Street, Augusta; and

WHEREAS, the adequacy of such service is of vital concern to Maine citizens with Augusta being the seat of State and County Government, and containing the main offices of Central Maine Power Company, Federal agencies and Veterans Administration; and

WHEREAS, the existing Class 1 office at Augusta is an experienced, competent and confidential operation, all of which may be lost through substitute service of lesser class; and

WHEREAS, the Legislature utilizes and depends upon this service, both for outgoing and incoming messages, with particular emphasis on the latter; and

WHEREAS, closure of the present office will have serious impact on the ability of such Departments of Transportation and Motor Vehicles to promptly and economically receive or transmit

by telegram vital information; and WHEREAS, in addition to uncooperative clerks receiving incoming telegrams, there is a considerable time lag in delivery of telegrams using the Centralized Telephone Bureau of Western Union at Moorestown, New Jersey as proposed; and

WHEREAS, the Federal Communications Commission approves or disapproves applications of this nature and considers all relevant opinions in reviewing said application; now, therefore, be it

RESOLVED: That we, respectfully Memorialists. recommend and urge the Federal Communications Commission and all applicable divisions thereof to take immediate and appropriate action to dismiss application No. T-D-20042-A now before the Domestic Services and Facilities Division of the Commission and to continue the existing Class 1 telegraph service in the Capital City of Augusta, Maine at its present location and level; and be it further

RESOLVED: That a duly authenticated copy of this Memorial be transmitted forthwith by the Secretary of State to said Commission and Division of the United States Government at Washington, D.C. (H. P. 1445)

The PRESIDENT: The Chair would like to announce that we have a very distinguished visitor with us this morning, Mrs. Gladys M. Spellman, President of the National Association of Counties. Mrs. Spellman is a County Council member from Prince Georges County, Maryland, the first woman ever elected to office in the National Association of Counties and also the first woman ever elected to the Governing Board of Prince Georges County, Maryland,

populous suburban county adjacent to Washington, D.C.

Mrs. Spellman is accompanied here to the Senate Chamber this morning by Paul Reny, a former member of this body and President Maine County Commisof the Paul sioners Association. i s accompanied by his wife, Pat, who understand is a City Council member in Saco, and the first woman to be elected to the City Council in Saco. They are also accompanied by Mr. Robert Vice President of the Barter, Maine County Commissioners Association; Mr. Roland Landry, Executive Secretary of the Maine County Commissioners Associa-Mr. Earl Banks, accomtion: panied by Mrs. Banks, Past President of the Maine County Commissioners Association.

I would like to ask the Sergeantat-Arms to escort Mrs. Spellman to the rostrum for any remarks she might care to make. (Applause)

Thereupon, the Sergeant-at-Arms escorted Mrs. Spellman to the rostrum where she addressed the

Senate as follows:

Mrs. SPELLMAN: Thank you very much, Mr. President. I felt that I was privileged to be here on a day when we had such an interesting demonstration. That is beautiful and it will be something that I will go home with. I thoroughly agree with your sentiments.

It is a real pleasure to be here because my coming here indicates that there are things afoot here in the State of Maine. The first step in any reform is to recognize that reform is needed, and we have gone beyond that step here in the State of Maine; we are about to do something on reforming government.

I have just recently been appointed to a commission — I serve on four of my Governor's commissions — and I have just recently been appointed to his newest one, and the one that we think is the most important, one to study the reorganization of our state government.

I was stunned some months ago when I first came into Maine to learn how impotent county government is here. It became very, very apparent that the lack of home rule seriously has impaired the responsiveness of county government and the quality of county services, and that it has created a log jam right here in the state legislature, with county budgets not moving as they should, with 2,000 - I understand you folks will have gone through 2,000 bills before you leave in this session - many, many of which really could best be handled on the local level.

I had the great privilege of serving on the President's Advisory Commission on Intergovernmental Relations when we studied Legislatures, and we found truly that in many cases the legislature was the weakest link in the states' governments because they were so bogged down with studying local matters, because they had not moved to put government closer to the people.

Now, we are at this point at a new era in government. I am a Democrat, but I must give a great deal of credit to our Republican President, who is attempting to put government back into the state and into the local levels. And this is the time when state and local government officials can't afford to miss a chance to prove that what we have been saying all along, that government works best when it is closest to the people, that government close to the people can really be an effective instrument for bringing about the change and improvement in the lives of our people.

This is the time when we have got to be thinking big. I have a friend at the White House who says he can measure the worth of a legislator by the way he votes on home rule matters. He says this is where you separate the men from the boys. I take it for granted he thinks we women always vote right; he didn't talk about us. But he said this is where you separate the men from the boys. The boys think in local terms. They think that state legislators are there to take care of each local problem, while the men recognize that these local problems ought to be handled at home and that they are there to take care of the matters that can be handled only on a state level.

Here in the State of Maine you have really been missing something that is really important. The impotence of county government has robbed your citizens of a vital level of government. It is the destiny of the county to bring America together at the local level. The county is prima facie a regional unit of government, a meaningful transition between the purely local government affairs, which are handled by the municipalities, and the state and the federal affairs.

I want to share with you -- I know I am taking too long, but I think this is kind of priceless — I got this from the White House just the other day, and it shows us that this whole problem of intergovernmental relations is one that has been around for quite some time. This is a memo sent by Franklin D. Roosevelt on the subject of conservation — and that fits right in with this morning, doesn't it - I think it is kind of priceless. He sent it to Harold Smith, who was the Director of the Budget at the time.

"Memorandum for the Director of the Budget. Dated July 28, 1939. I agree with the Secretary of Interior." Some of you who are old enough to remember remember that Harold Ickes was then Secretary of the Interior. He says "Please have it carried out so that furbearing animals remain in the Department of the Interior. You might find out if any Alaska bears are still supervised by, A. War Department, B. the Department of Agriculture, C. the Department of Commerce. They have all had jurisdiction over Alaska bears in the past and many embarrassing situations have been created by the mating of a bear belonging to one department with another bear belonging to another department." He says "P.S. I don't think the Navy is involved, but it may be. Check also on the Coast Guard; you never can tell."

So, you see, back in those days too we had struggles over who was going to do what. Around the states today, I am very happy to say, studies are being made and that allocations of functions are being assigned to that level of government which can best handle the job. I am hopeful, and frankly I am almost certain, that you will be passing a bill on government reform, that you will be giving home rule to your counties, that you will make them the vital unit of government that they ought to be, and at that time I know that your legislature will be able to do the job for which you were created.

I learned many years ago when I was a little girl that as Maine goes so goes the nation, but you are going to have to rush because around the nation these reforms have been made and are being made, so let's catch up. Thank you very much for inviting us.

Thereupon, the Sergeant-at-Arms escorted Mrs. Spellman to the rear of the chamber amidst the applause of the Senate, the members rising.
