Mr. BERRY: Mr. President, we have been waiting for an amendment on this bill, which will be ready tomorrow. In anticipation of that, I would like to move that the rules be suspended and the Senate reconsider its action whereby this bill was passed to be engrossed.

On motion by Mr. Sewall of Penobscot, recessed, pending the sounding of the bell.

After Recess

Called to order by the President.

Out of order and under suspension of the rules, the Senate voted to take up the following:

Order

On motion by Mr. Speers of Kennebec,

ORDERED, the House concurring, that the Joint Standing Committee on State Government is directed to report out a bill "An Act to Redistribute Certain Statutory Powers Now Vested in the Executive Council." (S. P. 831)

Which was Read and Passed.

Under suspension of the rules, sent down forthwith for concurrence.

Mr. Speers of Kennebec was granted unanimous consent to address the Senate.

Mr. SPEERS: Mr. President and Members of the Senate: There came to my attention last night what I regard as a rather serious situation in the State of Maine. I attended a Kennebec County Republican Caucus and was informed, as were those others who were present, that there are some newspaper media in the State of Maine which are henceforth refusing to print notices of political caucuses in this state as news items and that they will henceforth be printing them as legal notices, requiring payment by those county and town caucuses, town parties, in order to print these notices.

I think it is axiomatic, particularly in this year, that government in general is being attacked, that the populace in general is rather cynical of government, and that the best way to approach this problem is to get more and more people involved in our political process. This is the very basis of democracy and it should be encouraged in every way possible.

Last Spring I introduced a measure which would require that all political caucuses on both sides of the aisle in every town of the state be held on one single day. And as you recall the debate on that measure, it was my intent and my hope that the news media of the state would advertise and would comment upon that single caucus day to such an extent that the people of the state would be well aware that this is the basic foundation of the political process and that they would be more inclined to participate in it. It was my hope that there would be articles in the newspapers, that there would be comments in editorials, that there would be comments on the radio, that there would be comments on television, urging individuals to become involved in our political process and to attend those town caucuses. What have we had for a response? We have had, on the part of some newspapers of the state. the attitude that, far from advertising and commenting on these caucuses to a far greater extent than has been the case in the past, they no longer are even going to print them as news items, and are go-

ing to relegate them to the status of legal notices — and I think we all understand how often those are read — and ask the various parties to pay for these notices as well.

I think this is very much akin to taking the attitude that an election on November 7th or November 5th, or whenever the general election is held in any particular year, should be relegated to the status of a legal notice and that there should be no more comment and no news stories written about it in the newspapers.

I certainly hope that these remarks find their way to the appropriate individuals who are making this kind of a policy, and I consider this attitude on the part of the media of the State of Maine nothing short of disgraceful. Thank you, Mr. President.
