SENATE

Friday, March 1, 1974 Called to order by the President.

Prayer by the Rev. Douglas H. Robbins of Augusta:

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Clifford.

Mr. CLIFFORD: Mr. President, on these three bills we are not talking about whether they should pass or fail; we are merely talking about whether or not they should be referred to a committee. As I understand it, they reflect a great amount of time spent in preparation and, as I understand it, they are agreed upon with much of industry and much of labor and I think it would be a shame for us to postpone them before they have had a chance to be heard by the committee. I would oppose the motion of the good Senator from Cumberland, Senator Berry, and hope that you would at least allow these a public hearing before the Committee on Labor. Thank you.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY: Mr. President and Members of the Senate: I invite the attention of all members of the body to the two calendars in front of us and the starting off with numeral 1 of the new month. Now, there has been a long time to introduce legislation. They were in the Governor's call, all these items, and there was plenty of time to prepare them. We are not discussing the merit of them or the lack of merit of them, but we have a practical problem that some of us have got to get back and do some spring plowing, and I hope you would support me in my request. I ask for a division.

The PRESIDENT: A division has been requested. As many Senators as are in favor of the motion of the Senator from Cumberland, Senator Berry, that Items 1-1, 1-2 and 1-3 be indefinitely postponed in non-concurrence will please rise and remain standing until counted.

A division was had. 18 Senators having voted in the affirmative, and seven Senators having voted in the negative, the three Bills were Indefinitely Postponed in non-concurrence.

Thereupon, under suspension of the rules, sent down forthwith for concurrence.

Mr. SPEERS: Mr. President, I would like to thank the Minority Leader of the other branch of the legislature for the introduction of this particular bill at this particular time. I would like to call the attention of the Senate to the fact that it was not too many weeks ago when reference was made to the slowness of the legislative process, to the fact that many bills were presently in the Committee on State Government, and the expression of desire that many of these bills would come out of the Committee on State Government.

Well, up to this point, Mr. President, we have held all of our public hearings and we have very few bills left in that committee. We have had 72 bills in the Committee on State Government, more than any other committee in this legislature, and we have been working very diligently, as I am sure all the committees have, to get these bills reported out.

I think it a bit incongruous, the comments having been made as to the slowness of the legislative process, that another bill just at this point comes in and has a public hearing and be considered by the Committee. I would like to point out that it seems it is not really the legislative process or the Committee on State Government that should be singled out as perhaps holding up some of the legislative considerations.

The PRESIDENT: Is it now the pleasure of the Senate that this bill be referred to the Committee on State Government?

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowsky:

Mr. MINKOWSKY: Mr. President and Members of the Senate: I wonder if somebody from the State Government Committee could give us an explanation as to the intent and purpose of this particular piece of legislation.

The PRESIDENT: The Senator from Androscoggin, Senator Minkowsky, has posed a question through the Chair which any member of the Committee may answer if he desires.

The Chair recognizes the Senator from Androscoggin, Senator Clifford.

Mr. CLIFFORD: Mr. President and Members of the Senate: L. D. 2528 is an act which establishes a commission on Maine's future. It is a recommendation of the Maine Management Cost Survey. What it does is create a commission composed of citizens and legislators from all different parts of the state to study and make recommendations as to. as the bill says on Page 2, a growth and development policy for the State of Maine, collecting information regarding the future of the State of Maine, information on growth, interstate and intrastate migration patterns, and generally to go along with the national Committee on Critical Choices so that Maine would have a better input, especially from citizens, as to its future course of action.

The committee felt that the recommendation of the Cost Management Survey Commission was a good one and the committee went along with it, although we made several changes to ensure that there were representatives on this commission from all different parts of the state.

The bill is only three pages long and I think it is self-explanatory, but I think it was a fairly unanimous, if not unanimous, committee report from the Committee on State Government. There is no appropriation, and it is anticipated that there will be a grant forthcoming to fund the Commission on Maine's future.

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkowsky.

Mr. MINKOWSKY: Mr. President and Members of the Senate: I am just wondering if this is not just overlapping services that are being asked to be performed through this piece of legislation because the Department of Commerce and Industry is compiling information upon Maine's future development and so is the State Planning Office. I just cannot see adding on another layer in this bureaucratic system, even though it might be a task force of this type. I would ask that this bill be indefinitely postponed.

The PRESIDENT: The Senator from Androscoggin, Senator Minkowsky, now moves that item 7-1 be indefinitely postponed.

The Chair recognizes the Senator from Androscoggin, Senator Clifford.

Mr. CLIFFORD: Mr. President and Members of the Senate: I think the main difference between the information being gathered by the Department of Commerce and Industry and the State Planning Office, the difference in the thrust of the bill, is that this requires and gets citizen input. I think there has been a feeling that there has been too much bureaucratic input. I would request a division on the motion of the good Senator from Androscoggin.

The PRESIDENT: A division has been requested.

The Chair recognizes the Senator from Cumberland, Senator Berry.

Mr. BERRY: Mr. President and Members of the Senate: I am extremely appreciative of the fact that our good Senator, Senator Minkowsky from Androscoggin, has subjected this little bill to some scrutiny. I think perhaps we were sitting back in our seats yesterday where it got its initial acceptance.

I think that the State Planning Office has a role which is on the statute books and which they seem to pursue and discharge quite effectively. Responding to Senator Clifford's comments about citizen input, the State Planning Office in its numerous programs has held a lot of hearings all around the state on all sorts of planning subjects and our future. This seems to be crystal ball gazing and I wish we could accomplish such laudable objectives. I would commend, of course, the reading of the members to the bill, but I always get put in orbit when I read language like this: "These findings shall be articulated into a working document, and the commission is going to recommend a desirable and feasible description of the state's future." This is what I think is totally impossible.

Whether this is a big brother lining up our future for us or crystal ball gazing, or what other efforts we can take to determine the future, hazel twitching or apple twitching, or something like that, but I think as you read through on page 2 under Subsection 3310, that we have here an absolutely impossible situation. The nub of it would be item C. "A description of the future of the state as envisioned by Maine people." I think we in the legislature are working desperately to attempt to make this future as good as we can. If we are going to try to say where are we going to be twenty years from now, with our population shifts, our economic problems, our petroleum refineries, and all of the various problems we have, it seems to me we are asking too much for a non-paid, non-expense reimbursed operation. I strongly would support the motion of Senator Minkowsky for indefinite postponement.

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Henley.

Mr. HENLEY: Mr. President and Members of the Senate: I too would like to second my good friend Senator Minkowsky's motion. I only perhaps regret that I didn't notice it before. I feel that the idea behind this perhaps is solid and strong, but where are we headed in this legislature of ours when, it seems to me, session after session we are somehow setting up groups, bodies, boards, commissions, etc. to do the job we are elected to do?

It just seems to me that, as my good friend Senator Berry stated, we are very intent on helping plan and further the success and the happiness of the people of Maine and its future, and I don't see any reason why we shouldn't be in a position to do these same things ourselves. I have been very critical of new commissions and boards and groupings previously established. whether they had huge sums of money attached or not, to do these same things which we should be doing. I wonder how soon it would be when the business of the state would be conducted by departments, commissions and special committees set up. I think we can do very well without this bill, and I shall certainly vote for indefinite postponement.

The PRESIDENT: The pending motion before the Senate is the motion of the Senator from Androscoggin, Senator Minkowsky, that Bill, "An Act

Establishing a Commission on Maine's Future', be indefinitely postponed.

The Chair recognizes the Senator from Somerset, Senator Cianchette.

Mr. CIANCHETTE: Mr. President, I would ask for a roll call.

The PRESIDENT: A roll call has been requested. Under the Constitution, in order for the Chair to order a roll call, it requires the affirmative vote of at least one-fifth of those Senators present and voting. Will all those Senators in favor of ordering a roll call please rise and remain standing until counted.

Obviously more than one-fifth having arisen, a roll call is ordered. The pending motion before the Senate is the motion of the Senator from Androscoggin, Senator Minkowsky, that Bill, "An Act Establishing a Commission on Maine's Future," be indefinitely postponed. Mr. CLIFFORD: Mr. President and Members of the Senate: This bill is one in its original form which provides that each municipality would be served by a local or inter-jurisdictional agency for emergency preparedness, which most likely would be the Civil Defense Agency. It sets up the procedures for this. This amendment really should have been a committee amendment because the committee had agreed on it, but the bill got out before the committee amendment was put together, and it gives the Governor more flexibility in organizing the emergency preparedness capability by allowing him to appoint municipal CD officers or inter-jurisdictional CD officers or county officers. The original bill mandated him to appoint the county officers, and this gives him more flexibility. I think even though the amendment is long, I don't think there really is that much of a difference in substance from the original bill. Thank you.

The PRESIDENT: Is it now the pleasure of the Senate to adopt Senate Amendment "A"?

Thereupon, Senate Amendment "A" was Adopted and the Bill, as Amended, Passed to be Engrossed.

It would establish a salary for the director and clarify one other point in the bill. Therefore, Mr. President, I move adoption of Senate Amendment "A".

The PRESIDENT: Is it now the pleasure of the Senate to adopt Senate Amendment "A"?

Reconsidered Matter

On motion by Mr. Conley of Cumberland, the Senate voted to reconsider its action of yesterday whereby Bill, "An Act to Clarify Certain Election Laws", (S. P. 914) (L. D. 2526), was Passed to be Engrossed.

On further motion by the same Senator, the Senate voted to reconsider its action whereby Senate Amendment "A" was Adopted and subsequently Indefinitely Postponed Senate Amendment "A"

The PRESIDENT: The Chair recognizes the same Senator.

Mr. CONLEY: Mr. President and Members of the Senate: I think I should explain to the Senate something that happened yesterday. It is sort of a mystery to me, but the amendment that was offered yesterday was put on the wrong bill. I know the staff in our State House is so efficient that the blame would have to lie with me perhaps, so I will accept it. Mr. President, the amendment is not changed at all other than the fact that we are now amending the new draft of the bill.

I present Senate Amendment "A" and move its adoption.

The PRESIDENT: The same Senator now offers Senate Amendment "A" and moves its adoption. The Secretary will read the amendment.

Senate Amendment "A", Filing No. S-373, was Read and Adopted.

On motion by Mr. Shute of Franklin. tabled and Specially Assigned for March 5, 1974, pending Passage to be Engrossed.

(Off Record Remarks)

Mr. Shute of Franklin was granted unanimous consent to address the Senate:

Mr. SHUTE: Mr. President and Members of the Senate: As a graduate of your course which you prescribe, and as a graduate of the Dale Carnegie course, I respectfully would like to correct an impression left with you earlier with reference to 1-4. When Senator Speers made reference to the sponsorship of L.D. 2532 and, as a member of the Maine Committee on Aging, I feel compelled to tell you that this bill is probably one of the most important the committee has been considering. Its original sponsor, it so happens, was Representative Curtis from Orono. The bill has had some difficulty in its preparation and, in order to a c c o m m o d at e s o m e of the recommendations of the Cost Management Survey group, it had a

difficult time, and this is the result of its late appearance. I would like to correct that impression left by the good Senator.

The PRESIDENT: The Chair would like to caution the Senator about the Senate Rule which states you should not refer to people in the other branch, particularly the Representative from Orono.
