#### HOUSE

Thursday, January 9, 1975 The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Robert M. Butler of Jefferson.

The journal of yesterday was read and approved.

The SPEAKER: The Governor of the State of Maine, James B. Longley. It is my pleasure to present to you, and to the members of the House, the Governor of the State Covernor for the State Covernor Longley. State, Governor Longley

GOVERNOR LONGLEY: Mr. Speaker and Legislators: I do not intend to make this a practice. I appreciate this opportunity to appear before you this morning. I am here to say that your Representative and mine, Spike Carey. is a fine person, and he did what he thought was right. I think we can all learn from our mistakes as well as our actions, and I just speak in defense of his right to do what he. did yesterday.

I ask you to keep in mind that we have an unusual and unique situation here in Maine. The entire country is watching us, and I am sure you want, as I want, to be fair. I was elected by the people of Maine. The people who elected me were not here yesterday, and I did not have a party here to defend me. So I ask you to recognize the right of one of your Body to speak as he spoke yesterday. He was my friend before

he spoke — he is still my friend. I respect him. I respect his candor. And with that, I ask this Body to get on with the business of government and forget about yesterday, except to the extent that all of us, most of all your Governor, admittedly has much to learn.

I said before elected that there would be no person who ever worked harder to be the Governor of the people of this State, and I will say there will be no person more willing to step forward and say he has made a mistake and he is sorry and he apologizes.

I ask this Body to keep in mind that when criticism is leveled at the Governor of this State, it should be taken as criticism of a person and hopefully not criticism of the office. We should all learn from constructive and fair criticism. Hopefully, I am learning with each passing day. I need your help. I pledge my cooperation and I pledge you to do everything humanly possible to bring honor and credit on the government of this State and the Office of Governor. Thank you very, very much. (Prolonged applause)

At the conclusion of the address, the Governor withdrew from the House amid applause, the Members rising.

#### Orders

Mr. Jalbert of Lewiston presented the following Joint Order and moved its passage:

Ordered, the Senate concurring, that the Joint Standing Committee on Election Laws be authorized and directed to examine the election laws of this State as provided in Title 21 of the Maine Revised Statutes and related titles for the purpose of ascertaining as economically as possible all necessary repealers, amendments and modifications of existing laws as, in the judgment of the Committee. are necessary and appropriate and to consolidate all such repealers, amendments, modifications and recommendations in final legislative draft form for appropriate consideration at the regular session of the 107th Legislature. (H. P. 136)

The Order was read.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jalbert.

MR. JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: What prompted me to put this order in, was that quite a few years ago, there were single individual bills put in for all counties, wherein it concerned itself with increases in salaries for members of county government. We would be flooded with a hike for the Clerk of Courts in Lincoln County and a hike for the Sheriff in Cumberland and a hike for the Judge of Probate in Androscoggin and so on down the line. I have seen us, believe it or not, debate on one of these bills for two or three days at a time. I have cleared this order with the Speaker and leadership of both parties and the Chairman of the Election Laws Committee.

One, this would possibly allow the Election Laws Division to probably take some of the stuff on there that shouldn't be there. Two, a great many bills of duplication form — I mean they would all come out in some way or another. This could allow them on some of the bills that are before them to add this on under one roof, make an omnibus bill out of it, of those bills that they would agree upon, and those that were going to get the axe, give it to 17-A, give it to it. Then the bills that couldn't be agreed upon would be coming out as usual in the divided reports.

I think it would allow one big omnibus bill - I know it would. It would also allow the saving of a great deal of time by debating it for one day and allowing amendments to go on for one day. It is a time saver and I think it is badly needed. Mr. Speaker, I hope the order receives passage.

Thereupon, the Joint Order received passage and was sent up for concurrence.

Mr. Rolde of York presented the following Order and moved its passage:

ORDERED, that 5 Clerk-stenographers be employed to provide stenographic and clerical assistance to the Members of the House. Such Clerk-stenographers shall be selected, 3 by the Speaker of the House of

Representatives and 2 by the Minority Leader; and be it further

ORDERED, that the Clerk of the House. include in his payroll of House Officers, the Clerk-stenographers so employed, at a salary approved by the Speaker, the House Majority Leader and the House Minority Leader.

The Order was read.

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rolde.

Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House. I believe the Order explains itself very clearly. I would just simply emphasize the fact that these clerk-stenographers will be at the service of the members of the House for any letters or documents that they are going to need typed.

I know that in the last session this would have been a great service to me because I type with one finger. The workload on the stenographers and secretaries of leadership was so great that I always was afraid to ask them to do any work for me. So I think this will be of great help to us in providing further service to our constituents. I hope the Order will be passed.

Thereupon, the Order received passage.
