### HOUSE

Tuesday, January 28, 1975 The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Herbert Reid of Fairfield.

The members stood at attention during the playing of the National Anthem by the Messalonskee High School Band of Oakland.

The journal of the previous session was read and approved.

Mrs. NAJARIAN: Mr. Speaker, Ladies and Gentlemen of the House: I would like to call your attention to the report on your desk today from the State Government Committee concerning its investigation of the Maine State Housing Authority

This report is important to the State Housing Authority and to the people of Maine. It answers all the questions that were raised concerning the authority during the last session of the legislature. The allegations against the Maine State Housing Authority before the State Government Committee were of an extremely serious nature. An extensive review of those allegations by the State Government Committee have established that they had no basis in fact. The report states on page 3, "The committee's confidence in the State Housing Authority is based on its review of action taken by the Authority and the Legislature since January of 1973. While the authority has faced significant problems, it has demonstrated an ability to deal with its problems effectively to correct its errors and to reorient itself when necessary.

I hope that this report will allow the Authority to move ahead with its program Authority to move anead with its program to improve Maine's housing conditions. The Authority is an important tool for helping Maine people and our economy, and I believe we can improve the Authority's enabling laws to expand its ability to conver This report should help ability to serve. This report should help clear the way for such legislative action. I would also like to report that the Authority now has a \$500,000 surplus.
