The SPEAKER: The Chair recognizes the gentleman from Eastport, Mr. Mills. Mr. MILLS: Mr. Speaker, I now move

that we insist on our previous action on this

The SPEAKER: The gentleman from Eastport, Mr. Mills, moves that the House insist.

The Chair recognizes the gentleman from Bar Harbor, Mr. MacLeod.
Mr. MacLEOD: Mr. Speaker, I move that we recede and concur and would

speak to my motion.

The SPEAKER: The gentleman from Bar Harbor, Mr. MacLeod, moves that the

House recede and concur with the Senate. The gentleman may proceed.

Mr. MacLEOD: Mr. Speaker, Ladies and Gentlemen of the House: For the benefit of some of the new legislators, and just to east a little light on this bill, it was passed in the 106th Legislature. It was a conservation measure, and there has been some testimony made pertaining to this bill that it was to try to find out certain statistics around the salmon fishing. This is partially true, but it was also put in as a conservation measure. We have a very priceless item in this state or natural resource, in my mind, in Atlantic salmon, which several clubs and organizations have tried over the years to upgrade the rivers and make conditions and build dams in order to improve the run of the Atlantic salmon

I had sponsored the bill. The bill had had a good hearing in the Fish and Game Committee and it had gotten a real good report out and it passed in the last session. Originally it was for a dollar tax stamp for the residents of the state and a \$10 stamp for the non-residents. However, in the committee it was changed and raised to a \$15 stamp for the non-resident. There is some objection to this amount.

However, I do feel at this time, although it has not been a big money maker, we did not plan for it to be a big money maker, we not plan for it to be a big money maker, the figures that it did bring in is a total revenue of \$3,743.25. Granted, this is not a huge amount of money in today's bureaucracy or today's governmental procedures, however, it is a small amount of money which has been able to be used by the Atlantic salmon people on the river in their endeavor to improve the conditions

I realize there is some objection to the bill from certain quarters. However, before it got its vote and passed along, I felt that some of these facts should be brought out. Bear in mind that it is a conservation measure and is acceptable by many, although the department feels it is not enforceable, that it is very difficult to enforce which I will to a certain degree agree upon. However, we passed a pheasant tax stamp here in a previous legislature which if a man was hunting pheasant or partridge he still had to go out and check his stamp to find out which he was hunting for.

I think, although this may be partially unenforceable, there are not enough fishermen involved in it that it has not reached that degree. As you all know, the out-of-state fishermen and our own fishermen will go fish the Canadian waters for this same fish and pay far more than they ever would in our state. Therefore, I move that we recede and concur.

The SPEAKER: The Chair recognizes the gentleman from Eastport, Mr. Mills.

Mr. MILLS: Mr. Speaker. Ladies and Gentlemen of the House: There are those in this state who would like to impose their will on the fishing waters of Washington County and that is what this bill originally was all about — to enact the stamp thing. It was for the purpose of getting statistics to find out where the salmon fishermen were coming from. There are also those who would like to impose their will on this matter also.

Now, the fishing clubs down in Washington County have put considerable time and money of their own, and in pretty good sizeable hunks, into establishing the salmon in the waters of Washington County are totally opposed to this thing. It is cutting down on their membership through some kind of thinking, which I can't explain to you, because they resent the fact that the stamp is in effect after putting these huge sums of money into removing the dams and clarifying the waters and getting the stocking done down there, which they did on their own before the federal programs came in.

I want to have this House vote to insist on our previous action and repeal this so we can improve the economy in Washington County in the fishing element and sporting

element to some degree.
The SPEAKER: The pending question is on motion of the gentleman from Bar Harbor, Mr. MacLeod that the House recede and concur with the Senate. All in favor will vote yes; those opposed will vote

57 having voted in the affirmative and 70 having voted in the negative, the motion did not prevail.
