He has proposed that this would be of use to our leadership and to us, especially in the Clerk's Office and the Secretary of the Senate's Office in putting our seal on special documents and things' of this sort. He has indicated to us that there would probably be little cost to it, and there is the possibility of some cost savings in a few clerical matters.

However, the majority of the committee felt that the legislature does not need the seal, and second of all, that we here have more important things to do than to create a State seal for ourselves. We can get along without it, and I think that the public, upon seeing us pass as one of the first ten or fifteen bills of the session create a State seal for ourselves resembling the seal on our flag that we use on other things would

not think so highly of our progress.
Finally, Mr. Birt suggested to the committee, to show you what an emergency he thinks it is, would like to see it be an emergency bill so that it could be used right away. I am just not sure the public wants to see us spending our time passing emergency legislation to create a

seal for the State Legislature.

Mr. HEWES: Mr. Speaker, Ladies and Gentlemen of the House: With reference to the pending resolution, I would like to add that Jane Callan Kilroy was a beautiful person. It was my pleasure to ride back and forth with her to Portland on many occasions, and just yesterday, as I drove through the storm on Interstate 91 in Yarmouth, I recalled the occasion several years ago when we became stuck and she got behind the wheel and an Air Corpsman and I pushed the car with her driving up the incline by Casco Bay Motors.

She was reelected year after year with only a minor expenditure for perhaps one ad in the Church World because of her dedication to service and her tenacity to

push a particular cause.

I recall back in the 103rd Legislature when on the final day of the session bills galore were being killed in the other body when they were taken from the Appropriations Committee, and she had a bill on the youth that she managed to get through there, it came back here, finally passed here despite a nearly 2 to 1 Republican majority, and eventually was

signed into law

I think that her greatest contribution perhaps was her three fine sons, one who lives on the Cape, one in South Portland and one in Delaware. She was no spectator; she was a participant. She became involved. She had compassion for everybody, having visited my mother on her death bed in Saco some years ago, cheering mother at that time, and she spoke with some of the world's greatest. She enjoyed a private audience with the Pope. She has shaken hands with President Franklin D. Roosevelt, President Harry S. Truman and President John Fitzgerald Kennedy.

The world is a better place because of

the activities of Jane Callan Kilroy.

Jane Callan Kilroy I met on inauguration day of Governor Louis J. Brann back on the first Wednesday of January in 1933. I have been fond of her giver since I was fond of her from that day ever since. I was fond of her from that day on. And I think that anyone who would say that Jane Callan Kilroy — and she liked to be called "Jane Callan Kilroy," and if you forgot the Callan, she quickly reminded

you of it.

Jane Callan Kilroy liked people. Her tenacity was beautiful to watch. When she wanted something, she really got it. If you forgot to have her sing a song at a function,

you quickly heard from her.

I know that everyone that knew Jane are chagrined by her passing. She contributed a great deal to this body. She contributed a great deal to her city, to her state, and she was a great mother. I am very very chagrined, as I know all of us are, of hearing of her passing.

I knew her only briefly, but I came to admire her very much. She had more than one occasion to give me somewhat motherly or grandmotherly advice, and the advice was well taken. I think she was a very wise woman and she knew a lot about the world. I really appreciated her advice.

In addition to that, we sort of had a special thing going between us, because I was sort of Jane's piano accompanist ex-officio up here for the past two years. I accompanied her in the singing of the Star Spangled Banner on a couple of official occasions and Jane seemed to enjoy my accompanying her.

I would just like to say that we are really

going to miss her.

Thereupon, the Joint Resolution was

adopted in concurrence.
