Mr. BIRT: Mr. Speaker, Ladies and Gentlemen of the House: I have long opposed this order; I have for several sessions. I haven't been too successful, but I fundamentally disagree with the philosophy of having a pamphlet or booklet circulated which has the salaries of every employee in the State, including members of the University of Maine.

I have supported and I do agree with the idea that the information should be available, a pamphlet of this type, a single copy, or a couple of copies in the Legislative Finance Office so that the information can be obtained if anybody wants it, I think it is proper. But to have a booklet of this type circulated, I basically am not in favor of it.

I move the indefinite postponement of the order

The SPEAKER: The gentleman from East Millinocket, Mr. Birt, moves that this Joint Order be indefinitely postponed.

The Chair recognizes the gentleman

from York, Mr. Rolde. Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: I did want to speak on this order, too. For the benefit of the new members, let me say this is a recurring and often a very controversial matter, which is the ordering the printing of the so-called "snoop book" that sets forth the salaries of state employees. This order has always occasioned a great deal of debate on whether or not this is a proper action to take.

This year, we would like to view this from a slightly different angle and see just what it costs us to have this book published. We are undertaking some research right now to see in this year of economic difficulty whether the "snoop book" is a luxury or it is something we can afford and must have. And until we do have the exact figures, I would appreciate it if somebody would table this item for me
