HOUSE

Tuesday, March 4, 1975 The House met according to adjournment and was called to order by the Speaker

Prayer by the Rev. E. Richard Wrentzel of Auburn.

The members stood at attention during the playing of the National Anthem by the

Mt. Ararat High School Band of Topsham. The journal of the previous session was read and approved.

Papers from the Senate

Tabled and Assigned From the Senate: The following Joint Order: (S. P. 180)

Whereas, the Legislature believes that quality social services should be fairly and equitably available to improve the well-being of Maine citizens; and Whereas, services in the areas of

alcoholism and drug abuse prevention, mental health, rehabilitation, mental retardation, senior citizens and priority social services often provide similar or overlapping benefits to individuals; and

Whereas, the organization of state government agencies and the state financial assistance for such community based services is uncoordinated; now, therefore, be it

Ordered, the House concurring, that the Legislative Council study the distribution of social service funds, including the organization of state agencies responsible for administration of such services, state financial assistance of such community based services, the organizational and functional interrelationships of community agencies receiving state financial assistance and such related matters as the Committee may deem appropriate and present its findings and recommendations, including any necessary legislation, to the next special or regular session of the Legislature; and be it further

Ordered, that the state departments and state agencies responsible for administration of such services are respectfully directed to cooperate with the Committee and to provide such technical and other assistance as the Committee deems necessary or desirable to carry out the purposes of this Order, including, but not limited to, personnel and staff as a part of their regular employment without additional appropriation; and be it further

Ordered, upon final passage, that copies of this Order be transmitted forthwith to state departments and agencies as notice of this directive

Came from the Senate read and passed as amended by Senate Amendment "A' (S-14)

In the House, the Order was read. Senate Amendment "A" (S-14) was read by the Clerk.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Mulkern.

Mr. MULKERN: Mr. Speaker, Ladies and Gentlemen of the House: The Senate Order that we have before us today deals with a possible study to be given to the special session of the legislature in order to coordinate all efforts in social service programs. There has been some overlapping and duplication in these areas, and this order is trying to do that.

However, my problem is that I am the sponsor of a bill that is going to be coming in later on-there are several cosponsors -L. D. 771, which provides for a

comprehensive plan to deal with all social service programs. I am wondering if this particular order might be a duplication of effort, so I am going to ask that someone table this order.

Thereupon, on motion of Mr. Rolde of York, tabled pending the adoption of Senate Amendment "A" in concurrence and specially assigned for Thursday, March 6.

In the House:

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rolde.

Mr. ROLDE: Mr. Speaker, I move that we recede and concur and would speak

briefly to my motion. The SPEAKER: The gentleman from York, Mr. Rolde, moves that the House recede and concur.

The gentleman may proceed. Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: I would draw your attention not only to item 3, but to the next 2 items, which are non-concurrent matters on orders that we passed here in the House. They came back to us with amendments from the Senate.

What the amendments do, they set up a form, this was the form that we used last year in authorizing studies, and it would authorize the Legislative Council to direct committees to perform these studies. In the case of the first two orders, there

is absolutely no change, because the Performance Audit Committee was directed to make these studies in the original orders. In the case of the third matter, the original order called for a subcommittee of the Natural Resources Committee. It was felt that this could then be referred to the entire committee, and then they could organize themselves as they saw fit. So on item 3. I would move that we recede and concur with the Senate.

Thereupon, on motion of Mr. Rolde of York, the House voted to recede and concur.

The Chair recognizes the gentleman from Livermore Falls, Mr. Lynch. Mr. LYNCH: Mr. Speaker, Ladies and

Gentlemen of the House: In answer to the question, the law simply says that no loaded firearm shall be brought onto

public school grounds nor discharged by any person within 500 feet of any public

school property. The SPEAKER: The Chair recognizes the gentleman from Farmington, Mr. Morton.

Mr. MORTON: Mr. Speaker, I will give you a little more detail on the question. May a qualified instructor give instructions on firearms and actually fire firearms in a school area that is properly constructed, a range or something of that nature

The SPEAKER: The gentleman from Farmington, Mr. Morton, has posed an additional question through the Chair to anyone who may care to answer.

The Chair recognizes the gentlewoman from Vassalboro, Mrs. Mitchell. Mrs. MITCHELL: Mr. Speaker and
