Mrs. BACHRACH: Mr. Speaker, Ladies and Gentlemen of the House: I won't take up much of your time because I know this is a holiday and you want to get out of here, but I have read one too many of these editorials that direct us to leave things as they are and wait until people complain. I would like to draw your attention to who this is we are expecting to save our political necks with a great outcry against cuts in budget — these people are the poor, the elderly, the children, the sick, the mentally ill and the retarded. These are the people who are supposed to blow the whistle on the Governor's budget. I submit

whistle on the Governor's budget. I submit that they are the least capable of defending themselves. They may fear to jeopardize what little they have by complaining, at least those who are capable of complaining.

I thought for a while that the towns might come to the rescue. I now realize that they can put off repairing a couple of roads and hope it won't snow much in December, and as for social services in the towns, there we're back to the same game

I am certain that the people of Maine are compassionate people, but are busy making their own livelihood. They rely on us, their elected representatives, to defend the interests of less fortunate people

among us.

I propose that we must take up the responsibility and not pass any budget with the idea that complaints from "out there" will take us off the hook. The people involved could suffer for a year or two at least. Who is going to speak for them if we don't?

There are two more points: If 200 people are fired from Mental Health and Corrections, they will collect unemployment and do no one any good. They might as well be working for the people who need their help. The money that it is not a second to the control of t that is paid in social security comes out of their pockets too, and we may go back to locking up the patients and keeping them quiet with tranquilizers if there is not enough staff to handle them in any other way. Do you think that these people will write you and make claims and complain?

Lastly, I find it an insult to my intelligence to be told that Mr. Rosser is close to being able to operate within the budget if he can front load it and undercut the last half year. What kind of Watergate double talk is this? We all know you can't get away with living on Documbar's get away with living on December's money in June — it certainly will catch up with you. Funds must be provided for needed services and the legislature must do the job itself. We are deluding ourselves if we think that the people out there will do it for us.

I hope you will really seriously think when you say that you will want to hear from the people out there and remember who it is that is going to be most hurt by cuts.
