Mr. PIERCE: Mr. Speaker and Members of the House: The House Amendment "B", a copy of which was on the desks of everyone this morning, merely establishes a few rules to limit this agency bill.

The first part of the amendment states that certain rules and regulations will be put in writing by the State Liquor Commission so that anyone wishing a copy

of these may have them. Secondly, the amendment says that the Bureau of Alcoholic Beverages shall give proper notice to any interested parties who

might want to obtain one of these agency stores and shall make proper notification and so forth.

Finally, it says that any applicant who is aggrieved by the decision has the right to appeal to the administrative court judge, and if they are still aggrieved may appear finally to the superior court judge. I feel all these are for the protection of the people of

the State of Maine in these towns that

might be interested in some of these

The SPEAKER: The Chair recognizes the gentleman from Wells, Mr. Mackel

Mr. MACKEL: Mr. Speaker, Ladies and Gentlemen of the House: I just have a question I would like to pose if I may relative to this amendment. Would the purpose of this amendment be to limit these stores to one per municipality? And secondly, if this is the case, would it be possible to include villages as well as the towns and cities and unorganized territories?

The SPEAKER: The gentleman from Wells, Mr. Mackel, poses a question through the Chair to any member who may care to answer.

Mr. PIERCE: Mr. Speaker and Members of the House: This amendment does not address the question of whether or not it would be one to a town. It was the assumption of the committee that of course there would only be one to a town.

Secondly, I would think that the wording of the bill, which says cities, towns and unorganized territories and so forth is broad enough to cover villages if the bureau deems it necessary and feasible that a store be located there.

#### (Off Record Remarks)

Mr. Carpenter of Houlton was granted unanimous cnosent to address the House.

Mr. CARPENTER: Mr. Speaker, Ladies and Gentlemen of the House: I rise this morning to speak on an issue that we are all probably tired of hearing about, but I feel that being as today is a rather special feel that being as today is a rather special day in my life and the lives of everybody living in this country, that we should give some thought to it. It is a very sad day for me, and I mean it very sincerely. When I turned on the news this morning and I heard last night that the Republic of South Vietnam had fallen, I had many mixed emotions.

I don't know if I am the only member of the 107th Legislature who had the honor and the privilege — and that is what I considered it — of serving in the Republic of South Vietnam, but I certainly am in a minority group in that regard. I look back on the days I spent there and I look back on all of the press and all of the remarks and all of the media that have been brought into our living rooms for the last decade, and I come away with a couple of questions. The first question, of course, is was it worth it? I had a number of good friends who lost their lives or were injured badly in Vietnam. It was just about four years ago this month when a very very dear friend of mine, he was a 1st lieutenant in the Infantry of the 101st Airborne Division, was killed, and I think about that every year about this time. As I said, he was a close friend. So I question whether it was worth it.

The second question I come away with, and this was probably bothering me more than anything else this morning, is what is going to become of all of the people who fought with us? The last six months I was in the Republic of South Vietnam, I was a liaison officer and I had a very close friend who had the unique experience, as many Vietnamese did of fighting on both sides. He fought for a while the North Vietnamese and then he fought for a while with us. If there was any way possible that I could have brought this young man to the United States, I would have at that time; I thought that much of him. He lived near the city of Hue which fell some time ago. He had a wife and two children. I wonder what happened to him this morning.

These are the things I think we should think about. I read in the paper this morning where the President of the United States, Mr. Ford, said let's close ranks. I agree with that wholeheartedly. There are members of this House who, when I was in college, were on the opposite side of the fence from me on this particular issue. I think we have closed ranks. I think the United States of America can learn a lot from this experience, 6,000 people dead, many, many more thousands wounded and ruined, but I think it should not be considered a total waste. I think we can learn a lot about outselves. So I guess I lot about the world and I think we can learn a lot about our ourselves. So I guess I would end by asking that all the members of this House stop sometime today and think about somebody that you know who served there, think about the whole war, the whole episode in general, and maybe tonight or later on today you can be just a little more humanitarian, just a little more friendly, just a little more peaceful, and maybe we can all hope and pray that something like this never happens again to the United States of America or to any other country.

Mr. Hughes of Auburn was granted unanimous consent to address the House.

Mr. HUGHES: Mr. Speaker and Members of the House: I hesitate to follow the eloquence of Mr. Carpenter, whose Army experience included service in Vietnam, and for that he has an experience which none of us who have not been there can share. I would want to add a couple of comments, however, because Mike and I and others in this group are members of a generation touched by this war like no other generation, a generation divided in its politics about the war, a generation whose members fought the war, and I think it is worthy of some reflection here today.

I would simply add to Mike's remarks a couple of paragraphs, that we have an unfinished task ahead of us as a nation, the task, one, to make welcome and happy the thousands of refugees we were able to evacuate, to help alleviate the suffering of thousands more still at home, still in Vietnam and to face the difficult task of living in a war-torn country under a new government. And finally, here in America, to bind the wounds of our own society, less vivid but no less real than those in the country of Vietnam.

I think, too, from an experience such as this, no matter how traumatic, a great nation like our own draws strength. We

nation like our own draws strength. We study this piece of our history looking for the lessons it holds. We draw strength from the courage of our young men who fought the war, never certain of its purpose and with divided feeling at home, but following the call of duty as they saw it.

We, all of us, know the names of these men, my own close friends, Tom, Buddy, Jerry, Mike's friend Tom, Pete's friends Allen, Ben, Lon's neighbor Buddy, we could go on and on, but we need not utter their names, for their deaths but more their lives are a part of our hearts, and as their names, for their deaths but more their lives are a part of our hearts, and as they touched our lives, they became part of our lives and we live on as living imperfect memorial to their sacrifice.

Mr. Speaker, I suggest that when the House adjourns, it adjourn in memoriam.

Mr. BIRT: Mr. Speaker, Ladies and Gentlemen of the House: Being of a generation that fought in a war that probably had a much different perception by the American people, I would commend both of the comments made this morning, and particularly the very high level that the Representative from Houlton, Mr. Carpenter, made in his remarks, having had the long experience very closely associated with all of the veterans of Vietnam, and I would commend him for his comments. his comments.

Mr. Farnham of Hampden was granted

unanimous consent to address the House.
Mr. FARNHAM: Mr. Speaker, Ladies and Gentlemen of the House: I think most of you who have served with me in the past know I am somewhat of a flag waver and proud of it. About two weeks ago, I left here on a Friday afternoon, my first absence from the House, took in the Freedom Train in Portland, three and a half hours of sore feet, went on to Concord, New Hampshire to a conference at which the President spoke, and then fulfilled a dream of longstanding, to go on to Concord, Massachusetts and at six o'clock in the morning I was at the Old North Bridge. Here the scenes were reenacted what occurred 200 years ago, the Minutemen, the Fight and Gun Corps, all the pageantry of today.

It has been my privilege to serve with the gentleman from Houlton for four months. We have been on State Government together, and I can tell you, as long as we have men like Mike Carpenter, we have Minutemen ready to

defend their country.
