The Communication was read. The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rolde.

Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: I move this communication be placed on file and I would speak to my motion.

A number of months ago, I stood here and issued some small words of praise for the first of our Joint Committees to report a bill to the floor. That committee, if any of you remember, was the Legal Affairs Committee. Today it is really no surprise that the first committee to report that it has finished its work is the Legal Affairs Committee. I should add that it is the first committee with a significant number of bills, because the temptation is great to give a pat on the back to the Public Lands Committee, which has also finished its work, especially seeing that I am the House Chairman of the Public Lands Committee, but also, being truthful, I have to admit that we only had five bills to handle. The Legal Affairs Committee had 122 bills, many of them extremely complex and controversial matters.

Therefore, I want to pay special tribute, on the record, to the members of this committee for the fantastic job they did, to the House members, the Chairman, Mr. Faucher of Solon; Mr. Cote of Lewiston; Mr. Dudley of Enfield; Mr. Carey of Waterville; Mr. Burns of North Anson; Mr. Joyce of Portland; Mr. Shute of Stockton Springs; Mr. Hunter of Benton;

Mr. Perkins of Blue Hill; Mr. Gould of Old Town; and in the unmentionable other body, the Senate Chairman, Mr. Corson of Somerset; Mr. Cianchette of Somerset;

Mr. Danton of York.

What I am reminded of is a sign that I once noted on an apartment complex along Storrow Drive in Boston. It says, "If you lived here you would be home now." Transposing that to this situation, I would like to say, if we were all on the Legal Affairs Committee, we would be home

now. (Applause)

Joint Resolution Memorializing the President and Congress of the United States to Aid and Assist Vietnamese

Refugees

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the One Hundred and Seventh Legislative Session assembled, most respectfully present and petition the President and Congress of the United States as follows:

WHEREAS, the Governor of this State, with whom We, your Memorialists concur, has offered to do all within the capacity of this State to assist in the resettlement of

Vietnamese refugees; and

WHEREAS, it is in the best, most noble and strongest tradition of the American people to provide succor and shelter to those who, for whatever reason, are forced to flee their homeland; now, therefore, be

RESOLVED: That We, your Memorialists, respectfully request that the United States Government live up to its most noble traditions by providing sufficient financial aid to resettle Vietnamese refugees in peace and dignity; and be it further

RESOLVED: That We, your Memorialists, request guidance as to how the State of Maine can best support the efforts of the United States Government in resettling Vietnamese refugees, knowing that our citizens will offer their time, their homes and other means, to assist these refugees in their time of need; and be it further

RESOLVED: That suitable copies of this resolution be prepared and transmitted forthwith by the Secretary of State to the Honorable Gerald R. Ford, President of the United States, to the President of the Senate and the Speaker of the House of Representatives of the United States. Congress and to each member of the Maine Congressional Delegation and to such organizations in this State as may be assembled to aid and assist in the resettlement of Vietnamese refugees.

(Off Record Remarks)

Mr. Jalbert of Lewiston was granted unanimous consent to address the House.

Mr. JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: My remarks, casting absolutely no aspersions on the House Chairman of the Education Committee nor any members of the Education Committee, however, for myself, and naturally I can only speak for myself, I have no titles, but I have a constituency in Lewiston and as far as I am concerned, I am serving notice for myself here and now that any continued flim-flamming by the Department of Education will not be looked upon too well by me, because I can well remember being somewhat laughed at by that department when I tried to kill 1994 for the very

purpose that it was not funded for the second year of the biennium.

I know certain communities that did go hog-wild independently from what we are in the budgetary programs, such as separate programs and school financing

I know that it is a matter of record and I have stated so in caucuses and at meetings, here in joint caucus and also during the session, that even after we adjourn, I kept pursuing my thinking into the then Chairman of the Committee on Appropriations and I think those of you who were on the Appropriations Committee then will well remember that I pounded away on this until we finally got another memo, another letter from Asa Gordon of the Department of Education telling us we need have no fear, we will be all right; there will be enough money to fund the second year of the biennium.

fund the second year of the blennium. I don't want to bother you, but I can get that letter very easily and read you that paragraph with his signature underneath it. And all at once, bam, 9.5 in hock for the first year, then 14.5, then 20 million and then Lord knows what, to a point that again — I think that about the worst thing that could have happened, as far as I am concerned is returning to my desk and concerned, is returning to my desk and seeing not one but two of these things

I wouldn't believe these printouts if you told me it was Friday. As far as I am concerned, the Department of Education in this State has lost all of its credibility with me and there will be some heads that will roll. If I were to have done, in my private work, what was done with this thing here, I would long be drawing Social Security. I want to serve notice now that as far as I am concerned, before I believe anybody, somebody is almost going to have to cut their finger and sign it in blood.

I am not going back to my people with another loser. If I have to stand here three days to keep pounding away, I shall do it.

I think the membership of this House has been insulted, has been trampled upon, has been ridiculed. The members of the Education Committee have been put in a position where they wouldn't even know themselves where to turn, and I particularly must put some emphasis on the Chairman, because the chairman is the chairman and if it is good, he should take the credit for it; if it is bad, he has got to assume the responsibility to a degree. I know the sincerity and I know the hours and days and evenings that our Chairman of the Education Committee has put in on this.

I also know this, and this is unbelievable, even after the Superior Court motioned him down last week, one of the amendments that was drafted through the Department of Education still had the forgiveness clause in it.

On that basis, Mr. Chairman, I am sorry to take the time, but I think it is important, I want it clearly understood that now I really am from Missouri.

Mr. Susi of Pittsfield was granted

unanimous consent to address the House.

Mr. SUSI: Mr. Speaker, Ladies and Gentlemen of the House: I think there have some quite serious charges made here and I, like the gentleman who has just spoken to you, have been involved in this whole process and I feel that I have been a witness too. I feel right now that the inference has been made that we are suffering a deficit in our budget right now due to some conspiracy on the part of the Education Department, and having been closely acquainted with all of the

developments in this situation, I see no

basis to believe that at all.

We knew, when we went into this action that we have taken on the financing of education, that we were taking a major step. We knew that we were using temporary financing when we put this bill into effect. We knew that come this session we were going to need substantial amounts of money. We knew that involved in this whole process, there was a major shift in the cost of government from the property tax to a broader base tax. We knew as a practical thing that it would mean the income tax. I believe that we have a large percentage of this legislature that stands ready today to support an income tax.

There has been a new element added, a

person who campaigned pledging no increase in a major tax which has upset this timetable, but it has nothing to do with misrepresentation on the part of the Education Department, I feel that they are people of honor and I stand here today to defend them, I feel that the attack was

unwarranted

Mr. Lynch of Livermore Falls was granted unanimous consent to address the House.

Mr. LYNCH: Mr. Speaker, Ladies and Gentlemen of the House: The gentleman from Lewiston is correct in some respects. Two years ago, there were some obvious failures to close two doors. It wasn't recognized that they were unlocked but it didn't take the school superintendents very long throughout the State to find that they had access to what they thought was 100 percent funding of school construction and busing and they sold their communities on that basis.

I think the gentleman from Lewiston and many people in this House are going to get complaints from another direction, not on the overspending, but the mability of school communities to be able to spend the money that they would like to spend. We have spent a great deal of time closing doors and locking doors and we are continuing to monitor two areas of Special Education and Vocational Education. We are monitoring the school construction

costs.

The gentleman from Waterville, Mr. Carey, had a bill in, we have been working with BPI, and the Department of Education and many communities going in for construction of school units are going to find that they can't do with State dollars what has been done in the past. I am quite sure that, as far as it is humanly possible, we have closed and locked the doors to reckless spending.

Mr. Jalbert of Lewiston was granted unanimous consent to address the House.
Mr. JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: Over the years, I have enjoyed nothing but pleasant relations with the gentleman from Pittsfield, Mr. Susi, mostly opposing one another. I think if he went along with me, the shock would kill me. I want this clearly the shock would kill me. I want this clearly understood. I did not make the comment and did not use the word conspiracy, but let me put it this way here, when I was sent a memo, and I will read it to him, I don't have it here, even in October of 1963, five months after we had adjourned, signed by Asa Gordon, assuring me that we had enough money to fund the second year of 1994, that was not a conspiracy, that was not telling the truth. I am saying it quite

As far as I am concerned, the gentleman

from Pittsfield, Mr. Susi, has got a long, long, road to hoe before he can make me swallow any of these baubles (holding up papers). All I am doing, and I have a right to say it, one member of this House was attacked by the Mayor of the City of Auburn, who I think bought enough buses out of the \$2 million extra they got to practically lug every school student in the school. They went crazy spending that money.

I am just merely stating my position and I am doing it very mildly, as usual. Nobody is going to sell me a bill of goods until I am positive that the situation is right for my

community.
Now, the gentleman from Pittsfield, Mr. Susi, has a plug just like I have, he can vote as usual, opposite me, and we will all be happy.
