Mrs. POST: Mr. Speaker, Ladies and Gentlemen of the House: Ralph Cline, who died on Monday at the age of 81, will most likely be remembered by history as the man portrayed by Andrew Wyeth in his famous painting of the Patriot. However, his neighbors in Knox County and his friends around the state will remember him as much more.

Some will remember the man who loved, respected and worked with his wife Marion, his family, his community, his land and his country, one who was a true patriot long before the painting was done, a conservationist who planting was done, a conservationist who planted a tree for each one he cut for his saw mill. Others will remember the man who had an excellent sense of humor and often used it to convey his philosophy of life. Reportedly when he was asked by one of the traveling

journalists, who often came to talk to Ralph, whether he had in fact worked all his life, Ralph answered, "Not yet." But he did intend to and he did, and many will remember him for that, a fiercely independent, self-reliant businessman who took pride in his product and his ability, even into his seventies, to turn out that product.

I grew up with two memories of Ralph Cline: one was watching him march at the head of countless parades — 4th of July, the Seafood Festival. The other is more personal and I think expresses the essence of the man. Ralph was ill in bed when a lifelong friend and comrade died on Christmas Eve. He and his wife wanted to send flowers to the widow, but rather than trust them to an impersonal delivery boy, he got out of his sick bed to take them to her himself. Two days later, he performed the final act of love for a fallen comrade, that of folding the flag which covered his coffin and presenting it to his widow. His pride, loyalty, love, and his deep compassion were expressed so eloquently in that act. I shall never forget it, and that is how I, and I think everyone who attended that service, shall remember Ralph Cline.
