Dear Governor Longley: Pursuant to the request of Legislative Leadership to review and report its best

analysis of the current financial status of the State, the Joint Standing Committee on Appropriations and Financial Affairs has submitted its report dated January 29, 1976. We enclose a copy of that report herewith.

We are sure you will agree that the condition of the biennial budget as reported by the Committee, particularly with respect to the actual and projected revenue receipts, gives rise to serious concern. If the analysis of the Committee is to be accepted as an indication of our financial condition, we must recognize the existence of a potential financial problem for the State of Maine of considerable magnitude.

The Legislative Leadership and the entire membership of the Legislature stand ready to receive recommendations from you and to cooperate with you in finding solutions to the problem we face. We respectfully make this formal request for your comments and reaction with respect to the report of the Appropriations Committee and the financial condition it reflects.

At this point, the Speaker recognized the presence of Mr. Churchill of Orland who was recorded absent on the organizational roll call, and the rolls will be corrected accordingly.

Mr. McBreairty of Perham was granted unanimous consent to address the House.

Mr. McBREAIRTY: Mr. Speaker, Ladies and Gentlemen of the House: During our debate Friday on the moose bill, I thought Mr. McKernan did a great job explaining Joint Rule 28, which plainly states that no measure which has been introduced and finally rejected in the regular session shall be introduced at any special session of the same legislature, except by vote of two thirds of both houses. I also thought Jock's statement to the press stating that the moose bill would mean at least three day's debate at a cost approaching \$45,000 to the taxpayers was very true and correct.

I guess it wouldn't be very hard to convince me that the moose bill is not really an emergency. With the facts I have just mentioned, no doubt true, it disturbs me very much that the Natural Resources Committee has been pressured to report out probably the most emotional controversial bill facing 48 of the 50 states today, a bill which is still very controversial after several amendments and several years trial in Vermont and Oregon, a bill which could add ten days at a cost of \$150,000 to this special session, a bill which has already been turned down several times by the Maine Legislature. I guess by now you know I am talking about the bottle bill.

People back home have been led to believe the reason we are holding a special session is to act on emergencies only. The definition of an emergency is an unforeseen combination of circumstances, or the resulting state that calls for immediate action. I don't believe the moose bill or the bottle bill fit the definition of emergency. Politically it might be good for some of us to have the chance to vote for or against the moose bill. Politically it might be good for some of us to have the chance to vote for or against the bottle! ill. I am sure the best thing politically for all of us would be to throw all the bills that don't fit the definition of an emergency in the waste basket, take care of the few serious matters we have before us as quickly as

possible and go home. I think Joint Rule 28 is a very good rule if it applied to all bills fairly. If Joint Rule 28 is not applied honestly and fairly, we have

At this point, a roll call was ordered by the Speaker to determine whether or not a quorum was present. A sufficient number answered to their names and accordingly a quorum was found to be present.
