Mr. MERRILL: Mr. President and Members of the Senate: There is some disagreement. This bill does two things; it affects the color of lights that fire inspectors, specifically state fire inspectors, and it attempts to regulate the use of lights on vehicles of constables. The sponsor of this bill in the House put it in at the request of the Department. There hasn't been able to be worked out any sort of compromise between all the people who are worried about what color lights they are going to have, and that is the reason it has been on the table. The final decision of the sponsor was that she just wants the thing indefinitely postmend thing indefinitely postponed. The PRESIDENT: The Chair recognizes

the Senator from Aroostook, Senator Cyr. Mr. CYR: Mr. President and Members

of the Senate: This bill was heard before the Committee on Transportation, and I think it was the attempt of the Committee on Transportation to divide the various types of light into the groups where they belong. In other words, for all fire trucks and vehicles related to fire it was the attempt of the Committee on Transportation to divide the various types of light into the groups where they belong. In other words, for all fire trucks and vehicles related to fire it would be red, for police protection it would be blue, and for just a warning signal it would be orange. So this bill received a pretty good report, if not a unanimous report — I forget just what the report was in regards to this.

Now, this bill right here mentions "and also constables" that would be covered under the blue light. And the amendment would add, "constable in uniform", because as it is now, a constable, if we pass it just as it is, without the amendment to it, it would mean that a constable off work without uniform could stop anyone and

•

direct traffic or do any of those duties.

We usually associate the blue light with the state police, for instance, and anyone that sees a blue light will respect that and stop. Now usually, in fact at all times if it is the state police, the state police will be in uniform, and as such you will respect that blue light. But if a constable is allowed to put a blue light on his car, he can possibly stop at a scene of an accident and have his blue light on and yet not be in uniform, and a lot of people may approach very cautiously, and if they notice that there is no uniform on this individual they may not stop, and for good reason, because anybody can put a blue light on his car and imitate a police a one right on his car and imitate a police officer and possibly have some other reason for stopping the traffic. So this is why the bill was amended to read, "a constable in uniform", and as such. I think it is a good bill, and I think the motion that is before us to indefinitely notione should is before us to indefinitely postpone should be defeated.

The PRESIDENT: The Chair recognizes the Senator from Hancock, Senator McNally

Mr. McNALLY: Mr. President, would it be proper for me to ask how this bill came out of committee? I have been trying to find it.

the Senator from Hancock, Senator McNally.

Mr. McNALLY: Mr. President, I am very sorry but I haven't had a chance to read over this bill, and I wonder if it would

be in order to ask somebody to explain it. The PRESIDENT: The Senator from Hancock, Senator McNally, poses a question through the Chair which any Senator may answer if he so desires.

The Chair recognizes the Senator from

Kennebec, Senator Katz. Mr. KATZ: Mr. President and Members of the Senate: This bill surfaced yesterday and, if you recall, I asked for your faith and confidence to permit us to get the bill up to this point with a brief explanation. It is now in front of you as L. D. 1205. It is an interim measure which expresses the deep concern of the leadership of both houses and the Executive Department with respect to a gaping hole in the ability of communities to buy buses based completely upon their own determination for which we then become partially responsible for funding. I say this is an interim measure because

if all goes well on next Wednesday we might very well have the major legislation on school financing in front of us which will address itself to the question of busing. Thank heavens, busing in the State of Maine just means money; it doesn't mean all the other problems that it does around

the United States: What this does, in effect, is to indicate that the Commissioner of Education must give approval for acquisition of new buses or contracts on leases for buses. It is intended as a temporary measure to protect us from a last minute rush to buy buses prior to our new legislation which is buses prior to our new legislation which is

getting out. The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Speers.

Mr. SPEERS: Mr. President and Members of the Senate: I certainly concur with the remarks made by the good Senator from Kennebec, Senator Katz, in that this legislation before us today does represent a plugging of a loophole that was a matter of very great concern by the executive branch of the state government and as discussed fully with the legislative leadership of both branches of the legislature. We did feel that it would be appropriate to make sure that this appropriate to make sure that this loophole is plugged until such time as we can come forward with a comprehensive proposal regarding the school financing situation in the State of Maine. I would very urgently urge that this be passed

today. The PRESIDENT: The pending question before the Senate is the enactment of L. D. 1205, An Act Concerning the Purchase of School Buses. Will all those in favor of the passage of this bill to be enacted please rise and stand in their places until counted. Those opposed will now rise and stand in their places until counted.

Thereupon, this being an emergency measure and having received the affirmative vote of 31 members of the Senate, the Bill was Passed to be Enacted and, having been signed by the President, was by the Secretary presented to the Governor for his approval.
