The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator

Reeves.

Mr. REEVES: Mr. President and Members of the Senate: In regard to this bill, which would take some one million dollars from general revenues in addition to the income from a special tax to pay for spruce budworm spraying, I have received several requests from constituents to find out how much money has been spent by the paper companies and their lobbyists in promoting this measure. In fact, it is my opinion that this has been one of the heaviest lobbied bills at this session. And although this lobbying activity may have no effect on the outcome of the action we take here in this Senate, I think it is only fair to the general public that we ask how

I asked this question at the public hearing on this bill, and again recently in a letter to the paper company's office. I was told a full disclosure of this lobbying activity would be forthcoming. It is my hope that this information would be made public before we take any final action on

this proposal.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ: Mr. President and Members of the Senate: As I recall, I was the sponsor of the lobby disclosure bill that was enacted by the last session of the legislature, and the legislature at that time said it was public policy that there is nothing wrong with lobbying. The legislature made no move to do away with lobbying or to make it illegal. It is part of the scene. What we did say was that we want disclosure to know how much money was being spent, and the bill as it exists in the book does require disclosure by the employer, not the lobbyist but the employer, after the session is over.

I have never known of any specific bill to be over-lobbyed or expensively lobbyed by the people who are up here all the time. The real problem is in the one-shot deal where people come in en masse from out of state to convince the State of Maine that we must take a position on a subject on a

one-shot basis.

I have seen no evidence that the spruce budworm has been lobbyed very, very heavily at all. As a matter of fact, I have been surprised that my relationship with the lobby on this question has been almost while my motor was running as I have walked down the corridor. I have seen no

evidence of an impropriety, and I think that when the Senate does decide on this bill it will be decided on the merits of the bill as we see it, rather than any nefarious interference from outside.

The PRESIDENT: The Chair recognizes the Senator from Hancock, Senator

McNally.

Mr. McNALLY: Mr. President and Members of the Senate: I would like to express another reason for why I would like to have this bill tabled at least for one

day.
We have people who own more than 500
Chairmas trees on acres of land that have Christmas trees on them, especially in Hancock County, and they will need to spray. Now, we have one person in particular who has already bought the herbicide, as he has permission to use it, and the cost to him to date is to use it, and the cost to film to date is \$1300. Should he have to spray himself, which he does and is going to, and then pay the tax which this bill assesses, without some sort of an amendment put on it so that he could be allowed at least the cost of the herbicide against his tax, it seems wrong in itself because this isn't taking anything from the money that is used to spray the budworm that the bill is put in for, but this is asking the man to pay for his own herbicide to spray his trees and then turn around and tax himself for spraying acreage somewhere else in the State of Maine.

I wish it could be tabled for at least one day so that I could offer an amendment that would assist the Christmas tree people that are spraying on their own

It went through the Senate and over into the House, and they came back with a House Amendment which further clarified the committee amendment. In fact, they rewrote the whole bill, but they omitted one part which protected the animals relative to activities in school, and that is why I want to present another amendment to the House

Amendment, to clarify that position.

The PRESIDENT: The pending motion before the Senate is the motion by the Senator from York, Senator Hichens, that the Senate indefinitely postpone Committee Amendment "A". Is this the pleasure of the Senate?
