The PRESIDENT: Is it now the pleasure of the Senate that this Joint Order be passed in concurrence?

The Chair recognizes the Senator from Penobscot, Senator Curtis.

Mr. CURTIS: Mr. President, it seems to me at this particular time it would be appropriate to bring the Senate's attention to several items which appeared last week in the Bangor Daily News. The first one is a letter to the editor, entitled "True

Bravery". "To The Editor: "The parents and family of Cynthia Ann (Fowle) Calkins want to express publicly our gratitude to Harold (Hal) Goss of Brewer, the young man who saved Cindy's life on Monday. Such bravery as he showed when he jumped into icy waters and swam to our car where Cindy was trapped is far beyond the ordinary person's capability to even comprehend. We will love him forever for being the type of person he is, for risking his own life to save a stranger —our daughter."

The second item is an editorial of the same day from the Bangor Daily News, entitled "True Bravery".

"Harold Goss is the Brewer man to whom Cynthia Calkins owes her life.

"By now, practically all have heard about Goss's selfless act of heroism — jumping into the floodwater of the Kenduskeag Stream in downtown Bangor to free a total stranger trapped in her submerged car.

"It is a source of neverending joy to know that we are incapable of expressing the loving gratitude felt for this man by the Calkins woman and those close to her.

"Coming closest to it, however, are the words written in today's letters to the editor column.

In an age, I think, when we hear so much of the disinterestedness of observers of people in trouble, it is most comforting to know that the characteristics of bravery. courage, and concern for the danger of our fellow men are traits that still exist in this country and are epitomized by Harold Goss of Brewer. I move passage of the order.

Mr. Hichens of York was granted unanimous consent to address the Senate: Mr. HICHENS: Mr. President, in relation to this bill which we have just enacted, I would like to share a few words with the Senate.

Mr. President and Members of the Senate: This bill today is sort of special significance to me, because as a teenager growing up in the State of Massachusetts, I once made the statement that I wouldn't trade one inch of Massachusetts for the whole State of Maine. Since that time I have eaten those words a great many times, but a few years ago as I traveled from the outermost part of our state back home, I was suddenly struck with an inspiration and pulled over to the side of the road and I penned the words I would like to share with you today. Part of Me.

I've crossed the width and breadth of Maine

From lakes to ocean shore And from its highest mountain peaks Have scanned the landscapes oe'r. I've walked beneath its towering pines Mids't blossoms in the field And seen the mighty breakers roar Gainst cliffs that would not yield. I've seen its snows in winter time, The swollen streams in spring: Smelled new cut hay in summer months, Seen Autumn's birds on wing. I've seen Maine's oak and maple leaves Turn color in the fall. Emblazened glory wrought by God, Free to the eyes of all. I've seen the fish jump in the lakes

And watched the white-tailed deer Leapthrough the forest's glade with grace,

Unmindful I was near. I've seen the great potato fields Stretched out beyond my view,

Looked at burnt over berry lands Soon to break forth anew.

I've seen its people, strong and brave, Ambitious, tried and true,

Fishermen, farmers, woodsmen

Other professions too

And thinking of all other lands

Where I by chance could be. I'm mighty glad I'm part of Maine

And Maine is part of me.
