Examination of the initiative petitions relating to "An Act to Repeal the State Property Tax" filed with this office on January

19, 1977 has been completed.

The minimum number of valid signatures required to initiate this legislation has been determined to be 36,395. Our examination of these petitions reveals the following:

Number of petitions received 486 Number of valid signatures 46,583

In view of the foregoing determination of the number of valid signatures, it would appear that these petitions have met the constitutional requirements of the minimum of 36,395 valid signatures.

An Act to Establish the Maine Tort Claims

Act (S. P. 86) (L. D. 162)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure and a two-thirds vote of all the members elected to the House necessary, a total was taken. 141 having voted in favor of same and one against, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.
