Reports were read. The SPEAKER: The Chair recognizes the gentleman from West Gardiner, Mr. Dow.

Mr. DOW: Mr. Speaker, I move that we ac-cept the Minority "Ought Not to Pass" Report and would speak for a few minutes on my motion.

The SPEAKER: The gentleman from West Gardiner, Mr. Dow, moves that the House ac-cept the Minority "Ought Not to Pass" Report.

The gentleman may proceed. Mr. DOW: Mr. Speaker, Ladies and Gentlemen of the House: As this bill has been amended, it will increase the hunting for residents only for Saturday in the northern zone and Saturday in the southern zone.

It looks like I am voting against motherhood or anything else of that nature, so I would like to give you a couple of reasons why I have signed the "ought not to pass." Statisticwise, more deer have been killed or harvested on Saturdays and holidays and I am very afraid that if we open up two more Saturdays, with the commissioner's right to close the season at any time, we in fact might lose more days on the end of the season, instead of gaining we are going to be losing. This is an industry that brings in a lot of

money to the state, and to close especially the northern part of the state where there are a lot of camps, etc., we will be losing a lot of money to the state industry, which is hunting and fishing. For safety reasons too, because the department usually sets the season to start on Monday for the harvesting of deer for the safety aspect, if we have two more Saturdays in there. we will have more people in the woods and more chance for accidents.

The SPEAKER: The Chair recognizes the gentleman from Orland, Mr. Churchill.

Mr. CHURCHILL: Mr. Speaker, Ladies and Gentlemen of the House: I want to go on record as opposing the indefinite postponement by my good friend Mr. Dow from West Gardiner for the simple reason that I feel that the taxpayers of the State of Maine pay taxes on this woodland and property throughout the state, the abandoned farms, and I feel it is only fair that they have the first whack at the deer herd.

As far as putting more hunters into the state, we have other bills coming up that will increase the pressure on the deer herd much-more than this will.

This is a good bill and a lot of people would like to see a hunting season for residents only. My own preference would be the last for the residents, but I very much favor this and everyone I have talked with is in favor of a resi-

dent deer season, at least for one week. The SPEAKER: The Chair recognizes the gentleman from Limerick, Mr. Carroll.

Mr. CARROLL: Mr. Speaker, Ladies and Gentlemen of the House: When my colleague, Mr. Dow, said to speak against this bill he was speaking against motherhood, he was a hundred percent right, he just spoke against motherhood, because fatherhood is part of motherhood, you know that as well as I do, and the fathers go out into the forests, and some of the mothers, to hunt. But what disturbs me a great deal, my legislation asked for five days, and the committee, in their wisdom, asked me if I would settle for one apple instead of a bushel, so I said all right, I will accept this amendment. In good faith I accepted it and in good faith they gave it a majority "ought to paspass'' report.

I want you all to know here today that the people of the State of Maine have an inherited right to first choice in the State of Maine and first preference in the State of Maine, that the man with the dollar bill doesn't always buy the Maine product. So we should, in all sincerity and fairness to our citizens of the State of Maine, give to our citizens the first preference,

and that is one day in the southern zone and another day in the northern zone, which are Saturdays, to go deer hunting. I think this is only right, it is only proper. I am willing to set-tle for this but I am not going to settle for anything less.

I can assure you, if they want to readvertise this bill, I will fill that civic center with Maine residents who want first whack at the deer

When they speak of giving them the last five days, which was suggested to me at the committee hearing, I pointed out to them that when I invite a friend to a banquet, I don't serve him the crumbs that are left over from a feast, I like to allow him to sit down to a table that is laden with a bountiful harvest, and that is what we have in the first days of deer hunting.

I have great concern about the way this department is being run, but I will be compassionate to this department today and in return for my compassion I ask for your vote. I think every man in here who represents the people of the State of Maine should give the people of the State of Maine just this little morsel that I am asking for, and it is not asking for much. I should have gone down fighting for five days, but I will settle for the first Saturday in the southern zone and the first Saturday in the northern zone. I urge you all not to accept the minority "ought not to pass" report and then we will go on and accept the majority "ought to pass" report.

The SPEAKER: The Chair recognizes the gentleman from Limestone, Mr. McKean.

Mr. McKEAN: Mr. Speaker, Ladies and Gentlemen of the House: I signed the majority report on this bill and I use this rationale feel I should support what I signed.

The safety problem was brought up, but traditionally, we in the State of Maine are safety minded, and since we, the people of the State of Maine, will be the only ones hunting deer on that particular Saturday, I feel that the

deer on that particular saturday, i test that the safety doesn't pose a problem to us. Another thing, we in the State of Maine are not a real rich community, therefore, we find that we have to work five days a week. We find when Monday comes along, if we can get off work, we have to compete with the people out of state hunting on the same day. Therefore, I felt that we the people, the taxpayers, owe ourselves and the other people in this state something of benefit and I felt that this was a benefit to our citizens. I wish you would support the "ought to pass" report.

The SPEAKER: The Chair recognizes the

gentleman from Unity, Mr. Tozier. Mr. TOZIER: Mr. Speaker, Ladies and Gentlemen of the House: I voted "ought not to Waldo County, the heart of the hunting area in the State of Maine.

Where I come from, 80 percent of the hard core Maine hunters hunt for three or four weeks ahead of time anyway and the other 20 percent hunt from the 4th of July on, so they do not need this bill. I would like to move indefinite postponement of this bill and all its accompanying papers.

papers. The SPEAKER: The Chair recognizes the gentleman from Milo, Mr. Masterman. Mr. MASTERMAN: Mr. Speaker, Ladies and Gentlemen of the House: I feel like Mr. McKean does, that I should rise as I did sign the "ought not to pass" and I think I should explain why

why. When I first saw this bill I was quite excited When I first saw this bill I was quite excited and I thought, great, I would love, as a Maine citizen, to have an extra week of hunting. But then as I listened to the debate that went on in the testimony, it dawned on me that this was unfair. The out-of-stater pays so much for licenses — it happens to be \$60.50; we pay a fee to do the same thing, to hunt for a certain number of days which is set up by the Fisheries

and Wildlife Department, what they think is a reasonable and safe time to hunt and not deplete the herd to any damage and extent. For this reason, I think it ought not to pass because I see it as very discriminatory, and most of you all recognize now that I am against discrimina-

tion in any form. The SPEAKER: The Chair recognizes the gentleman from Lincoln, Mr. MacEachern. Mr. MacEACHERN: Mr. Speaker, Ladies

and Gentlemen of the House I urge you not to vote for the postponement of this bill. We have a beautiful recreational state, I would like to enjoy it and I am sure that everyone else does, but we have nothing sacred to the resident in Maine at this time. This is one little thing that we could do for our own people that would be sacred to them. I feel that we should vote against this motion and go along and pass the majority report and give our own people something. It is only one day; it is not going to deplete the herd by any great amount. I feel that we should give our Maine people something

The SPEAKER: The Chair recognizes the gentleman from Calais, Mr. Gillis. Mr. GILLIS: Mr. Speaker, Ladies and Gentlemen of the House: I signed the minority report for the following reasons: The greatest influx of non-resident hunters into the State of Maine for deer hunting is during the first week of hunting and Thanksgiving week, and Thanksgiving week is primarily for the native sons coming home to spend the holidays with Ma and Pa and Grandfather and Grandmother. etc

If this majority report is accepted, it will kill off the bulk of non-resident hunting licenses, primarily due to the \$60 non-resident license fee plus the shortened season, and this is only going to drive the non-resident hunters into other states for deer hunting.

I believe it was estimated that approximately 70 people attended the public hearing. Out of that 70 people, only two or three were in favor of this bill.

Acceptance of the majority report will create a hardship on the hunting campowners, the guides, the local independent grocery stores, the Ma and Pa type stores, plus an effect on the general economy and a loss of revenue will cer-tainly be brought about for the Inland Fisheries and Game Department, a loss which they cannot afford. Acceptance of the majority report, coupled with last year's increase to \$60 for a non-resident hunting license, will drive the outof-state hunters to other states and the State of Maine cannot afford this loss.

I ask your support in defeating the majority report.

The SPEAKER: The Chair recognizes the gentleman from Orland, Mr. Churchill.

Mr. CHURCHILL: Mr. Speaker, Ladies and Gentlemen of the House: I am not here to represent the sport organizations, I am not here to represent the sporting campowners throughout the state, I am here to represent the native residents of our state. I certainly hope that you will show compassion for your own residents of this state and the landowners of this state to vote for the majority "ought to pas-s" report and also, if we cannot give them five days, let's give them that Saturday before hunting season. At least give them that to show that we are thinking of them. Never mind the out-of-staters. Myself, I don't care if they never come into the state and I think the majority of the people feel the same way.

Please don't vote to indefinitely postpone this bill. Let's accept the majority "ought to pass" and attach the amendment for one day to this bill

The SPEAKER: The Chair recognizes the gentleman from Eastport, Mr. Mills.

Mr. MILLS: Mr. Speaker, Ladies and

Gentlemen of the House: As you heard the testimony here today, you have heard various ideas expressed pro and con on this bill. There were the same arguments back and forth in committee but, nevertheless, this has been a growing swell across the State of Maine for the past six years to my knowledge, that they want something done for their own local citizens who maintain the taxes the year round to carry the load in general.

If we were to pass this out on an indefinite postponement, we are doing our own citizens a great disservice. There is no question about it, the facts prove it. I would move that you defeat the motion of indefinite postponement.

The SPEAKER: The Chair recognizes the gentleman from Franklin, Mr. Conners.

Mr. CONNERS: Mr. Speaker, Ladies and Gentlemen of the House: I am one of those sporting campowners and I see no reason why we should not have the residents of the State of Maine be able to hunt for the Saturday preceding the open season. I do not see where it is going to interfere in my operation of my camps for three weeks. I hope you defeat the

The SPEAKER: The Chair recognizes the gentleman from Unity, Mr. Tozier.

Mr. TOZIER: Mr. Speaker, Ladies and Gentlemen of the House: If you pass this bill today to open the hunting for one day before the rest of the hunting season opens, you will be killing an extra estimated 3,500 deer. The SPEAKER: The Chair recognizes the

The SPEAKER: The Chan recognizes the gentleman from Waterville, Mr. Boudreau. Mr. BOUDREAU: Mr. Speaker, Ladies and Gentlemen of the House: In response to the gentleman who said that the hard core Maine hunter hunts for three weeks before the season opens anyway, there have been allegations that some of these hard core hunters have many deers hung up when the out-of-staters come into the state and if the out-of-staters do not get a deer, they can always buy one.

I will tell you an instance where I saw an outof-stater with a deer. I don't know much about deer, but this deer looked to me like he had been dead for about three weeks. I said, "when did you shoot that deer?" The guy said, "I shot it this morning." There was no blood dripping out of the deer, the deer was ice cold. I don't know where he got it, but I think this law would help in stopping poachers from selling deer to out-ofstaters

The SPEAKER: The Chair recognizes the gentleman from Corinth, Mr. Strout.

Mr. STROUT: Mr. Speaker, Ladies and Gentlemen of the House: When this bill originally came out to allow five days, natives only, I was opposed to this provision. Having spent some time in the last two or three weeks talking with business people that are in this type of operation across the State of Maine, they see no real hardship to allow the Saturday before hunting season to natives only. If you were to grant a five-day season. I think this could create some hardships. But where the committee saw fit to amend this bill to allow one day only in the northern and southern zones, I think it is imperative on us, as members of this House, that we allow the natives of the State of Maine to have one day to hunt before the out-of-state residents come in here and take us over.

Mr. Carroll of Limerick requested a roll call. The SPEAKER: For the Chair to order a roll call, it must have the expressed desire of one fifth of the members present and voting. Those in favor will vote yes; those opposed will vote

A vote of the House was taken, and more than one fifth of the members present having expres-sed a desire for a roll call, a roll call was ordered

The SPEAKER: The pending question before

the House is on the motion of the gentleman from Unity, Mr. Tozier, that this Bill and all its accompanying papers be indefinitely post-poned. Those in favor will vote yes; those opposed will vote no.

D. 160 deals with the annexation of the Town of Otisfield, the process by which it would be annexed into the County of Oxford. Many of us of the Cumberland County Delegation have some serious reservations, along with local selectmen and city councilors and commissioners, about the bill in its original form, which separates any financial obligation to the county. This amendment removes that section to the financial obligation and does put in some wording so that the commissioners of Cumberland County and the selectmen of the Town of Otisfield, upon the effective date of this act, could sit down and talk about the bonded indebtedness which was incurred while that town was a member of Cumberland County.

I would urge the support of this amendment and the Bill, L. D. 160.

The SPEAKER: The Chair recognizes the

gentlewoman from Bridgton, Mrs. Tarr.

Mrs. TARR: Mr. Speaker, Men and Women of the House: Of course you know that this amendment deals with the civic center. I am getting so I hate to even mention that name in conjunction with Otisfield, but this does deal with that. My first reaction, of course, was to strongly oppose this amendment. I guess I would rather fight than switch.

I have been in close contact with the selectmen of Otisfield, I have kept them aware of what was happening, and they have advised me to let this amendment go, so I will not op-pose this amendment, and good luck and let Otisfield go to Oxford County.

Mr. PEARSON: Mr. Speaker, Ladies and Gentlemen of the House: This amendment deals with a very small section of the Errors and Inconsistencies Bill, and it deals with the scholarships for North American Indians, and there has been some concern expressed on the reservation in Old Town by the Governor of the reservation and his council as to whether this amendment is proper at this time, this change, I should say, in the Errors and Inconsistencies.

There will be another chance later on in the session for another errors and inconsistencies bill, and if we could have time to look this item over, we were not aware of it until yesterday afternoon, we could deal with it later when the tribe has had a chance to consider the measure.

The SPEAKER: Under Rule 55, the Chair recognizes the Representative of the Penobscot

Tribe, Mr. Goslin. Mr. GOSLIN: Mr. Speaker, Ladies and Gentlemen of the House: I am Ernest Goslin, the Penobscot Indian Representative. At a meeting load signal of the G meeting last night of the Governor and Council of the Penobscot Indian Tribe, they voted to reject any word changes in considering our laws. The thing is that we have in our private and special laws that any word changes, any legislation dealing with the Penobscot Indian Reservation has first got to come to the Indian Representative and to the Governor and Council, which in this case has not been done.

I just want to say again that we cannot accept this, we will not accept it, and we wish that you would strike it from the record.

The SPEAKER: The Chair recognizes the gentleman from Standish, Mr. Spencer.

Mr. SPENCER: Mr. Speaker and Members of the House: On behalf of the Judiciary Commit-tee, I would like to apologize to the Indian Representative. The change here was not a change of substance, but in the future we will be sure that any changes, whether substantive or not, are first cleared with the Indian Representative and the Council.
