The SPEAKER: The Chair recognizes the gentleman from Standish, Mr. Spencer.

Mr. SPENCER: Mr. Speaker and Members of the House: The Committee on Judiciary felt that it was appropriate for certain comments to be made in conjunction with the withdrawal of L. D. 52, An Act to Define the Moment of Death.

We were concerned that any negative action

taken by the legislature might be construed as a prohibition in the State of Maine of the utilization of the brain death criterion for the pronouncement of death. The committee was concerned that without some recorded statement, such a negative implication might arise. Therefore, I, as House Chairman of the Judiciary Committee, advise the legislature of the reason for the committee's action.

The committee conducted an extensive hearing on this legislative proposal. We heard testimony from Counsel to the Maine Medical Association and the Maine Hospital Association, physicians engaged in the utilization of brain death as a means of determining death for purposes of organ transplantation, members of the clergy, representatives of the Maine Right to Life Committee and other members of the public. All of the witnesses who appeared before the committee agreed that the concept of brain death is necessary. All of them recognized that the concept has been utilized for several years in the State of Maine as a valid and legal means of determining death in certain circumstances.

As indicated at the hearing, a determination of death on the basis of total and irreversible cessation of brain function is the only basis upon which to secure viable organs for transplant purposes. If the pronouncement of death were delayed until the heart actually stopped beating, the organs would undergo so much deterioration that a successful transplant

would be jeopardized.

Last year in Maine, 22 kidneys were removed on the basis of brain death criterion. Testimony indicated that approximately 150 Maine citizens

are currently waiting for kidney transplants. Several witnesses felt that statutory codification of the concept of brain death was unnecessary and inappropriate. These witnesses felt that the physician was best able to make the determination as to when death occurred and that such a determination would be based upon the customary standards of medical practice.

All of the witnesses were in agreement that the utilization of brain death, as determined by the physician, was a lawful means of determining death in the State of Maine. The committee

agrees with that position.

As a result of the public hearing, the sponsor of the legislation and the committee determined that the concept of brain death is lawful in the State of Maine. It was the opinion of the sponsor and the committee that it was unnecessary to enact legislation specifically recognizing this concept by statute, inasmuch as we believed such a concept is recognized as part of the common law of Maine and inasmuch as there has been no question concerning the validity of this concept ever raised in this state.

For these reasons, the committee recommends that this body accept the request of the sponsor and the report of the committee that L. D. 52. An Act to Define the Moment of Death, be

granted leave to withdraw.

I apologize to the members of the House for

taking so much time.

Mr. PALMER: Mr. Speaker, Ladies and Gentlemen of the House: I will be very brief, but I must admit to you that I was a little bit upset a few moments ago when a bill which I sponsored and indeed the Majority Leader said was one of the finer bills we have before the legislature this session was tabled for two days and it may end up being tabled unassigned with the PUC bills, for all I know, for the rest of this

I want to bring a few things out about this bill because I think it was a travesty to allow that to happen. One, this bill went before the State Government Committee. There was not one word of opposition at the time of the hearing. It came out of the State Government Committee with a unanimous "ought to pass" report. It has gone through this House and the other body without one word of opposition, and this morning it comes to the point of enactment and we table it. We table it for nothing more than purely raw, political reasons because there is another bill having to do with agencies which happens to be a Democrat bill.

I have no fight with the fact that there is a Democrat bill here on agencies. I have not expressed opposition to that bill. As a matter of fact, that bill and this bill can pass together and one would not conflict with the other whatsoever. I just see this as something which is purely partisan, which is going to extend this session if we continue to do this sort of thing.

This bill has the editorial support of most of the Maine newspapers, it is a good bill, it is a people's bill, it is a bill the people of Maine people's bill, it is a bill the people of mannewant. This morning we are delaying action on that bill only for one reason, which is to see what happens to the other bill, and I presume that if the other hill. the reasoning would follow that if the other bill fails, we will kill this one too, regardless of how good it may be. I think it is a poor start in a very, very bad direction for this session.

Gentlemen of the House: We had a development this weekend which I think is of great interest to all of us. On Friday, Loring Air Force Base received the new Environmental Impact Report, and a discussion with the Commander at Loring, the report is fairly accurate. They are estimating around a 22 to 26 percent unemployment rate on account of the reduction at the base. The figure of 83 percent reduction still is in the mill. It is the one they are still looking forward to.
