ment and redistricting purposes; and WHEREAS, the 107th Legislature ordered a joint select committee to be established to study the census requirements for reapportionment and redistricting and that committee began that study; and WHEREAS, that study is presently in-

complete and needs to be completed as soon as possible; now, therefore, be it

At this point, the Sergeant-at-Arms escorted William J. Rogers to the rostrum amid the applause of the House, the members rising. The SPEAKER: The Chair is pleased to

welcome a native son back to Maine. Bill is a graduate of Edward Little High School and during World War II served in the Navy as a bomber pilot and achieved the grade of Lieutenant Senior Grade and is a graduate of Syracuse University.

He came back to Maine and became a founding member of the Keep Maine Scenic organization, served as Vice President for 20 years of the United States Brewers Association and held just about every post in the American Legion. His home post is still Post 153 in New Auburn. He resides now in Kennebunk.

For those of you who don't know, and I am sure there isn't anyone here who doesn't know, Bill has been elected National Commander of the American Legion. Of course, this brings not only pride upon himself but the entire State of Maine. For that reason, I am pleased to introduce to you the National Commander of the American Legion, William J. Rogers. (Applause)

WILLIAM ROGERS: Thank you very much, Speaker John, distinguished members of the House of Representatives in Maine and my friends: It is a real pleasure to be back in the State of Maine again and particularly for me to be in these halls. I think probably many of you know that I spent a great deal of time here some 10 or 15 years ago fighting many battles. I think probably you know from John's introduc-tion that I do work for the United States Brewers Association and there was a thing. called bottles and cans we were concerned about in those days, and still are, incidentally. It was so far back that I remember when the Senator Motel was still selling those great lobster sandwiches for \$2. I understand they don't even sell them any more.

I am pleased to address you today for just a few moments. I know how busy your time is and I think perhaps I am going to take one point of personal privilege, if I may, Mr. Speaker, and I am not going to introduce all of the people who are up here, but I do want you to meet Mr. Legionnaire in the State of Maine. He was the Adjutant of the State of Maine for some 46 years and he still is very active, going to national conventions and to national executive committee meetings, and that is Jim Boyle from Waterville. (Prolonged applause)

We of the American Legion welcome the opportunity to speak to legislatures at all levels of government, and for me, this is a very special occasion, as I have said. I think it is to us a continuing evidence of the success of this great American system of government, by and for the people, which was once a noble experiment but is now a time tested, workable reality. Two centuries of existence under every kind

of circumstance the human condition can undergo is a demanding test of any system, and now we are embarked upon our third century as a strong, free and independent nation and the envy of the world.

Most of you are familiar with the role of the American Legion as far as our legislative ac-tivities are concerned, and you know that the vast majority of our legislative work is done with the Congress of the United States in areas such as veterans' affairs, rehabilitation, national security and other similar activities.

There have been occasions in the past, and there will be those occasions in the future, when we have had national programs requiring action. at the state and local levels to make them effective. We have even had occasions when it took the collective voice of many state legislatures to convince the Congress of the United States that our objectives were proper, popular and reflective of the will of the people. The most recent example of the latter type was our long and strenuous battle to have Veterans' Day returned to its proper place of November 11. Our petitions to the Congress fell on deaf ears for a number of years, until we decided to appeal to the legislatures of the several states to enact legislation to return Veterans' Day to November 11 in their own states.

We worked diligently at this project for more than two years, and the response of most states was very heartwarming. By the time 46 states, either by declining to change the date of their Veterans' Day observance or by legislative action returning the date of the observance to November 11, the Congress saw the handwriting on the wall and heard the voices of the people through the collective voices of the state legislatures and voted overwhelmingly in both the House and the Senate to change our national holiday back to November 11.

This is a perfect example of accomplishing indirectly that which cannot be accomplished or could not be accomplished directly, and it further serves as an example of the fact that our state legislatures are more responsive to the wishes of the people. The process, I believe, speaks well for our system of government by proving once again that this system of ours does work. The system is worth having, it is worth defending. Members of our organization, just as many of you have, have fought for it, and while it is our earnest prayer that neither we nor our children will ever have to fight again, the will of the American people for the defense of the freedom must always remain strong, and we do not believe that the will of the American people, whether it be proposed by Republican or Democrat, includes amnesty for draft dodgers.

We are going to carry this message to the Congress of the United States, the message of the American Legion on behalf of a strong system of national security. We are going to continue to carry that message to the American people. We are going to continue to carry it to governmental bodies such as this legislature, even though you do not shape national defense budgets or policies. budgets or policies.

We take this approach to the problem of making known our position on the status of our national defense system because everyone should know it, and the more people who know it, the more people are concerned, and the more people who are concerned, there are more to voice that concern to the Congress of the United States.

Ladies and gentlemen of the Maine Legislature, I thank you again for allowing me to appear before you briefly. It is a pleasure to return to my native state of Maine. I left it for some 12 years, and moving back to Kennebunk was our choice, and believe me, it was a happy one. Thank you very much. Thereupon, Mr. William Rogers was escorted

from the hall by the Sergeant at Arms amid prolonged applause, the members rising.
