Mr. BERRY: Mr. Speaker, Ladies and Gentlemen of the House: I am going to move the indefinite postponement of this bill and all of the accompanying papers and I would like to of its accompanying papers, and I would like to tell you why. I had made a few notes that I was going to refer to, but I think they slid over onto Mrs. Kany's desk and we can't find them, so I will do the best I can without the notes.

In 1975, we had a fine bill come in here, and that is very rare, and we enacted it into law, and I think it is too bad, if you do get a good bill in here and enact it into law, that you come back two years later and try to repeal that, and that is essentially what the L.D. that is present-

ly before you does.
What we did in 1975 was enact a law that said if county commissioners hire a county administrator to do their duties, then those county commissioners would have to forego their salaries, except for \$25 for each meeting they attended. If you repeal that, then the county commissioners can go out and hire a county administrator and they can be paid their salaries and the county administrator can be paid his slary, and essentially they are all doing the same job.

I hope you will support the indefinite post-ponement motion.
