HOUSE

Tuesday, January 24, 1978 The House met according to adjournment and was called to order by the Speaker.

gentleman from Orono, Mr. Davies.
Mr. DAVIES: Mr. Speaker and Members of the House: It is with a very sad and heavy heart that I stand today to address my remarks to one of my very good friends and close associates in Orono, a person who may have served with some of the more veteran members of this House in the Legislature in 1963 through 1965.

Keith Anderson was truly a distinguished citizen of Orono, and I do not use the term lightly.

He was a person who, during every day of his adult life, served his fellow citizens in some fashion or another. It is more than just a long list of credits that you find in a person's obituary, it is the personal experiences that you have with a person in observing him in action and seeing the things that he does for his fellow citizens that truly make a person distinguished, and certainly Keith Anderson filled this definition. He is a person who was always looking out for the people who lived in Orono, whether it was in his service as a State Legislator here in this body in the early sixties or whether it was as Postmaster of Orono, a position that he has held since 1965, whether it was as a member of the Town Council, which he held unitl the day of his death, whether it was as member of the school committee, whether it was in voluntary organizations of all types, Keith Anderson was a busy man, a person who had not time to worry about his own personal situations, a person who gave his all to his fellow citizens.

It is with great sadness that we have to say goodbye to him, because we can ill-afford to lose people of his caliber, but he is gone and there is nothing that we can do except to remember him fondly, remember him for all the good that he did and to wish his wife and his amily the best in passing through this hard time and may they, when they come out of it, see the value that he gave to his community and to his state, to his nation, and that they might feel a degree of comfort from knowing that he was a good man and a distinguished citizen of Orono.

The SPEAKER: The Chair recognizes the gentleman from East Millinocket, Mr. Birt.

Mr. BIRT: Mr. Speaker, Ladies and Gentlemen of the House: This was a little surprise to me when I came in and found out what had happened to Representative Anderson. I am probable one of the few people who served in the Legislature with Keith, served on the Appropriations Committee. I have occasionally seen him since then. I think he made some real contributions during his period of time in the Legislature serving as assistant floor leader, and I am sure it is a great loss. He was a young person who had a great deal of capability and had made some real contributions. I think we should all be sorry for his passing.
