I am sure that the Bill's sponsor would want to appear at a hearing supporting it, and convince the Committee that there is a need for it. I respect the judgment of the Committee,

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Merrill.

Mr. MERRILL: Mr. President, I certainly

am not an expert on suckers or this Bill, but as I understand this Bill and certainly Chairman of the Business Legislation Committee, the Senator from Kennebec, Senator Pierce, can set me straight if I am wrong, this Bill actually removes the legal impediment for activity now in this State. The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Jackson.

Mr. JACKSON: Mr. President and Fellow Members, this morning there was on your desk a piece of correspondence from the Local and County Government Committee regarding County salaries. We wish that you would take note of what we have put together in here. What we did was we listed the budgetary figures from the budget for the Statutory officers salaries.

If you are in disagreement with these, we would appreciate it if you would contact either Chairman of the Committee, with a sufficient number of signatures, requiring better than 50 percent, in agreement to raising these salaries or decreasing. If you would take note of this, and please have this in by Thursday, because this is the only Bill that is holding up the County budgets, and we do need this Bill in order to put these budgets out.

The PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Chapman.
Mr. CHAPMAN: Mr. President and Ladies

and Gentlemen of the Senate:

I rise to speak briefly on what is a significant occasion in our country and what is a singular opportunity for us here in the state of Maine. As I'm sure you all now realize, this is the day that the 200-mile limit law goes into effect. As Senate chairman of the Joint Committee on Marine Resources, I am acutely aware of the impact that this law is going to have on the fisheries industry here in Maine.

For the first time in years, we have a broad public awareness of this resource off our shores an awareness not only of its existence, but also of its limitations and of its importance to our state economy — a resource that has been tapped heavily by foreign fishing vessels, while our own fishing efforts have declined due to a vast number of reasons, all of which our fishermen are only too well aware. We are waking up to the situation at last, and the first great step has been taken.

But, lest we get a sense of satisfaction that all is well, we must see this step as our opportunity to get to work — to participate and do our share. By "we", I mean both our fishing in-dustry in all of its facets, as well as the State of Maine through its Legislature and its Department of Marine Resources. We must take this opportunity and make it our rallying flag by actively working together, constructively and purposefully, to rebuild a healthy and prosperous Maine fishing industry. To not do so will only create a void into which surely the federal government will step. We must not allow this to

If truly there is Down East independence left in Maine, it certainly is found amongst our fishermen. I feel very optimistic that they will meet this challenge. I admonish us here in the Senate, and our colleagues in the House, that we also meet this challenge when we are presented with legislation designed to assist in this renewal of our fisheries industry.

A new opportunity now exists today, and it is only good to us, if we take it. I think we will. The future can be bright for our fisheries industry.
