In accordance with 3 M.R.S.A., Chapter 6, Section 151, and with Joint Rule 37 of the 108th Legislature, the Joint Standing Committee on Public Utilities has had under consideration the nomination of Diantha A. Carrigan to the position of Commissioner, Public Utilities Commission.

After public hearing and discussion on this nomination, the Committee proceeded to vote

on the motion to recommend to the Senate of the 108th Maine Legislature that this nomi-nation be confirmed. The vote was taken by the yeas and nays. The Committee Assistant called the roll with the following result:

Representatives -10

NAYS: Senators - 0 Representatives -0

ABSENT: 0

Thirteen members of the Committee having voted in the affirmative and none in the negiative, it was the vote of the Committee that the nomination of Diantha A. Carrigan to the posi-tion of Commissioner, Public Utilities Commission he confirmed.

Mr. PRESIDENT: The Joint Standing Com-mittee on Public Utilities has recommended that the nomination of Diantha A. Carrigan be confirmed.

Mr. PRESIDENT: The pending question before the Senate is:

Shall the recommendation of the Committee on Public Utilities be overriden? In accordance with 3 M.R.S.A., Chapter 6, Section 151, and with Joint Rule 37 of the 108th Legislature, the vote will be taken by the yeas and nays. A vote of YES will be in favor of overriding the recommendation of the Committee. A vote of NO will be in favor of sustaining the recommendation of the Committee. Is the Senate ready for the question?

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Mr. CARPENTER: Mr. President and Ladies and Gentlemen of the Senate, as you will note on your calendar this morning, it was unanimous decision of the Committee on Public Utilities to recommend the confirmation, or reconfirmation if you will, of Diantha Carrigan to the Public Utilities Commission.

The three member Board is presently involved in three of the bigger rate cases that the State of Maine has ever seen, and even though Diantha was just confirmed to the Public Utilities Commission a short time ago, and during the interim between then and now, she has not been feeling well, so she has missed some time. I thought it was very admirable and interesting that no opponents appeared before the Public Utilities to oppose Diantha to a full seven year term.

This is a very serious position, and I think that it is more serious, or the seriousness is high lighted when you realize it is a seven year term. Which is one of the longer terms of any office I believe in the State of Maine. And I would hope this morning, that given her qualifi-cations and the discussions that have taken place, really she has had two confirmation hearings within the last three months and it has been very, very closely scrutinized and I know of no opposition at this point, and I would hope we would give her a unanimous bill of approval this morning. Thank you. The PRESIDENT: The Secretary will call
