the nomination of Mary Adams be denied.

Mr. PRESIDENT: The pending question before the Senate is: Shall the recommendation of the Committee on Education be overridden? In accordance with 3 M.R.S.A., Chapter 6, Section 151, and with Joint Rule 37 of the 108th Legislature, the vote will be taken by the yeas and nays.

A vote of Yes will be in favor of overriding the recommendation of the Committee.

A vote of No will be in favor of sustaining the recommendation of the Committee.

Is the Senate ready for the question?
The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Mr. KATZ: Mr. President the Committee on Education dealt with six nominations by the Governor. We dealt with them all in one day. It was patently improper for us to attempt immediately to sit down and discuss all six, we de-layed our action. Although the Committee was not in contact, the various members were not in contact with each other, we had a signifi-cantly long time to consider what we had heard and how we were going to vote.

On the nomination of Mrs. Adams the Committee voted 8 to 5 against confirmation. The Committee has come under significant criticism for its vote. I was one of those who disagree vigorously with the majority of my own Committee, but I must be protective of the Legislative process and say that when ever any Legislative Committee is assigned a task and its members are called upon to exercise their conscience and vote, it is my feeling that I respect the vote of those who disagree whether they are in the minority or the majority. I want to assure this Senate that the 13 diverse members, and believe me it is an extremely diverse Committee when these 13 members casts their votes, their votes were not capricious but represented the best judgement and the honest judgement of each one of them.

I voted for Mary Adams because I feel that she is a highly qualified woman. She brings a bright mind and proven ability to the task of the State Board of Educaion.

I was involved in writing the language which created the current State Board of Education so I have a feeling for what was intended by the Legislature at the time that we created it. We specifically precluded from service any professional educators save only if one were a college president. I want the Senate to understand that at the time that language was written the reason we included a college president was because the State Board of Education also functions in the performance of its duties as the Higher Educational Facilities Commission, which at that time dealt with federal monies for college construction.

The hearing of Mrs. Adams was long, it was searching. When it was all over and when finally we voted, many members of the committee, 8 of them to be exact, voted against her. There is never any partisan implications in a report of the Committee on Education, we studiously avoid it. Some Democrats voted against her, and some Republicans voted against her and the opposite was true. I am absolutely confident today that when I ask the Senate to sustain the majority point of view that the Senate overwhelmingly will vote to overturn the report of the Committee on Education and confirm Mrs. Adams to the State Board of Education. I have had a long and unique relationship with Mrs. Adams and perhaps as well as any other person in this Body I have reason to be unenthused about some of her ideas but my wife points out to me on occasion I am wrong and so do the people of the State of Maine. So. I ask the Senate to override today and vote to ap-

prove the nomination of Mrs. Adams.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Merrill.

Mr. MERRILL: Mr. President and Members of the Senate: I intend to vote today with the Chairman of the Education Committee to override their recommendation and hopefully to confirm Mary Adams. I would like to say that I do so, because I think that any board benefits from a strong division of opinion and I certainly respect the vigor with which Mary Adams has put forth her position in the state and in which she continues to. I would just like to say though in voting that to confirm her, that I want there to be no misunderstanding that I do not share her views on education. I feel very strongly that the people who are involved in education in the state are making a terrific contribution. I feel very strongly that educators, in particularly teachers, have been maligned in the last few years much more then they should be and I would like to say in voting as I do today that some of the negative feelings that have been expressed toward the educational system by Mary Adams certainly are not my own. And I would hope that people of the state would un-derstand that that is probably the position of the Senate as well.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Mr. CONLEY: Mr. President and Members of the Senate: I would like to echo the sentiments of my colleague from Portland Senator Merrill, that my vote will also indicate that I do not agree with the policies that have been expressed by Mary Adams in the past couple of years, but I think that it is extremely important that any board that we establish in state government does have balance on that board and I believe that because of the fact that of confirmation of Mary Adams that it may just give some different ideas and different ways of thinking with respect to the entire establishment within education, and it may very well turn out to be one of the better things that could happen to state government. And for those reasons I will vote to confirm her this morning.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Usher.

Mr. USHER: Mr. President and Members of the Senate: Today we decide on the nomination of Mary Adams to the State Board of Education, a very important job. Many of my constituants are concerned about the attitude and comments of the nominee because they feel that she may jeopardize the future education of this state. This board has to work together and set guidelines for educational systems. Eight members of our Committee voted in the negative for the nominee for valid reasons. I feel that the Committee vote should stand. There have been comments from the media that Mary Adams was questioned extensively. I feel that she was treated as fair as the other nominees of that day. I ask that the Senate not override the committee vote.

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkows-

Mr. MINKOWSKY: Mr. President and Members of the Senate: Up to this morning I was a little apprehensive about the vote on Mrs. Adams. And I received a few pieces of correspondence from a few constituents as well as a few telephone calls from people who happen to live in or outside of my Senatorial District voicing the disapproval of Mary Adams actions, especially on a television broadcast which was referred to as News Circle Extra Addition, around May 14th.

I guess if I was to look at it just from the viewpoint of some of the expressions made by Mrs. Adams that I would not be doing my job properly because I think a balance has to be struck between people who sometimes become very complacent on these different boards and a person who might be dynamic that might put in a different point of view which would enhance the meeting of what the lay people on the

Board of Education would want.

On that particular basis Mr. President and Members of the Senate I intend to vote this morning for confirmation of Mrs. Adams to the State Board of Education.

The PRESIDENT: The Chair recognizes the

Senator from Kennebec, Senator Katz. Mr. KATZ: Earlier this year Mrs. Adams was elected to her local school administrative district board of education. In an opinion of the Attorney General dated May 25, 1978, in response to a request from Representative Edith Beaulieu of May the 4th the Attorney General has indicated that there would be a conflict between simultaneous service on the State Board of Education and the local school board. We have been assured by the Governor and I pre-sume by Mrs. Adams that upon confirmation by the Senate she will indeed resign from the local school board so that she may serve without conflict on the State Board of Education.
The PRESIDENT: The Chair recognizes the

Senator from Sagadahoc, Senator Chapman.
Mr. CHAPMAN: Mr. President, Ladies and

Gentlemen of the Senate: I too urge the Senate to confirm the nomination of Mary Adams to the State Board of Education. I have had the opportunity of knowing and working with Mary Adams during the past two years. She is an

alert, intelligent, sincere person, with deep convictions about the desirability of more local control of education, and the need to stress the "back to basics" philosophy of education — views that are strongly supported by many citizens of this state. It is true, her background is not one steeped in education experience, but she does, nevertheless, have educational experience, as Senator Katz has just mentioned she has been elected to the local school board SAD. 46 which indicates the confidence of those who know her best in her ability to address educational management problems.

Mary Adams can bring to the State Board of Education a healthy viewpoint from the other side of the coin — one well versed in the coping with education from outside the establishment. The old saying "One can't see the forest for the trees" may well apply to education management these days. If so, a voice questioning established methods and procedures can certainly help to focus attention to these areas in the form of critical analysis and constructive reassessment. Such a balancing of views has to be healthy, and certainly in the best in-terests of the citizens of Maine.

If the ideas Mary Adams espouses are found to have merit by at least four other members of the State Board of Education, then she will prevail on an issue. But only then, for she will be one of nine and certainly not a situation for panic for those who are concerned about her philosophy. Again, I see this as a healthy ba-lance which can only inure to better, more reflective, administrative results for the State of Maine.

There are some who have criticized Mary Adams for her negative attitude toward education. Negativism, like beauty, often is in the eye of the beholder. Because Mary Adams has been on the opposite side from that of many in the emotion-filled issue of the uniform property tax, she is considered by them to be negative. Far from it, in my view, for the clear majority of voters in this state soundly supported the position she advocated. Better than for all concerned that she be involved from within on this matter of education management which so dramatically affects us all.

Mary Adams is a dedicated citizen. She is qualifed for this appointment. It is in the best interests of the State of Maine that she be confirmed and given this opportunity to serve. Let her put her actions to work. Let her put her

words into commitment.

Dear Senator Sewall: This responds to your request of May 12, 1978. In that letter you ask if Senate action on June 2, 1978, regarding certain recommendations for confirmation submitted by the Committee on Labor would be valid and appropriate to confirm or override the recommendations of the Labor Committee. We answer in the affirma-

The question you pose results from legislative consideration of two nominations to the Maine Labor Relations Board. The nominations in question were submitted by written notice of the Governor on February 15, 1978. The Joint Standing Committee on Labor recommendations of these positions. ommended confirmation of those nominations on May 4, 1978. The Senate meets June 2, 1978, to consider recommendations of various committees regarding pending nominations. 3 M.R.S.A. § 151 prevents the Senate from validly considering and confirming or overriding the Committee on Labor's recommendations.

Attached hereto is an opinion dated April 11, 1978, in which we generally discussed the status of the Maine Labor Relations Board nominations which were then pending before the Committee on Labor. As noted in that opinion, since § 151 contains no sanction specifying that the nomination be disapproved, approved or moved to the next step in the process when a time limit is not met, the nominations must be deemed still pending. Therefore, the nominations, having been acted upon by the Committee on Labor, may now be considered pending business in the Senate for action as the Senate deems appropriate.

Mr. President and Members of this Senate: On a number of occasions, I have been critical of the bureaucracy here in Augusta. On a number of occasions I have heaped praise upon a certain individuals, such as Richard Barringer, the Commissioner of Conservation. Praise for Ken Stratton for his efforts in changing the image of LURC. Praise for Donald Hoxie and Eugene Moreau in Health Engineering for their efforts on a new and improved plumbing code.

And I've even apologized on this Senate floor - and had struck from the records - the remarks I made about the former Director of the Department of Environmental Protection. And I apologized for a remark I made about some people in the Department of Education.

I've also stood here at my desk and made that remark that "A Deputy Attorney General can issue an opinion, which then becomes law and must be challenged in the courts before it

can be reversed."

Mr. President and Members of this Senate -I resent it and I believe we should be concerned when any department head uses the office of the Attorney General to interpret any law - to be used in any way - that is not the intent of this Legislature.

Mr. President — I, along with many other members of this body, voted for the so-called agency bill to permit agency stores in remote areas that wanted liquor, but it was not feasible to establish these stores. The intent of that piece of legislation was not to close any of the existing state stores nor to replace them with agency stores - but that is exactly what our

Beverages.

It must be remembered that the same stores the commission is closing are those that were established under enabling legislation - and I doubt his or their authority to do so.

present director of the Bureau of Alcoholic

On or about May 1st, in a letter to me by the director he asked for my views on the closing of the state stores in Mexico and Rangeley. He cited L. D. 1122 and about intermittent employees and these stores would be replaced by agency stores permitted to operate between the hours of 9 a.m. and 12 p.m.

I drove to Augusta a week later. The director was in California. However, I did express my views to the other two commissioners that were present and they said they would pass them on the the director for their May 23rd

meeting. The town officials of the town of Mexico directed the town manager to convey their views to the commission and their opposition to any

agency store in the town.

On May 25th I called the director of the bureau. He informed me that the commission voted to close the two stores - and to open agency stores. I told him I would not object to the Rangeley store. I understand the remoteness of it and the cost of the operation there. If he must close the store in Mexico fine, but, no agency store in the town, that is what we do not want in the Town of Mexico. He informed me that regardless of how I felt — of the town officers felt - he had the authority - and he would establish and agency store in the town of Mexico.

There is a state store in Rumford and there is one in Mexico. Each gross more than \$400,000.00 annually. The cost of operation is below that 8 percent figure that we heard tossed around during debate on another bill.

The cost of operating the Mexico store is less than the Rumford store. I believe the figure was 7.4 percent. With the recent increase in liquor prices - the cost would be nearer 7 percent - can you believe it - we are going to have to have an agency store - give someone 8 percent to sell the liquor and put two persons out of work.

Mr. President, when I expressed my concerns on who or what type of person might be operating the agency store — he assured me that there would be input from local officials before a decision was made as to who it would be. I asked if he had any idea as to who would

make application for the agency. His reply was that a certain well known company, I won't name the company had indicated a desire for

Mr. President - the Mexico State Liquor Store is in a complex owned by this certain company. I know that there are a great number of state liquor stores located in complexes owned by this company and I wonder how many more will become agency stores. Mr. President as long as state liquor stores rented space at a price that was comparable to that of other renters in these complexes — I did not — and would not object.

But I have an uneasy feeling that perhaps this certain company will wind up with a statewide network of agency stores and the state will be out of the business. It seems certain in my mind that the agency concept for the town of Mexico was brought about because of this certain companys' interest in it.

Mr. President — each of us here today are public servants. We try to represent our constituents and their desires. Each employee of this state is a recipient of the taxpayers' dollars and therefore also public accounts. lars and therefore also public servants, and they should not forget it.

I find it intolerable when a man is appointed to a position of trust and then flagrantly abuses that power to subvert the intent of the legislature and then dictates what he will or will not

I submit that the actions and performance of our present director of the Bureau of Alcholic Beverages, Keith Ingraham, is highly suspect.

Mr. LOVELL: Mr. President and Members of the Senate: As Chairman of the Liquor Control Committee I feel that I should make some response to the good Senator, Senator O'Leary. I have only been on in the last session but it was my understanding when I went on the Liquor Control Committee that any liquor, State Liquor Store that did not show a 15 percent net profit could be eliminated when the lease was up in that area or community and a non-participating liquor store could be named

Now four years ago they stated, the Liquor Control Committee stated that the Liquor Commission would be allowed thirty such grocery stores. Well we have one down in Wells, the Harris Grocery Store and in the last session of the Legislature we had two bills in. One to raise the Legislature we had two bills in. One to raise
the profit for the grocery store or drug store
that sold the hard liquor to 15 percent and one
to 12 percent at the present time with the
excise tax the profit is 10 percent and with the
excise tax the store only makes 8 percent. But
we argued on the Senate floor if you remember
that a drug store for example sells newspapers,
sells cigarettes and makes little or no profit but sells cigarettes and makes little or no profit but he does it to get the people in the store. Now we will admit that 8 percent profit is not a very high profit but on the other hand the liquor control, the Department, handling liquor makes \$25 million a year on some \$4 million business. And we felt that if we raised this up to 12 or 15 percent for the grocery store that it would cut the profit of the liquor stores down considerab-

Now as far as running a store is concerned in a community. If the store does not make sufficient net profit to make it worthwhile to have that store in that community then, I do not care if it is a liquor store or a hardware store or a grocery store, they are going out of business and then maybe somebody else will start right up in a different area or in that same town. Well that is the way the liquor thing was set up as my understanding. And I could stand to be corrected, but the State Liquor Commission was allowed 30 stores and they reported to the Liquor Control Committee last year that, no I guess that it was this year, that their 30 stores

have been successful and they had 29 at the time and they had been successful, and they had made good money and they would like the Liquor Control Committee to allow them to have more stores in the State of Maine having hard liquor in grocery stores which would permit them to make a good profit to take care of towns that were so far away from a liquor store that the people might have to travel 30 or 40 miles to get liquor which would be quite inconvenient. For a heavy drinker certainly. So consequently, the Liquor Control Committee voted to allow the commission to open more stores in various areas of the State. Now I think that that covers about what I had to say, and I do not think that I do not know the exact profit of what the Mexico store made. I do know that the Rangeley store was under the net profit that it should be and I am sorry to see the Rangeley store closed because the owner of the store is a former state Senator, Senator Noyes and I would like to see if I could his store stay open. But I just cannot take sides on this. And I thank you for your patience.
