Mr. JALBERT: Mr. Speaker, Ladies and

Gentlemen of the House: Yesterday, I was unable to be here for personal reasons. watched the news in my community and picked up the phone and called one of my colleagues from Lewiston, Representative Georgette Berube, to tell her about her comments as far as CETA is concerned, and we discussed it at some length, that part of the program, and that was all that she discussed and I thoroughly agreed with her.

In this morning's Bangor Daily News, and I am not taking issue with the Bangor Daily News. I am not taking issue with the individual who wrote the article, because I always make these comments every two years and the time is appropriate now as far as I am concerned. If I pick up a paper and an article is in my favor, I buy 125 copies. If it is against me, it is the opinion of one man. If they misprint my name, I sue

them

I am only talking now and addressing myself because the article heads, "Knox CETA Chief Blasts Aid Misuse Charge." I am talking about

that solely, addressing myself principally to my good colleague from Knox County. It says in part, "Just when you get some good press, some half cocked legislator comes along and lambastes a program she does not personally like. Those of us who bust our butts to try and run a good program, who try to gain the public confidence, get hit by these false accusations and are on the defensive all the time.

"If she had simply followed through, at least in Knox County, she would have found that a complete rebuttal was on file to account for every penny of that money. She would have found that her charges were felonius." These remarks were made by Manuel Mitchell, director of the county program, who I do not know at all, no doubt a fine gentleman, although he should, in the press at least, refrain from the words 'butts,' at least when he is talking about

a fine lady.

I do know Mrs. Berube is very conscientious. She is from my community. I am the senior member of not only the legislature but certainly from my community, and she doesn't need any protection from me. She never has discussed—I am addressing myself to the Knox County members-Knox County on town conversations I have had with her concerning CETA, and her comments, in my opinion, were appropriate. Not once has she ever mentioned Knox County. I know she has a strong feeling for Knox County. I have a very strong feeling for Knox County being married close to that county, but I think I can speak for Mrs. Berube. I would like to have our legislators from Knox County call Mr. Mitchell, tell him that Mrs. Berube never mentioned them, that we have affection for Knox County and we want to keep it that way, but we could very quickly lose it.
