Mrs. KANY: Mr. Speaker, Members of the House: I move acceptance of the Minority "Ought to Pass" Report.
The SPEAKER: The Chair recognizes the

gentlewoman from Brunswick, Mrs. Bachrach.

Mrs. BACHRACH: Mr. Speaker, Men and Women of the House: I move that this bill and all its accompanying papers be indefinitely postponed.

This bill was heard with two other bills proposing changes in the age in which people can serve as either Senators or Representatives in state government. I feel that there is no pressing need to change the age of Senators, primarily, and also that there is good reason to propose that people should be a little older than 21 years in order to be Senators.

The weight of responsibility of the Senate position is heavier than that in the House. They are representing more people, thay have more committee responsibilities and it is altogether

a somewhat more difficult job.

In addition to the difficulty of the job, however, you have to consider the fact that what we rely on in the legislative process in the committee hearings is the background and expertise of our members. We are fortunate in having a wide range of expertise built right into this system because of people coming from different parts of the state and having different experiential backgrounds.

A person 21 years old, however bright he may be, has very little in the way of his past experience to draw on when it comes to making decisions in committee, and for this reason, I feel that a few more years of living and working and learning is really desirable if you are to

serve in the Senate.

Also, there are fewer Senators and therefore there are fewer people to rely on. The House can provide the learning process because we have so many members; in the Senate that is

The SPEAKER: The Chair recognizes the gentleman from Augusta, Mr. Paradis

Mr. PARADIS: Mr. Speaker, I would like to pose a question through the Chair to anyone who may answer. If the size of the House of Representatives were to be reduced from 151 members to 132 members or 99 members. would the age requirement be upped in order to go in line with the remarks I have heard this

morning?
The SPEAKER: The gentleman from Augusta, Mr. Paradis, has posed a question through the Chair to anyone who may care to answer.

The Chair recognizes the gentleman from Lewiston, Mr. Nadeau.

Mr. NADEAU: Mr. Speaker, Members of the House: I can appreciate the comments and the concerns of the gentlelady from Brunswick, Mrs. Bachrach but, of course, I must respect-

fully disagree.

I would like to cite a personal experience or observation in terms of qualifications of younger members. Myself, being 21 years old, at 18 I was managing and doing the bookkeeping for my father's family business. I had to make the deposits at the end of the week, meet the payroll, pay the IRS taxes and, indeed, learned a great deal about the value of a dollar. During this process. I was receiving an education in a part-time program at the University of Maine in Augusta, so I feel that between the ages of 18 and 21. I have learned a great deal about life and a great deal about responsibility

I would also like to cite some statistics and some testimony I gave before the State Government Committee. The reason I introduced this bill in the first place was that I felt that it was simply inconsistent to have this variation in the age between the House and the Senate. As far as I have been taught, we are equal bodies in almost every respect, and I sincerely believe that if we in the House are qualified at 21 years old to serve, there is no reason why we should not be qualified to serve in the State

I would cite that other states, indeed, have age qualifications suggested in L.D. 97 - Connecticut, Florida, Illinois, Michigan, Oregon, Virginia. The only unicameral Legislature in the country, Nevada, has a statutory limit of 21. For that it is worth, the Virgin Islands form of government, their Senate is 21 years old as

I would simply ask you to consider this and

deliver what I feel is fair and just and that we equalize the age between the two bodies. So, I would hope you consider to oppose the motion to indefinitely postpone.

The SPEAKER: The Chair recognizes the gentleman from Milo, Mr. Masterman.

Mr. MASTERMAN: Mr. Speaker, Ladies and Gentlemen of the House: The previous speaker made some very interesting comments, and I am sure that at 21 he has learned a great deal. In his own words, he said that he has had a lot of experience at 21 and he has learned. I am sure that he is absolutely right. I would suggest that in the next 21 years, he will have learned a great deal more, and I would urge you to support Mrs. Bachrach's motion for indefinite postponement.

The SPEAKER: The Chair recognizes the gentlewoman from Waterville, Mrs. Kany.

Mrs. KANY: Mr. Speaker, Members of the House: I would like you to think about the faith that you are willing to put in the voters of the State of Maine. Actually, if this bill passes, it would still be up to the voters, the electorate, if they choose to vote in favor of sending someone 21, 22, 23 or 24 years old to the other body. After all, you have to realize that these people, the people of Maine, had the good sense to elect all of us. Why not trust them to choose good legislators?

I would hope that you would vote against the motion before us and in favor of this bill.

The SPEAKER: The Chair recognizes the gentleman from Farmington, Mr. Morton.

Mr. MORTON: Mr. Speaker, Ladies and Gentlemen of the House: The remarks of the most immediate previous speaker, the gentlelady from Waterville, Mrs. Kany, called to my mind a point which I think we all ought to consider in this matter. It is true that the voters of the State of Maine elect their Senators and Representatives, the same thing is true in the National Congress, but there have been and there has always been a tradition of respecting the opportunity to gain experience and that is reflected the Federal Constitution and in our Maine Constitution. And I would just say in refutation of what the gentlelady just said, if you were to follow her idea to its logical conclusion, that there be no age limits and that someone might be elected who was 10 or 12 or 15 years of age, to say nothing of 21, 22, 24 or 30.

I think there is no harm in retaining age limitations for certain responsibilities. I think it is good business for the people of the State of Maine and, frankly, I have not heard the people of the State of Maine clamoring for this legislation. This legislation did not come from the people of the State of Maine and I think we

ought to remember that.

The SPEAKER: The Chair recognizes the gentlewoman from Waterville, Mrs. Kany.

Mrs. KANY: Mr. Speaker, Members of the House: I just wanted to point out that this bill does not propose that we allow 12 year olds to run for the other body. It, indeed, would just call for 21 year olds being able to run for the other body, which is the same age at which people are allowed to run for this House.

The SPEAKER: The Chair will order a vote. The pending question is on the motion of the gentlewoman from Brunswick, Mrs. Bachrach, that this bill and all its accompanying papers be indefinitely postponed. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

75 having voted in the affirmative and 52 in the negative, the motion did prevail. Sent up for concurrence.

gentleman from Lisbon Falls, Mr. Tierney. Mr. TIERNEY: Mr. Speaker, Men and Women of the House: A few moments ago, my internal intercom telephone rang and my good friend from Cumberland, Mr. Garsoe, requested that this bill be tabled for a day so that his party might have the opportunity to caucus on it. Naturally, in the spirit of bipartisan cooperation, I readily agreed, and perhaps even the Democrats might want to dicuss it, but prior to that motion being made, I just want everyone to take a good look at this bill. It allows the Maine Secretary of State to appoint all justices of the peace without any particular hinderance or guidelines, and I would just hope that if the Secretary of State is not acceptable, perhaps the job could be shifted to the Governor or some other such position, and I look to your guidance or perhaps Mr. Garsoe's guidance on it next week.
