Monday, March 26, 1979

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Reverend Donald Jones of the First Baptist Church, Livermore Falls.

Rev. JONES: Let us pray! Oh God, our help in ages past, our hope for years to come, we gather as representatives of the people of the State of Maine to do the work of legislation. We are aware of the awesome responsibility that rests upon our shoulders. We recognize the far-reaching effects the decisions we make today will have upon our people. Thus, oh God, we would not treat lightly the responsibilities you have given us, for we are answerable to the people. Help us to be sensitive to human needs about us, and may we have clarity of thought concerning the issues that confront us. Give us the courage of our convictions and temper our deliberations with love. For all this, we give you our hearty thanks in the name of Jesus Christ, Our Lord. Amen.

The members stood at attention during the playing of the National Anthem by the Livermore Falls High School Band.

The journal of the previous session was read and approved.

Mr. BROWN: Mr. Speaker, Ladies and Gentlemen of the House: As you probably may have guessed, today is a very proud day for me, and a proud day for the people of Livermore Falls, Livermore and Fayette.

Last fall, the Livermore Falls High School Band found that it had been selected as the official band to represent Maine at the Cherry Blossom Festival scheduled for Washington D. C. next week. At first it appeared that between \$7,000 and \$9,000 would have to be raised for this project. That seemed like a lot of money for such a small organization. Further research showed that it was going to cost at least \$14,000 to send this group. That was a massive task.

The young people began a fund drive in our communities and sought to raise that amount. For many months, all of us in those communities have been saving our newspapers, our bottles and cans and helping in every way that we can to make that fund drive a success. The results speak for themselves. Last week, this group of dedicated young people topped the \$14,000 limit. The effect of raising that money to send these outstanding people to our Nation's Capital has had a lasting impact on our communities. It has brought us together in a way that perhaps we have never been brought together before.

We have with us today some of the finest young people in the nation. I am very proud of them and our communities are very proud of them. Won't you join with me today in wishing them well as they prepare for the great honor of representing the great State of Maine in Washington D. C. next week.

The SPEAKER: The Chair recognizes the gentleman from Limerick, Mr. Carroll.

Mr. CARROLL: Mr. Speaker, Ladies and Gentlemen of the House: I would now move that we accept the Majority "Ought Not to Pass" report.

The SPEAKER: The Chair recognizes the gentleman from Woolwich, Mr. Leonard.

Mr. LEONARD: Mr. Speaker, Ladies and Gentlemen of the House: This is probably not one of the bills that will be least heard of in the State of Maine. I am sure the Press Herald and other papers in the State of Maine won't give me front page coverage. However, it is an important bill and it seems that it has received a little bit of unfair treatment in the committee.

I will explain the bill. The title really does explain it, but it simply states that there is a problem in the State of Maine that many people in trying to speed their way, expedite their way from one place to another, are cutting across corner lots, leaving the roadway that was provided for them by the State of Maine at our benevolence and our tax dollar, and cutting across some private citizen's lot of land and

then entering the roadway on the other side. That, I submit, is an unsafe practice.

I was asked four years ago to sponsor this bill, which I did, and it met a similar fate, although I was kind of hoodwinked by the committee back then; they asked me for a leave to withdraw or a majority "ought not to pass" and I took the leave to withdraw and that is the way it came out.

I went back and I talked with — having been a freshman I really wasn't prepared, so I talked with Chief of Police Association, I talked with the State Police, I talked with local police departments and I asked, what is wrong with the bill? In no case whatsoever, never has one of those agencies said it is a bad bill. Never has one of those agencies said it is an unenforceable bill. They have all said it is needed in the State of Maine and we very definitely should have it and it should receive passage in this Legislature.

I presented my bill in front of the Transportation Committee. I really wasn't terribly psyched up for its presentation because I thought it was such an automatic bill that I really wouldn't receive any opposition. However, I found, much to my dismay, that several of the people, I shouldn't say several but at least a couple of the members on the committee, make it a practice to go across a corner lot in order to get here to the State House on time. Well, if that is the reason for voting against the bill, I submit they are being a little bit reckless with their authority.

I won't speak again, but I am going to give you a couple things that come from the Maine State Police, the Department of Public Safety. Number one, their position on L. D. 406 — there are several areas in the state where this is a problem. To avoid a traffic light, some of us will cut through the yard of business and back on the highway beyond the intersection. They state that this is a hazard to the safety of pedestrians and other motorists. Presently, there is no law that prohibits this type of action; the Bureau of State police is in favor of this bill.

Second-after having hearing reports from the committee that this is an unenforceable bill, that is the thrust of their "Ought not to Pass" Report as I understand it, I asked the bureau again, is it enforceable? They said, yes, it is the opinion of the Bureau of State Police that this proposal would be enforceable. This type of action in usually taken in a rapid, continual manner so as to avoid the traffic that is waiting for the control device to change. It is this type of action that would indicate to a law enforcement officer that a violation had taken place. The officer, after stopping the individual, would be able to determine if there were any extenuating circumstances and would have the option of issuing a summons, a warning or taking no action at all. The fact that this would be illegal would deter the average motorist. Those operators that intentionally ignore the law would be the obvious violators as described above. Obviously, they would be prosecuted to the full extent of the law and not make the session, possibly.

I hope that you will vote against the Majority "Ought not to Pass" Report, vote for the "Ought to Pass" Report, when I make that motion after we have dispensed with the "Ought Not to Pass" Report.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Jacques.

Mr. JACQUES: Mr. Speaker, Ladies and Gentlemen of the House: This bill has been in front of our committee for the past 10 to 12 years that I can remember. As a matter of fact, we had an opinion in our caucus in the City of Lewiston at one time that it was unconstitutional. This is private property. The owner of the station or the store can always sign a warrant against that gentleman that went through that parking lot or whatever it is. I saw one time where a man was arrested, he had forgotten his pocketbook, so he went right through

the filling station and went back home to pick up his pocketbook so so he could get some gasoline and he was picked up by an officer and the judge let him go. These are the things that we don't want to mess around with. We have city ordinances, if they want to put them in, which were ruled as being unconstitutional because this is private land. So, it is up to you to pass or not to pass.

The SPEAKER: The pending question is on the motion of the gentleman from Limerick, Mr. Carroll, that the House accept the Majority "Ought Not to Pass" Report. All in favor of that motion will vote yes; those opposed will vote no.

A vote of the House was taken.

73 having voted in the affirmative and 38 in the negative, the motion did prevail.

Reports were read.

The SPEAKER: The Chair recognizes the gentleman from Limerick, Mr. Carroll.

Mr. CARROLL: Mr. Speaker, Ladies and Gentlemen of the House: I would now move that we accept the Majority "Ought to Pass" Report.

The SPEAKER: The Chair recognizes the gentleman from Eliot, Mr. McPherson.

Mr. McPHERSON: Mr. Speaker, Ladies and Gentlemen of the House: Having signed the minority report, I feel I should at least bring to you some of my reasons. I feel that this is merely foot-in-the-door approach by the trucking industry for larger trucks. I question as to where it is going to stop; just how much bigger are they going to get? The reason given for the bill is to allow for longer power units on the tractors, better load distribution.

The people of the State of Maine spoke quite clearly in 1974 when they initiated a referendum and defeated legislation which increased the gross weight at that time to 50 tons. I feel our secondary road system in this state is inadequate to handle any larger trucks. As we heard the other day, our Highway fund is in trouble by \$7 million to \$8 million.

On the turnpike, the motorist is literally being blown off the road by trucks. Friday, going home, I noticed six trucks following one another, six tractor-trailer trucks, one behind the other. This would mean, if this bill were passed, that there would be 360 feet of trucks alone, never mind any space between them.

This trucking industry claims that their concern is for the driver's safety, and is he really concerned when he is exceeding the posted speed limit 10 to 15 miles an hour. They con-

cern themselves with telling us about all the taxes that they pay, but they never mention the thousands of dollars that are being lost to the State of Maine in fuel taxes that they aren't paying by fueling up in New Hampshire and some of the other schemes that they are pulling.

I would just like to point out to you, ladies and gentlemen, our concern here today should be for the motorists and that small 3,000 pound car, not really the trucker in his 80,000 pound giant.

The SPEAKER: The Chair recognizes the gentleman from Sangerville, Mr. Hall.

Mr. HALL: Mr. Speaker, Ladies and Gentlemen of the House: I, too, have problems with this because, as you are well aware, in my area, going from Guilford through to Harmony, there is a truck every 15 minutes night and day, five days a week over this road. The psychological effect that I have noticed when my wife and I have followed these trucks, the length that they have already is that they take up about five-eighths of the road, leaving about three-eighths of the road to the people that are passing on the other side. Now, they may be within the lines that are designated in the center of the road, but the people that are passing them or going the opposite way, have the daylight scared out of them because of that load they already have. Some of those loads are more crooked than a snake's back. You are going to meet yourself coming, and I don't see how you are going to justify having trucks any longer than they are now.

The SPEAKER: The Chair recognizes the gentleman from Lincoln, Mr. MacEachern.

Mr. MacEACHERN: Mr. Speaker, Ladies and Gentlemen of the House: This bill is a safety bill. It slightly increases the length that a trailer truck can be. At the present time, with the boxes that they use on the back of these, they have to have what they call a cab-over, in which the driver is sitting right on top of the engine. He is right up in the bow of the thing. It is a perilous position to be in one of those trucks.

This bill merely allows them to increase the length of the towing unit, the tractor so called. It permits the engine to be out front and the driver sitting back behind it. Maine is the only state in New England that doesn't have this length increase. It would just bring Maine in compliance with the other New England states and permit the truckers to have a little bit safer rig to be going down the road with. It doesn't increase the width of the truck, it doesn't increase the carrying capacity, the gross weight, all it does is let them use a little safer truck. I hope you vote for the bill.

The SPEAKER: The Chair recognizes the gentleman from Portland, Mr. Joyce.

Mr. JOYCE: Mr. Speaker, Ladies and Gentlemen of the House: I thought I would have a great deal of difficulty in voting on this bill. Today when I throw my switch, it will be the first time that I will be voting without the expert advice of our truck authority from Portland, for our expert in this field did not choose to run again, and when I look over to my left, I no longer see that authority, Representative John Jensen.

The good representative would get up and make long speeches, would tell us how on these trucks the back wheels actually ran forward. He was the authority on lengths and weights of trucks. He had a certain fixation regarding trucks, and I think that was part of my life when I used to help him cross the street down there in front of the Portland Exposition Building. He would speak in detail about these trucks, and I learned always to listen, then to vote opposite.

I looked for an authority this time and said I would have to go to someone who would guide me. I had the occasion then to talk to Mr. Albert Grasse in Portland, a long time employee of Milliken-Tomlinson; they are the dis-

tributors for the independent grocers of Maine and run trucks throughout the state. He took several minutes and explained to me what an energy saver this bill would be and how much it would cut costs, strictly an energy thing.

You know, I looked the bill over and I went and got the amendment today, and I know if Representative Jensen were here, he would knock this one, so I feel safe and I urge you to vote to support this bill, the "ought to pass."

The SPEAKER: The pending question is on the motion of the gentleman from Limerick, Mr. Carroll, that the Majority "Ought to Pass" Report be accepted. All those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

85 having voted in the affirmative and 30 having voted in the negative, the motion did prevail.

Thereupon, the Bill was read once. Committee Amendment "A" (H-124) was read by the Clerk and adopted and the Bill assigned for second reading tomorrow.

I think this is a serious situation. I don't like the bill and I hope that you vote against enacting it.
