Thursday, October 11, 1979
The House met according to adjournment and was called to order by the Speaker.
Prayer by the Reverend John H. Ineson of

P. 1589) (L. Subsequently, Mr. Baker for the Committee reported that they had delivered the message with which they were charged, and the Governor was pleased to say that he would address the House forthwith.

Whereupon, Governor Joseph E. Brennan entered the hall of the House and addressed the members as follows:

Mr. Speaker, Ladies and Gentlemen of the House: We are doing this anticipating that the Senate will enact the bill.

I am pleased, though, to have a chance to address you this final time, your work completed.

I appreciate the frustration of many of you of

waiting and waiting and waiting. I know it has not been easy, but the development of new and unprecedented legislation seldom is easy. I know that you have worked in good conscience and have been separated by honest differences as to the proper role of government in solving new problems and in spending the limited resources available to us. I appreciate that you have labored under additional difficulties brought on by the uncertainty as to when and to what extent the federal government will meet its obligations, but despite these very real obstacles, a bill to meet a part of the need created by the massive oil price increases has been enacted.

I believe that the bill that has been passed is not as much as we should do and it is not as much as we could do, but it is apparently the best that we can do working through a legislative process which I have the greatest respect for. At least we do have the satisfaction of knowing it is a greater effort than any of our sister states have made.

I will continue to be concerned, as I am sure all of you will, that our elderly, that our neediest citizens, that the most vulnerable among us, do have enough fuel for this winter. We will watch the situation carefully, we will work for adequate federal funding, and in January, when winter has set in, we will report to you our assessment of the state and of the needs of our

In the meantime, I do want to express my appreciation and the appreciation of your fellow citizens for your honest and for your good-faith effort to deal with the very human problem to make sure that none of our citizens go cold.

At the conclusion of the Governor's address, he withdrew amid applause, the members

Mr. MAHANY: Mr. Speaker, and Honorable Members of the House: I move that the House stand adjourned without day.

Thereupon, the motion prevailed and at 4:16 P.M., Eastern Daylight Saving Time, Thursday, October 11, 1979, the Speaker declared the House adjourned without day.
