The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Trotzky

Senator TROTZKY: Mr. President and Members of the Senate, I know that all of you are saddened to hear of the loss of Joseph Saxl to the State of Maine.

Joseph Saxl was a friend of mine in Bangor. He was Superintendent of the Bangor Mental Health Institute. Four years ago, or so, the Legislature was faced with a Bill which would have closed Bangor Mental Health Institute. During that time many legislators, many people in the community, many people within the mental health field sought to examine BMHI to see if it was providing quality health services to the people of the State of Maine. At that time, in the examination and the political fight that ensued, Joe Saxl, through his leadership and through the work of all the employees at Bangor Mental Health Institute, achieved accreditation for that institute. It was through his leaderhip that this accreditation was obtained, and because of this accreditation BMHI was allowed to remain open to serve the people of the State of Maine. Joe Saxl was a man who motivated people, and when I was up to BMHI I saw how he motivated all the State employees in that unit to work together.

I would like to read into the Record, a statement which I see which was a statement from Joseph Brennan. Governor Brennan Joe Saxl proved himself to be a dedicated and innovative administrator and a caring man. His leadership was instrumental in obtaining the first accreditation of BMHI in 1976. He believed that BMHI should be a part of the health care system of the community, not separate and an aloof facility. He worked clo-sely with other service providers to integrate BMHI into the community. He was a leading proponent to the belief that families of those served by BMHI deserved a treatment facility located in Northern Maine, to minimize bar-riers created by distance.' Thank you. Senator from Penobscot Senator Pray.

Senator PRAY: Mr. President and Members of the Senate, I think it would be very easy to stand up here and laud the accomplishments of Joseph Saxl, but more important than just that is the fact that Joe Saxl, to those of us who knew him, will surely be missed just as a human being. The love that anybody that worked with Joe had for him, the respect, the admiration, and the love for such a man who could accomplish so much with so little, with not only what the State gave him but other people as well. The patients at BMHI and those who worked there and those who are served by that institute will miss Joe more as a human being than as superintendent of the facility.

We receive a number of these memorials that go through here and I think this is, of all the ones I have seen in my 4 terms down here, this is the one that really saddens me the most for what this State has lost.
