Senate called to order by the President.

Prayer by Father William Bartoul of St. Joseph's Maronite Church in Waterville.
FATHER BARTOUL: Let us pray. Heavenly

The PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Minkows-

Senator MINKOWSKY: Mr. President, and Members of the Senate, the reason why I had this bill placed aside yesterday, so that it could be tabled until today, was so as to get a reasonable explanation from someone on the Judiciary Committee relative to if this particular item, which endeavors to make public without written consent of the parties the proceedings that would be used as evidence in any subsequent proceedings civil or criminal.

I only ask for an explanation from somebody on that particular committee. I thought possi-bly we might be getting into an area of precluding somebody's rights, in so far, as knowing what is going on. I feel that the Maine Human Rights Commission in its wisdom handles many hundreds of cases during the course of a year, but I certainly do not want to cover up if there is justifiable cases that should have public scrutiny. All I guess that I am asking for really is the explanation that this item will not be covered up by the Maine Human Rights Commission.

The PRESIDENT: The Chair recognizes the

Senator from York, Senator Kerry.
Senator KERRY: This specific bill was introduced by the Maine Human Rights Commission, to resolve a problem with confidentiality prior to a 1977 amendment, which allowed for a predetermination resolutions of a Human Rights Commission problem. All of the commissions had to conduct full investigations. Therefore, when the 1977 amendment was presented it did not include a confidentiality section, giving the people who were involved in the discussions confidentiality in trying to resolve it without a full investigation. What this does in effect is allow them to discuss the problem without having to reveal it publicly. It protects them from having any evidence presented to be used against them in either criminal or civil court proceedings later.

Secondly, if, there is a predetermined resolu-tion of the problem the public document, that results from this discussion, then becomes public. This is similar to a court proceeding or "rules of evidence," I believe, it is Rule 408 of the General Court Proceedings in the Statutes. Therefore, the main point is that it does not preclude the publication of the document which is the settlement and it does allow the commission, and the people involved to discuss it freely
