I was of the opinion this Bill would not even receive a public notice to have a public hearing, and as a courtesy to me it would be granted.

However, the Bill was put out as a notice to the public that it would have a public hearing. I did get press releases, I did make radio announcements, and such, that this Bill would be asked for a Leave to Withdraw, but a lot of people did not hear this, didn't read it.

There were people here from Rumford, Auburn, Bucksport and Woodland. I talked to them out here in the corridor and told them my reasons. I gave them copies of the opinion. I think in the future when a Bill is requested from the committee chairman that it not be advertised that they would like a Leave to Withdraw that the courtesy should be extended. I now move the pending question.
The PRESIDENT: The Chair recognizes the

Senator from Lincoln, Senator Sewall. Senator SEWALL: Thank you, Mr. President, Members of the Senate. The Bill had been, as Senator O'Leary said, referred to the committee. I checked with May Ross and I checked with Ed Pert, as to the procedure that must be taken. They said, that since it had already been printed, and its number, and been referred to the committee before cloture, even though it could have been held until the last day, since it had been referred we had to schedule it for hearing. We did that, we gave several weeks notice, there was three weeks notice, that we were going to do this. The PRESIDENT: The Senator has the floor. Senator O'LEARY: Mr. President, this Bill received a public hearing last week. I thought that both the proponents and the opponents

stated their case very well.

Mr. President, I am of the opinion that the method of entry by liquor inspectors is not in keeping with the image as public servants. They obtain entry, in what I would call less then ethical methods. To give you an example of why I believe this: One of my organizations, which is a non-profit organization and donates their extra menutal themset all writer and for their extra money to the mentally retarded, for scholarships and such, had a dance, one night, two liquor inspectors, a male and female, following another couple in. The guard at the door said: Hi, Noel, to the club member. The Guest book is right there, and the inspector says, how do you spell Noel's last name, he says 'Theberg'. So he writes it down that he is a guest of Noel Theberg. Fine. He and the other inspector then proceed in, purchased a drink, and the following business day they receive a summons.

Mr. President, I do not believe, that that is an ethical procedure on the part of liquor inspectors. They are public servants paid for by the public's dollars. The fine that goes along with the illegal sale to a none club member is perhaps a hundred dollars, the lose of the license for a month means, that much less that is going to be donated to a scholarship fund, or a mentally-retarded organizations. I do not think it is asking to much that when these people are going to appear in one of these licensed premises that they appear in uniform. They wanted the uniform, they wanted pistols, they have got them, now use them. I would, therefore, move the Minority Ought to Pass Report.
The PRESIDENT: The Chair recognizes the

Senator from Waldo, Senator Shute.
Senator SHUTE: Mr. President, Ladies and Gentlemen of the Senate, the reason for the lopsided report on this 12 to 1 Ought Not to Pass, wasn't a coincidence. The Bill in question requires that liquor inspectors have their uniform on before taking any action, arresting anybody, or serving a warrent, or summons or anything. Now can you imagine if a youngster was buying liquor up to Shaws Market, or First National, and they had to run home and get their uniform on before they could arrest that

youngster from buying beer, or liquor.

Somebody suggested at the hearing, that the liquor inspectors should, at least, be required to blow their siren, have their lights on, and blow a whistle before entering these establishments that they have had problems with. The Committee did not think that we should go in quite that direction.

I know one of the clubs that the good Senator from Oxford, Senator O'Leary is referring to was busted five times and maybe that was one

of the reasons for the Legislation.

I think the committee felt that if these clubs were going to have the privilege of operating, not outside of the law, but with privileges that other places do not have. They should have some responsibility to operate under the present system. I really think that it would not work to well to have a liquor inspector have to be in uniform before making an arrest, any more than it would be for a police officer to have to be in uniform before making an arrest if he saw some criminal act being committed.

I would urge that you reject the pending motion and accept the Ought Not to Pass
