I have the honor to transmit herewith an initiated bill, "AN ACT to Create the Maine Energy Commission," and the result of the examination by this office of the initiative petitions relating to it.

The minimum number of valid signatures required to initiate this legislation is 37,026. On January 22, 1981, our office received 1,767 petitions said to contain 43,268. After extensive review we have determined the number of valid signatures to be 43,214.

In view of the foregoing determination, I hereby certify that these petitions have met the constitutional requirements of the minimum of 37,026 valid signatures. Since the petitions have previously satisfied the constitutional requirements in all other respects, under the provision of Article IV, Part Third, Section 18, of the Constitution of Maine, I do hereby declare this initiative petition to be valid.

In the event the Legislature rejects this initiative proposal, a referendum election will be called for November, 1981.

The department has come in because it was a department Bill, but it was done through a regional study, to have uniformity throughout the Northeast region. The departments and bureaus with the same functions having the same names, so that they could be easily identified.

There seems to be some question about the social welfare, there was some debate down in the other body, in this regard. I really did not want to get into that now, but if you want to I

There seemed to be no, the department brought the Bill, because that it seemed to be by statute that it had to be done. That question was not raised as to whether it could be done by

policy of the department.
