When we changed over from the Executive Council to our new confirmation process we made up a long laundry list of people that we felt it was important for us to look over and confirm. I suspect at that time that we made some good judgments and some bad judgments. It is really kind of difficult when you come up with that initial list to know who you should confirm and who you shouldn't.

It seems to me that since the process has now been around for awhile, it would make a lot more sense for the Committee on State Government to look at all of those whom we confirm and all of those that we don't, and make recommendations, on kind of an omnibus basis. There are obviously some that we do not need to do, or that we thought we might, and there are others that we feel we should

I think, that that would make a lot more sense than just having a legislator come in here with one bill after another for their own pet concerns, that we are going to now confirm: the Liquor Commissioner, or the Housing Authority Commission, or whatever. I do not think that that is a very orderly process. I do not think that it makes a lot of sense for the Legislature to address additions or deletions to the process in that manner. I did, at least, just want to bring that thought to the attention of the Senate.

The PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Ault.

Senator AULT: In reply to Senator Pierce, I just would like to say that if he would support any such Order that would direct the State Government Committee to investigate all confirmations, I would be pleased to pass the word on to Representative Kany and I am sure she would be pleased to sponsor it.

that we Accept the Majority Ought Not to Pass

The PRESIDENT: The Chair recognnizes the Senator from York, Senator Dutremble.
Senator DUTREMBLE: Mr. President, and

Men and Women of the Senate, I would hope that we would not Accept the Majority Ought Not To Pass Report and I would like to say a few words on that.

You know, I use checks quite a bit, and I have got one right here for you. Little did I know when I took out this checking account, a few years back, that in 1981 I would become a criminal suspect for using it.

You know, when you go out and get a checking account that you can have all these little pictures on it. Maybe we could have them start putting our fingerprints on it; so that we could save these businesses some time, and save them some money; so that they could go out and check on us anytime that they want to.

You know, last year in the Committee on Business Legislation we had a Bill on Lie Detector Tests. I do not consider this to be any different. We prohibited Lie Detector tests for employees, last year, because it was an invasion on people's privacy. I do not see this Bill being any different than preventing an invasion of people's privacy, when they go to a business and they require you to take fingerprints before you can purchase anything. That is clearly an invasion of my privacy, clearly.

I cannot believe that if I want to go to certain places in this State that they would require me to do that, if I want to use a check to buy it.

There are other ways of identification, and other ways that people don't mind. They don't mind the driver's license, they don't mind any other kinds of identification. When you get to the point when you have to start using fingerprints for identification, then it is time to start questioning the direction that we want to go.

Now, it has been said, that the consumers can take care of that themselves by not shopping in that store. What happens if this becomes widespread? What happens if the consumer is intimidated? It's pure harrassment. It is an embarrassment. I can just picture myself going into a store and being in a long line, and the guy says; well we have to take your fingerprints if you are going to write

a check.

You know, this Bill does not hurt business. It doesn't cost business anything, it doesn't create paperwork for them, it is just a good preventive bill.

I am for free enterprise too, but I am not for free enterprise for business at the cost of the privacy, harassment, and embarrassment of the consumer

I think, that if we do not pass this bill, even though it is not widespread right now, that it could become in the future. If we do not pass this bill, I think, that all we are doing is giving a green light to some of these businesses in the State. Believe me, I think, that a lot of them will pass it. I would hope we would vote against the Majority Ought Not to Pass Report, so that we can Accept the Minority Ought To Pass

The PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Sutton.

Senator SUTTON: I would like to reply to the proposition that is now before us. It really is too bad that we have to be standing here even talking about this subject, but I guess that that is one of the things that comes with being an elected official, you have the opportunity to place legislation before the State Legislature regardless of its worth.

The good Senator who indicated that it was an invasion of privacy to do this, I would reply to, that if he were required to go to that store in the first place that we might accept that as a possible theorem, but he is not required to go to the store.

One store in the State of Maine, that we know

of was requiring fingerprints at one time.

Bad checks is a bad problem in the State. By the way, you might like to know the terrible thing that you have to do or did have to do at that particular store that was place one finger on a pad, that did not show when you put it on the back of the check, that did not show. We were also told that they did arrest several people trying to pass checks that were not good, by this method.

The free enterprise system certainly will adjust itself to this. This is nothing that the State Legislature should be intervening in, a position between stores and the public, or the banks.

At one time, we were requiring fingerprinting of children in school, this is an invasion of privacy, unequivocally, and I would not be standing here defending it, but this is something that we should not be involved in. I would certainly urge you to Accept this Ought Not To Pass Report

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark. Senator CLARK: Mr. President, Men and

Women of the Senate, the good Senator from York, Senator Dutremble has tendered a position, this morning, which reflects the sentiments of the sponsor of this measure. There is merit to his concern, and I think, it is appropriate that the Maine legislature consider the issue before us.

Fingerprinting in business in order to cash a check at the check-out counter is a reprehensible practice. I concur that it is an invasion of privacy, I also, concur that it may cause embarrassment, that most customers don't know that this will be required should they attempt to pay for their bill with a check.

I signed the Ought Not to Pass Report for some of the reasons as expressed by the good Senator from Oxford, Senator Sutton, the Senate Chairmen of the Committee on Business Legislation. The practice was isolated with one merchandizing business who had a number of branches in the State of Maine. The impetus of the introduction of this measure to prohibit that practice, encouraged that single business to stop requiring fingerprints should customers

wish to pay their bills with a check.
I signed the Ought Not To Pass Report, because I believed at this time, that it is indeed inappropriate that we prohibit a practice in Maine business enterprises which, in fact, doesn't exist at this time and on this date. Should, however, that business resume the practice of fingerprinting, I would sign, should the Bill be introduced at another time, to prohibit that practice with the Ought To Pass Report. At this time, I would encourage the Members of the Senate to Accept the Majority

Senator COLLINS: Mr. President, on our

desks this morning was a copy of a letter from Martin Wilk, a former Deputy Attorney General of the State, to our present Attorney General. Attached to that letter was a copy of LD 731 which is now before us.

Yesterday, the Attorney General requested members of Leadership of both Branches to meet with him. He explained to us the urgency in presenting, to the Legislature, the question that is involved in this Bill.

In order to gain a full understanding of this measure, we have arranged to have the representatives of the Attorney General's Office meet with the Senate, in Joint Caucus, so we may all hear an explanation and ask questions. That Joint Caucus will follow in a Recess

You will note this measure has already been Passed to be Engrossed by the other Body without Reference to Committee so that the matter could be moved along promptly.

It would be my request to the Senate that we do the same in this Body; that we pass the measure to be Engrossed without Reference to Committee: that we then Recess and have a full explanation and discussion of the measure, so that when it comes back to us for Final Enactment we will know exactly what we are doing. If we have any doubts about it, we can express them at that time.

Therefore, Mr. President, I would move that we proceed with this paper to the extent that is indicated, after which time I would move that the Senate be in Recess so we could have a

Joint Caucus. Thank you, Mr. President. The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Huber.

Senator HUBER: Mr. President, because of the possibility of the appearance of a Conflict of Interest, I request Leave of the Senate to abstain on this measure.

The PRESIDENT: The Senator from Cumberland, Senator Huber, has requested Leave of the Senate to refrain from voting on this issue.

Is it the pleasure of the Senate to grant this leave?

It is a vote.

The PRESIDENT: The Chair would also request Leave of the Senate to refrain from voting on this issue because of the possibility of an appearance of a Conflict of Interest.

Therefore, we don't need a Bill and this is why we granted the Leave to Withdraw. That was almost unanimous, at least; all the members of the Committee that were present there, except maybe there was one missing, we were all in agreement. This is why we would like to see the Leave to Withdraw stay the way it is.
