Senator DEVOE: Thank you very much, Mr. President. Mr. President and Members of the Senate, I present Senate Amendment "A" under Filing Number S-15 and move its Adoption, and would speak briefly to my motion. Senate Amendment "A" (S-15) Read.

The PRESIDENT Pro tem: The Senator has the floor.

Senator DEVOE: Thank you, Mr. President. Mr. President and Members of the Senate, this amendment deals with the Bill, concerning the forfeiture of cash that is found and other securities that are found in drug raids.

It is a unanimous committee Bill. The committee was under the impression that the Bill as drafted and as it fitted into the other sections in Title 22, would insure that all the cash that was found and ultimately forfeited in court proceedings would go to the general fund of the state after the cost of the forfeiture proceed-

We were advised by the Assistant Attorney General, who was working on the Bill with us, after we had reported the Bill out-of-committee, that he felt it appropriate that if the committee wanted to insure that the cash went to the general fund that we should amend the Bill.

Assistant Attorney General Irwin has prepared this amendment. It meets with the pleasure of the Judiciary Committee unanimously, Mr. President, I move its Adoption.
