The PRESIDENT: THE Chair recognizes the

Senator from Washington, Senator Brown. Senator BROWN: Mr. President, and Men and Women of the Senate, I'm confused. I realize perhaps that's not a great revelation to a number of people in these Halls. I'm confused over this particular Bill, LD 4. I'm confused over why this should not be just a simple housekeeping Bill, as opposed to a Divided Report as it comes out of committee.

I have some familiarity with the problem of pesticides, being from Washington County, in the Town of Dennysville, where we've had a lot of concern over pesticides. The present Board of Pesticides Control is made up of: the Commissioner of Agriculture, the Commissioner of Human Services, the Commissioner of Conservation, of Inland Fisheries and Wildlife, of Marine Resources, of Transportation, of Environmental Protection, and of the Chairman of the P.U.C. That makes up the present Pesticides Control Board.

It has been my experience that the present board is an extremely competent board, in conducting hearings about certain toxins in the environment. The fact is that the Departments of Transportation, of Conservation, and of Human Services all use toxins that are regulated by the Pesticides Control Board.

The question comes to me as to why the Department of Agriculture should be the department that registers toxins as opposed to the Board of Pesticides Control. Perhaps someone that's involved in that committee that's been more familiar with this Bill can explain that to me. As it stands now, it seems to be reasonable that we ought to Accept the Minority Report on this Bill. Thank you.

The PRESIDENT: The Chair recognizes the

Senator from York, Senator Hichens.
Senator HICHENS: Mr. President, I beg to correct the good Senator from Washington, Senator Brown. The present Pesticides Board is not as he has stated, that was changed two years ago. That was the big problem that was stated at the hearing. The new Board is now made up of people from the outside of the agricultural units altogether, headed by Mr. Ginn, and one man from the potato industry, and other consumers from other parts of the state. It is not made up of commissioners of the different organizations in which he has stated to you.

Less than two years ago, the Legislature amended the laws relating to the Board of Pesticides Control. Now with the Board having had only two meetings since its formation, we are presented with a Bill to repeal a section of that law without the functions of the Board being really implemented. The present law, which this Bill repeals, states "registration of pesticides, no determination of the commissioner, with respect to the refusal to register or renew a registration, cancellation, suspension, or limitation or use of any pesticide is effective until approved by the Board. The Board shall not approve any such refusal, cancellation, suspension, or limitation for any pesticide registered by the United States Environmental Protection Agency under the United States Insecticide, Fungicide, Rodenticide Act unless a public hearing has been held."

LD 4 repeals that section and replaces it with section 1471, Exercise of Powers by the Board of Pesticide Control, and reads as follows:
"The powers established under the Maine Pesticide Control Act in 1975 should be exercised by the Board of Pesticides Control established by section 1471", which I have just read to you.

The purpose of the Bill is to transfer the responsibility for the registration of pesticides from the Commissioner of Agriculture, Food and Rural Resources, to the Board of Pesticides Control. This will allow one state agency to exercise the existing regulatory authority concerning pesticides in a direct manner without duplication. The majority of the members of the Committee on Agriculture feel that this Board has not been functioning long enough to warrant any change in the present law. Furthermore, the Bill relieves the Commissioner of a responsibility, that in the majority of the committee's opinion, is rightfully his as commissioner

The purpose of transferring responsibility is to eliminate duplication. However, there is little evidence to support that reasoning. In fact, it clouds a more pertinent and desirable arrangement, which is the proper division of responsibilities. The Board should continue to inform and educate the public, while the Department of Agriculture, with its technical expertise, upholds the charge to review and certify pesticide registration requests, which is of critical importance to the productivity and economic viability of Maine agriculture.

At the hearing, there were several organizations who went on Record as opposing LD 4, which represent the farmers and the people interested in agriculture throughout the State, including: the Maine Potato Council, the Maine Potato Sales Services, Aroostook County Farm Bureau, Agricultural Bargaining Organization, Agway, Inc. and the Maine Farm Bureau.

I, therefore, ask that the Senate Accept the

Majority Ought to Pass Report.
The PRESIDENT: The Chair recognizes the Senator from York, Senator Wood.

Senator WOOD: Mr. President, I would request a Division on that motion, and would urge the members to reject the Ought Not to Pass Report, and then go on to Accept the Ought to Pass Report.

There are basically four reasons why I think LD 4 should receive our support and I would like to go over them. The first reason is that it allows for the Commissioner of Agriculture to return to his rightful position of being an advocate for the interests of our farming community. Presently, under existing law, the Commissioner has a regulatory role, so he must remain neutral in pesticide matters, so that he can weigh both sides of the issue. By passing LD 4, we will free him of this neutrality, and allow him to take, as his primary responsibility, the advocating on behalf of the farmers regarding pesticide matters. I think the farming community would be well represented if they had an advocate in the Department of Agriculture instead of a neutral person.

Secondly, this Bill does away with costly duplication by streamlining all pesticide matters to the Pesticide Board where they belong. Currently, because the Commissioner has responsibility in this area, there is a legal quagmire. In order to skirt this quagmire, the Commissioner and the Board have had to hold joint hearings. This causes administrative duplication and increased costs.

Third, from a budgetary viewpoint, of this Bill, presently funds have to go through a rather complex series of fiscal transactions because the present system of funding this agency goes through another agency, namely the Bureau of Public Services, Division of Regulations. LD 4 would allow all pesticide funds to go into one account to be used by the Pesticide Board, thus doing away with costly and complicated budgetary matters.

Fourth, by locating all pesticide functions in one place, the farmers, chemical manufacturers, dealers, and public would have one phone number, one address, and one unit of government to deal with, instead of two, as they have presently. It was for these reasons that I signed the Ought to Pass Report, and

would urge you to do likewise.

The PRESIDENT: Is the Senate ready for the question?

Senator MINKOWSKY: Mr. President, since I am going to vote on this issue, I certainly would like to pose a question through the Chair to the Chairman of the Agriculture Committee. Upon assessing the present Maine Pesticides Board, even though it's only been in existence 8 months, do you find the caliber and quality of the person on the Board satisfactory? In your

the person of the board satisfactory? In your estimation, are they doing a good job?

The PRESIDENT: The Senator from Androscoggin, Senator Minkowsky, has posed a question through the Chair to any Senator who

may care to answer.

Senator HICHENS: In answer to the good Senator from Androscoggin, as I stated in my original statement, they have had two meetings. I think they are getting organized and are probably doing a good job at the present time. That's why I am hesitant to have a change as to the responsibilities. I will remind the members of the Senate that when this bill was passed two years ago, the present Commissioner of Agriculture spoke in favor of the bill as it now

The PRESIDENT: The Chair recognizes the Senator from York, Senator Wood.

Senator WOOD: I would like to, also, respond to that question. I had some reservations about the makeup of the Board when we initially created it, because I thought it was weighed heavily towards those people that are proponents of pesticide use. Although the Board might well have had only two formal meetings, they have held meetings all over the State, various meetings, more numerous than the two that the Senator mentioned. I think that from all aspects, all elements of our state, from the pesticide users to the general public, that there is overwhelming support for the Board. People generally seem to be happy with the makeup of the Board.

I would also point out that although last year this bill was acted upon, and it is correct that the Commissioner did support it at that time, that in the drafting of this bill, this section, I think, was inadvertently left out. In fact, Mr. Shafey, representing the Maine Forest Products Council, came to our hearing, and wondered why we were dealing with this bill because he thought when we redrafted the bill last year we had this section put in. So I would be of this agreement that this probably should have been in Errors and Inconsistencies instead of a full blown bill

The PRESIDENT: A Division has been requested.
