### March 11, 1981

Senator MINKOWSKY: Mr. President and Members of the Senate, before we Accept the Ought to Pass Report of the Committee, possibly somebody from the Education Committee might be able to clarify one point relevant to this particular Bill. That is, presently there are non-degree-granting institutions in the State of Maine. Some of our degree-granting institu-tions including the State of Maine do accept these credits. Will it make it more difficult for the non-degree-granting institutions in the State of Maine to transfer credits to the degree-granting institutions? If somebody on the Education Committee would address that particular question, I'd be very happy to hear their reply

Senator PIERCE: Mr. President, and Members of the Senate, in response to the good Senator's question, which I really didn't hear, I would say that this particular Bill is actually designed after some regulations which have been in the making for quite some time, and follow the present guidelines. It would not make it more difficult for them to do that which the Senator is referring to. In fact, I think this was a very positive and consumer-oriented piece of legislation of the State.

Senator COLLINS: Mr. President, I would like to call the Senate's attention to this particular Bill, and to commend the Committee on Labor for its efforts to tighten up, even though in a modest way, the treatment of unemployment benefits

We're in a week here, in the State of Maine, where there is grave concern about certain aspects of our economy. We are reading every day something about the poultry industry, and the fact that its very existence in Maine is in jeopardy.

One of our colleagues yesterday, at a meeting with some members of the poultry indus-try, heard loud and clear the fact that Maine's very high Workers' Compensation Insurance rates, and Maine's high Unemployment Tax rates placed Maine businessmen and farmers at a competitive disadvantage, which is so delicate a problem, that it can mean the demise of an entire industry.

Maine's Unemployment Trust Fund, which is financed entirely by payroll taxes on em-ployers, is presently indebted to the Federal Government for \$36.4 million. This amount reflects loans which were obtained in order to make benefit payments during the recession of the mid-70's. Since the loans have not been repaid, Federal Law requires Maine employers to pay progressively escalating penalty taxes, under the Federal Unemployment Tax Act.

In 1981, employers are required to pay an additional three tenths of one percent of taxable wages, taxable wages, of course, are the first \$18 per employee. In 1982, an additional six tenths of one percent, or \$36 per employee. In 1983, nine tenths of one percent, or \$54 per employee, and so on.

Assuming that contributions to the fund remain relatively stable, and no additional burdens are placed on the fund, it appears that the State may be able to repay the loans some time in 1983. It will be extremely close. Any legislative action in the meantime, which adds to the current financial drain on the fund, will render total repayment impossible. This will not only necessitate more borrowing from the Federal Government, but it will also result in the continued escalation of Federal Unemployment Tax penalties, penalties 1.2 percent in 1984, 1.5 percent in 1985, and so on. They could conceivably go up to 3.4 percent if the loans are not paid off by the early 1990's.

This scenario would have a dramatic impact on the State's development effort and the health of the existing business community. It should be stressed that the Federal Unemployment Tax Act penalties are paid in addition to the regular State and Federal Unemployment Taxes. The normal Federal Unemployment Tax Act rate is seven tenths of one percent of taxable payroll. The State Unemployment Tax rates vary from 2.4 percent to 5 percent of taxable payrolls, depending on the particular employer's experience.

We all recognize that inequities in the law may exist. The Labor Committee has many pieces of legislation this Session to consider, and some of them may be required to correct inequities. But the solvency of the fund must be the paramount concern of the Legislature. Therefore, Republicans in the Senate have committed themselves, and do commit themselves, not to allow the Maine Unemployment Security Fund to reach the status of the Federal Social Security Fund. We are pledged not to enact legislation that will draw on the fund without providing for the means of financing these added benefits.

I hope the Senate will Accept and Enact the pending measure

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pray.

Senator PRAY: Mr. President and Members of the Senate: I think that the Record should be perfectly clear as to why we are in the situation that we are in today. Back several years ago, when the State came into the economical hard times, the Legislature and government itself was faced with the question of either increasing the Unemployment Tax to pay for the high numbers of individuals unemployed in this State, of working men and women of the State of Maine, who through the economic times became unemployed. At that time the businesses of this State appeared before the Labor Committee, and requested of the Governor that we, the State of Maine, did not increase the Unemployment Tax. Instead they requested that we borrow money from the Federal Government. The reason they wanted to borrow from the Federal Government was because historically in other states that had borrowed, they had never been asked to pay it back. Those few states that had paid it back, and paid it back

late, were assed no penalties. I kind of think what's happened, that busi-nesses, myself included as a businessman, kind of felt we had a free lunch coming down the pike from Washington D.C. Times have changed. The situation, though, is not the fault necessarily of the working men and women of this State who are unemployed. To them, this is a very important sustaining income during those economic times. I think that the first priority of this Legislature should be the welfare of the people of this State, the working men and women, who make Maine a very prime State for industrial development. The working men and women of this State have a long record of producing for the employers of this State. I would hope that we would not arbitrarily, blindly, commit ourselves to legislation which would forget these individuals.

This is one of those laws which just says; Title 17 M.R.S.A. Subsection 3208 is repealed. I'm wondering if anyone on the committee who heard this Bill could ex-plain exactly what it does. Reading the Statement of Fact, from the Bill itself, it says: what is does is repeal an obsolete and unenfor-ceable law, which allows individuals, the guests of hotels and restaurants, prevents them from just spending their time to drink or idly spending their time at play on Sunday. Could somebody explain what that means? The PRESIDENT: The Senator from Penob-scot, Senator Pray, has posed a question

Senato, Scharber Shuffer. Mr. President, Members of the Senate, the Bill does exactly what the Statement of Fact says. It repeals a section of the law that says; the only people that can pa-tronize hotels and lodging places are travelers, or lobbies in the hotels, or bars, or whatever. It seemed to be a little bit obsolete, so we thought it ought to be repealed.
