Senator DUTREMBLE: Mr. President, Ladies and Gentlemen of the Senate, I would hope that we would not Accept the Minority Ought Not to Pass Report so that we could Accept the Majority Ought to Pass Report.

This is a good Bill. It would require an employer to pay for a physician's certificate if that employer requires an employee to get it, before he can go back to work, if he misses a day of work, or any other numbers of days of work. The problem with the law, the way it is now, is that if an employer requires this, a guy who goes out and gets this certificate from the doctor, the bill he gets from the doctor could be as high as the money he makes for one day. It is truly a form of intimidation for an employee to be forced to get a certificate from the doctor, so he could prove that he was really sick on the day he was out.

I think that what we need here is a little bit of trust between the employee and the employer. I think when this happens, it shows that the employer really doesn't trust the employees.

I would hope that we would not accept this Minority Report. I would request a Division, Mr. President

The PRESIDENT: A Division has been requested. The Chair recognizes the Senator from Lin-

coln, Senator Sewall. Senator SEWALL: Mr. President and Members of the Senate, I signed the Ought Not to Pass Report for several reasons. First, to ad-dress what Senator Dutremble has just addressed, and that is the cost of the doctor's appointment. That is paid by the employer, if

they have a sick pay policy.
This Bill applies to both the public and the private sector, to both non-union business and unionized business. In unionized business it's a negotiable item. In a non-union business, some businesses don't even have a sick pay policy. Therefore, they may not even get one if the employer starts thinking that perhaps it's going to cost more and more every time they do it.

What's the reason for an employer asking for the certificate? Usually, an employer asks be-

cause there's a large rate of absenteeism.
This Bill also applies for big business and very small business. The cost to a small employer could be troublesome. That is the simple reason that this Bill is not needed and I hope

you support my report.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley.

Senator CONLEY: Mr. President and Mem-

bers of the Senate, this is a very, very minor piece of legislation. Apparently, the good Senator from Sagadahoc is not quite aware of what it is like out in the, Lincoln, excuse me, working field to know just how much harassment can take place not in a union employment. We have many businesses throughout the state that are non-union. Many employees who can, under the state labor law, can join the union, or organize to have a union if they want. There are many places, as I say, that have preferred to exercise their judgement and have voted unions down. But we do have plenty of shoe shops in this state, we still have a few of them left, where harassment can be part of the employer who has a grievance against one of their employees, may be out sick for a day, may be out sick for two days. When the person comes back to work, he's met at the front door, and he's told, go get a physician's certificate stating that you're well to come back to work, and when you get that, then we'll put you back to work.

Many of these people have families. They can't afford that loss of revenue, that can be well-used for another can of beans, and another loaf of bread on the table at a meal.

We discussed this Bill today at our Democratic caucus. Some people have some concerns about this Bill, the way it's presently written. I think that, perhaps, when it got to the Second Reading stage, we could offer an amendment that would certainly be one that would be accepted in the sense of a five day period, for example, or a three day period. But to mandate someone because one employer or one supervisor working in an establishment may have a personality clash with a particular person, can be an economic disaster in the case of some people.

I would hope that the Senate would vote ag-

ainst the pending motion, and at least, rather than becoming all dominoes, Democrats go one way, Republicans go in another, that we sit down and we try to resolve what I think is a problem, and what many other people think is a problem.

When the vote is taken, Mr. President, I would hope that the Senate would vote against

the pending motion.
The PRESIDENT: Is the Senate ready for
