Which Reports were Read. The PRESIDENT: The Chair recognizes the Senator of from Oxford, Senator O'Leary. Senator O'LEARY: Mr. President, I move Acceptance of the Majority Ought to Pass Report of the Committee.

The PRESIDENT: The Senator from Oxford, Senator O'Leary, moves that the Senate Accept the Majority Ought to Pass Report of the Committee.

The Chair recognizes the Senator from Aroostook, Senator McBreairty. Senator McBREAIRTY: Mr. President, I

would hope that you would not Accept the Majority Ought to Pass Report, so that you might Accept the Minority Ought to Pass Report, so that you might Accept the Minority Ought to Pass Report. I would ask for a Division on the motion that's before you.

The PRESIDENT: A Division has been requested.

The Chair recognizes the Senator from Oxford, Senator O'Leary

Senator O'LEARY: Mr. President, this is not a partisan Bill, it has the bipartisan support of our committee. The Bill is very simple. It sets up a state standard on lead emissions to be exactly the same as the federal, except for one particular point. That point is that you're only allowed, under this Bill, to exceed the limit of 1.5 once per year.

Currently in Maine, there is no one that does exceed the 1.5 limit, although there may be a potential for it in the future. This is kind of a preventive measure.

Under the amendment of the Minority of the Committee, the lead emission remains at 1.5, the same as the Bill, but it establishes, as only an average over a calendar year. Which means that you could exceed it to 2.0 one day, 1.0 the next day, as long as you averaged out at a 1.5, you wouldn't be in violation of the law. It has a very hazardous potential for the air quality.

It's particular damaging, these lead emis-sions, to the young of this State. I hope that you will Accept the Majority Report.

The PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator McBreairty. Senator McBREAIRTY: Mr. President and

Members of the Senate, I have to make one correction in Senator O'Leary's statement. He said, this would allow this over a period of a year. It does not allow it over a period of a year. It would be the average for one quarter. If it averaged more than 1.5 for one quarter of the year, then standards would be exceeded.

Now we have continually in the State of Maine gone with more stringent regulations than the fed's have. This has put our industries and people in a real serious position as far as competing with other areas. I don't believe there's any danger whatever if we go with this Minority Report and accept the Federal standards.

To give you an example, this says, if you exceeded more than one 24 hour period during the year, more than one 24 hour period, you're exceeding the standard on this Bill. In Presque Isle, Maine, where we consider the air as about as pure and clear as anywhere in the State of Maine, they reached 1.76 during a 24 hour period last year sometime. Now I don't know whether they had their testing device stuck up the exhaust pipe of an automobile, where they had it, but they did exceed it once in Presque Isle last year.

I would hope that you would go with the Federal standards. I believe that they are stringent enough. I believe everybody in Maine will be safe, because I doubt if we'll ever reach it. Thank you. The PRESIDENT: Is the Senate ready for

the question?

The Chair recognizes the Senator from Oxford, Senator O'Leary. Senator O'LEARY: The Board of Environ-

mental Protection received evidence and testimony at five public hearings held throughout the State. The Board, after evaluating all the data, adopted a 24 hour lead air quality standard that requires concentrations of lead at any one location not to exceed 1.5 micrograms per cubic meter except once per year. Once per year, not once per quarter, once per year. In order to provide the people of Maine with a greater margin of safety, the Board adopted a lead standard based on a 24 hour maximum lead level. This type of standard precludes the potential of higher levels of lead which may occur within the three month averaging time of the Federal standard. The quarter is the Federal level standard.

The only significant point, source of lead, identified in Maine is from the burning of automotive waste oil, at International Paper in Jay. The department is continuing a study of the impact of this source. At present, there is no evidence that even this mill at Jay, which burns this automotive waste oil, is exceeding the 1.5.

As I said before, this is just a preventive measure, so that in the future, there will not be any more than there is absolutely necessary.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Conley. Senator CONLEY: Mr. President, I request when the vote is taken, it be taken by the Yeas

droscoggin, Senator Minkowsky. Senator MINKOWSKY: Mr. President and Members of the Senate, just for a point of clarification, would the people on the Committee for Energy and Natural Resources give me a more thorough explanation of the term 1.5 mi-crograms per cubic meter. Would they relate that in layman's terminology, so that I could

understand exactly what they're referring to? The PRESIDENT: The Senator from An-droscoggin, Senator Minkowsky, has posed a question through the Chair to any knowledgeable Senator who may care to answer.

The Chair recognizes the Senator from Oxford, Senator O'Leary.

Senator O'LEARY: Mr. President and Mem-bers of the Senate, I'm not knowledgeable in this area. I've never asked the question of how they measure any of these units.

The PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Trotzky. Senator TROTZKY: Mr. President, I'd like

to pose a question through the Chair to mem-bers of the committee as to who opposed, during the public hearings, L. D. 216 as drafted?

The PRESIDENT: The Senator from Penob-scot, Senator Trotzky, has posed a question through the Chair to any member of the committee who may care to answer.

The Chair recognizes the Senator from Aroostook, Senator McBreairty

Senator McBREAIRTY: Mr. President and Members of the Senate, I can't recall who opposed it. I oppose it, because I feel that if we adopt the Federal standards, it's good enough. We're going to breathe the air that comes across from Canada, and from New Hampshire, and everywhere else. We'll probably be dealing with this air whether we adopt ours or not. I think everybody will be perfectly safe if we adopt the Federal standard. I think that we could put somebody down the road in a tough position if we go more stringent, once in a 24 hour period. That 1.76 in Presque Isle, we've already met the standards in this Bill. If we wanted to add something there, kicked out a little bit of lead, we probably can't do it, because we already met the 24 hour period. The Federal standards allows you to average this over a quarter of the year. Then if you exceed it, you're exceeding the standards. That's my feeling on the Bill. If you want to go more stringent, go ahead, but you don't need to. The PRESIDENT: Is the Senate ready for

the question?

The pending question before the Senate is the motion by the Senator from Oxford, Senator O'Leary, that the Senate Accept the Majority Ought to Pass Report of the Committee.
