Senate called to order by the President.

Prayer by Pastor Linda J. Campbell-Marshall of the People's United Methodist Church

briefly to my motion.

The PRESIDENT: The Senator has the floor. Senator McBREAIRTY: Mr. President, Honorable Members of the Senate, the Amendment that we adopted several days ago in the Senate would adopt the Federal standards on lead emission. The difference between the Bill itself and the Amendment we adopted is that the Bill allows 1.5 micrograms per cubic meter during only one 24 hour period during a year. The Federal standards allow an average of one quarter before you would exceed.

Now I don't really believe it makes a lot of difference one way or the other, which one of these standards we adopt. The only difference, I think, is that I feel it's time that we, the State of Maine, stopped sending messages out that we are going to be more stringent than the Federal Government and more stringent than many of our neighboring states. I think this has a deterrent effect on people who wish to come to the State of Maine to do business.

Surprisingly enough, they tell us that in

Presque Isle, Maine, where we feel our air is pretty pure, they did reach 1.76 during a 24 hour period last year. So, if they wanted to set up in certain areas, I'm sure they could exceed this standard in most any city or town we have for one 24 hour period. Thank you.

Senator HICHENS: Mr. President and Members of the Senate, I spoke on this Bill when it was first brought out of committee. I opposed it on the basis that it was imposing too many programs into our public schools. Since that time I have received two letters from my district and just outside of my district, which I would like to share with the Senate. It says, "My dear Mr. Hichens. We are opposed to L. D. 319, An Act Providing for Pupil Screening for Scoliosis and Related Spinal Abnormalities. Students in the Wells Ogunquit Community School District have yearly spinal screening in grades 5-10 and this screening is also part of the routine physical examination required for all students in grades 4, 7 and 10 and sports partici-

We feel that this Bill is unnecessary mandating a service and would also fragment school health services.

Sincerely," with the names of 3 nurses at the Wells Ogunquit Community School District.

This one comes from Biddeford School Department. "Dear Senator Hichens. The York County School Nurses Association Communications Network tells us that you are one of the few persons in the Senate who is attempting to be helpful regarding scoliosis screening in schools.

We are a department of 2 registered nurses and one half-time LPN caring for 4,123 children in 8 separate schools. A mandated scoliosis screening for grades 5 - 8 becomes one more time consuming task that takes us away from the daily imperative needs of the children and their families. We heartedly support your efforts on our behalf.

The PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Gill.

Senator GILL: Mr. President, I too, have received many letters, a lot of them from parents and one of them I will just read briefly. It says, "We immunize our children so that they will not have to suffer the devastation of polio and measles, let us not ask them to suffer the crippling effects of scoliosis. It does not have to happen if identified early and treated prop-

Once again we are not mandating the school system to do this, they have the option of getting help from volunteers in the area, to assist them with this screening process, not mandation. Thank you

The PRESIDENT: Is the Senate ready for the question?

Senator BUSTIN: I do not have the letter before me, but I do have a letter from my pediatrician and two other members of his office, who strongly supported this legislation.
