August 28, 1981

nobscot, Senator Trotzky. Senator TROTZKY: Mr. President and Members of the Senate, the position that we're asked to confirm today is of Dr. Gordon Weil for the position of the Public Advocate. This is a new position that was created by this Legis-

I just want to quickly state that the Public Advocate represents the using and consuming public in matters within the jurisdiction of the Public Utilities Commission with regards to rates, service, and so on. In his or her discretion, the Public Advocate may review, investigate, and make recommendations on these matters to the PUC, may intervene in proceedings before the Commission, and appeal, and so on. The Public Advocate represents the consuming public in matters before the Public Utilities Commission.

We have right now three Public Utilities Commissioners which were appointed by the Governor and confirmed by the Senate. They are supposed to determine fair, just, reasonable rates, however, the public in the State of Maine has seen the rates, electric rates rise. Basically it's because the OPEC oil rates, the oil prices, have gone up, and up and up. These are just passed through on the fuel adjustment clauses. The public is saying, who down here in Augusta is controlling their rates, the rates they pay on their bills.

We found out, our Committee this Session, that the Wall Street firms, financial houses, in rating public utilities commissions around the country, rate our Commission as one of the toughest commissions in the country in terms of regulating public utilities. Private investors who invest in the public utilities, Central Maine Power, New England Telephone, and so on, are being told that the Maine Public Utilities Commission is tough on public utilities.

However, because there is a great deal of concern, and there is a referendum coming up in November, we created an office called the Public Advocate, to try and reassure the public that there is someone down there who is going to bat for them. In reality, our Public Utilities Commission has been doing a good job.

The man that we're asked to confirm today to this position is Dr. Gordon Weil, who has served in many capacities in state government, recently as the Director of the Office of Energy Resources, and as Commissioner of the Department of Business Regulation. He has many excellent credentials. I've passed out this sheet to you so everyone can see them. He was born

in New York, I see.

He's a fighter. I've seen this before my Committee. Whatever cause Dr. Weil takes up, he fights, whether it was during the bottle, the returnable container bill referendum, he represented one group, not a group that I agreed with, but he fought hard. In front of the Committee, he fought hard for the Governor's positions, was loyal to the Governor. Many times I disagreed with him, but I respected the fact that he represented the person that he was hired by, and he fought hard. I believe he will fight hard in his position for the consumer and the State of Maine.

Unfortunately, in November we are facing a referendum. False hopes are being held out to the public that if you elect commissioners, you're going to get lower rates. As we all know, when you go with State-wide elections, the money often determines who gets elected, because you have to go into the media. It's very possible that if you go to elected commissioners, you're going to end up with the utilities putting people in as commissioners.

The feeling of the Committee, or at least specificially of myself, is that the Public Utilities Commission in Maine is doing a good job, but we hope that the Public Advocate will reassure that public that there is someone down there specifically that they can identify with, who represents their interests. We feel that this is a well-qualified and top man for the position.

Senator MINKOWSKY: Mr. President and Members of the Senate: I also had supported the Public Advocate Bill during the last Regular Session of the Legislature. I think the scenario that was played out by the Chairman of the Public Utilities Committee was very accurate. I think the public does need somebody that they can rap their concerns with.

As I started to research Mr. Weil's job descriptions, as well as his participation in various agencies in state government, I began to wonder about one particular factor. Starting off with the Department of Business Regulation, his credentials are, according to his resume, impeccable. According to the people in the Department, he did an outstanding job, but he only did that job for about one year. Then he moves on to the Energy Resources Department, and now on as Public Advocate.

We in the Senate go through the confirmation process, and ordinarily you would anticipate that people who are selected for these different posts, in state government, would at least serve during the term of the Governor, meaning the four year span of time. My assumption at the present time, either the man is so qualified and is capable of being the Governor of the State of Maine, or possibly the Governor's not satisfied or is moving him around so much as he has in the past two years.

Another concern that came up was an article that appeared in the paper a few weeks ago. That was relevant to the Public Advocate position, where it was brought up that Mr. Bradford, who will be retiring from the Nuclear Regulatory Commission, chances are because he won't be reappointed by President Reagan,

is looking for a similar job.

Now, are we going to go through the confirmation process again next year, when Mr. Weil is moved from one department to another department, and Mr. Bradford is the nominee by the Governor, at least from the assumption I got from the newspaper, that he will then be considered the prime candidate for that particular slot? I don't like the game that's being played. I think we have enough skilled, competent, qualified people in the State of Maine that should be, that we should find a person that can handle these jobs and stay on during the duration of the term of the Governor.

To go through this manipulation process by moving one man three times, and using the confirmation process three times, is intolerable. I'm unsure at the present time, really how I'm going to vote on this particular issue. I felt it was incumbent, and at least from the discussion I had with my constituency, they had some reservations of exactly what's going on.

These are the points I wanted to bring out at this Senate Session this afternoon, because I don't think this should go by without having something on record exactly how at least one Senator feels about this particular thing, of a person being moved around three times in the course of one and half or two years.

These jobs, in my estimation, are too important. Whether it's Business Regulation, or Energy Czar, or as Public Advocate, but again, I go back to my original thought. That is that we have enough competent, qualified people in the State of Maine that the Governor could select from to fill these different slots without taking one person and shifting him around as many times as he had, regardless of his credentials. Thank you very much, Mr. President.
