Augusta, Maine January 6, 1982

Pursuant to the provisions of the Constitution and the laws of the State of Maine, the Senators convened in the Senate Chamber at 10 o'clock in the morning and were called to order by the President.

Prayer by the Reverend David L. Glusker of the Green Street Methodist Church of Augusta. REVEREND GLUSKER: Let us pray. Lord God, we pause with thanksgiving as we enter into this new year, and this new season in the life of this Body. We are grateful for all of the ways in which You have blessed us during the

past year, for the accomplishments and achievements which have been ours to enjoy, and for the gifts that we now benefit from as

we reflect on past actions.
