Senator BROWN: Mr. President, I'd like to say a comment or two about Dr. Lincoln A. Sennett, one of the outstanding leaders of Washington County. He has died at the age of

Dr. Sennett has had a 46 year career in education. A recent newspaper article has said the following about Dr. Sennett: "Sennett was a career educator who received his first college degree in 1925. He started teaching and coaching athletic activities at Washington State Normal School, now U.M.M., that same year. In 1946 he became a principal. In 1952, he was named the first president of Washington State Teacher's College. In 1965 the institution became Washington State College. In 1968 it became the University of Maine at Machias.

He was dedicated to his institution on the hill. Mac, as he was known to his friends, was an institution and a bit of a character in the best sense of the word. He possessed an indomitable spirit and was a hallmark of his manifold challenges as an educator, a civic-leader, and a businessman. Combined with the clarity of vision, this spirit made him an uncommon leader who worked with equal effectiveness in unseen ways in public efforts to advance his community and college.

We in Washington County feel very badly that Dr. Lincoln A. Sennett has died.

ENACTOR

The Committee on Engrossed Bills reported as truly and strictly engrossed the following: Emergency

AN ACT to Provide for the Appointment of a

Provisional County Treasurer. (H. P. 1850) (L. D. 1830)

The PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Teague.

Senator TEAGUE: What this Bill does, is in the event of concurrent vacancies in the offices of county treasurer and deputy treasurer, the county commissioner shall appoint a provisional treasurer, who shall serve until a treasurer is chosen and qualified in accordance with Section 601.

The provisional treasurer shall have all the authority granted to treasurers under this Subchapter, and be subject to all the requirements of this Subchapter.

This Bill came into being because Somerset County's county treasurer resigned last Friday. We do not have a deputy treasurer. therefore, there was no one to sign the checks for the employees of the county.

Unless this Bill is passed, and we have the 22 votes, I mean the county's employees will not

have a paycheck this week.

This being an emergency measure and having received the affirmative votes of 23 Members of the Senate, with No Senators voting in the negative, was Passed to be Enacted and having been signed by the President, was by the Secretary presented to the Governor for his approval.

The Adjournment Order having been returned from the House, Read and Passed, in concurrence, on motion by Senator Pierce of Kennebec, Adjourned until Tuesday, January 19, at 11 o'clock in the morning.
